Dear M. I really don't know where to start as I have so much to tell you about.

Anyway, I want you to know that I appreciate having you for my new friend.

I have about Seven different Energy devices. About half of them can be proven to work right now as I can direct you to different website to see the concept actually working.

The most crazy one of my concepts is called the STIWAL (Static Time Internal Warp Levitate). I normally would never mention this device as it really sounds totally crazy and therefore it is the last one that I would ever talk about.
