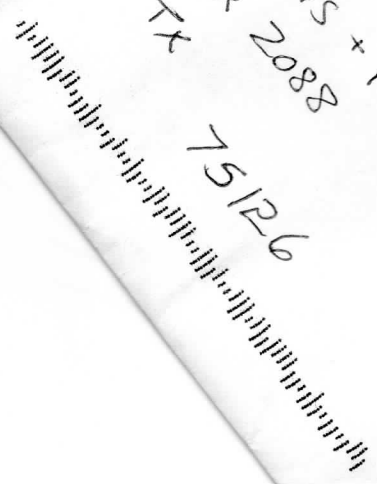



Anyway I want you to know that Eddie Kahn is my friend and he has never done any crime and he like me was targeted. I also knew Erwin shift, who died in prison on Bogus charges. → to S

3) I was Arrested a Sat in the Boise Jail for two + mi years and never knew what my charges were. While in the Boise Jail, MR SWISHER sued me and got the Judge to give him access under a Temporary Restraining order and Swisher lost this lawsuit as the papers they forged of me giving them my property showed that I gave them the WaterOz Factory - But as I felt I had built this factory for God, and I'm an expert in Land Laws and titles I was never the legal owner of the WaterOz Factory.
