Dear Mr. & Mrs. Davis,

I received your letter yesterday and was elated to read that there are still good hearted people who are fighting the good fight against this corrupt Babylonian system. First to answer the few questions you posted in your letter:

- 1." I don't believe in the bible." I KNOW that the bible is the truth, the whole truth and nothing but the truth. The reason I don't use the terminology "believe" because belief implies a trust of something without having evidence whether it's true or not. You can beLIEve a LIE, however, when it comes to the truth, you KNOW it to be true because it has been verified. I can PROVE the Divine authenticity and unerring accuracy and infallibility of the bible, of course excusing mistranslations, interpolations, carnal minded interjections and spurious phrases.
- 2. I have a King James Bible, A Sacred Scriptures Bible, A New World Translation Bible, Strong's Concordance and a Bible Dictionary. I use the true original name of the Heavenly Father which is YHWH (Yahweh), his divine title which is ELOHIM and the original name of the savior which is YAHSHUA. I can go into detail at another time why the powers that be INTENTIONALLY took the true names out of most bibles and replaced them with greek substitutions like "Jesus, Iesus, Iesus, Christ, Christos, Lord and God," which "Lord" and "God" are not names, but 'titles' derived from England and Assyria. Did you know that in the very first edition of the King Iames Version in 1611(his name was not spelled James but Iames, because there was no letter J in existence yet), there are no letter J's in the whole bible. "Jesus" is spelled Iesus, Jeremiah is Ieremiah, Jehovah is Iehova, etc. The letter J is only about 300 years old. You can do the research yourself to find out the truth which I highly encouraging you to do so. There is so much that we have been lied to for 13 millenium, and it's time for the TRUTH to be told to the masses.
- 3. My birthday is August 9, 1971.

- 4. I was charged and arrested on Feb. 15, 2017, while awaiting trial in my unlawful filing of documents and grand theft of a house (yes they said I stole a house!) in Florida, which was actually a foreclosure case that I saved a family from being evicted by Bank of America and since I exposed the systemic mortgage fraud being committed by banks and mortgage companies in complicity with the courts and was charged with grand theft of the house for not allowing Bank of America to foreclose on their home and take possession of the house. After I was incarcerated for the "Unlicensed Practice of Law," they came with the Sheriff and evicted the clients out of the home and 3 months later, charged me with the grand theft of the house! I have been incarcerated since May 17, 2016 from the earlier Florida UPL charge until now. My Florida case is in appeal's court and will be overturned shortly because the Attorney General never rebutted my brief. They knew it was pointless because all the facts with corresponding exhibits were attached to my briefs, so they knew there was nothing they could rebut. The appeal would have already been completed, however, I was told that the clerk "somehow file the brief incorrectly as a regular document instead of a brief," which is why my appeal has been delayed for a year, otherwise, it should have already been overturned by now.
- 5. The current charges against me are mail and wire fraud. They alleged that I misrepresented through email and the mail what I could do for client in which I never did. The very people they alleged that I defrauded have signed affidavits stating that I did nothing but help them and that these charges against me are discriminatory and retaliatory because of my exposing the corruption of the FBI, judges, attorneys, banks, mortgage companies and other law enforcement agencies. You can check out one of my videos on YouTube where I confronted the FBI office in Tennessee for slandering my name and defaming my character and the officer was calling around to my clients telling them that I was a crook and that I change my number every 30 days and to not support my cause or my company. I recorded the incident and uploaded it on YouTube under "Anthony Confronts FBI part 3." There are part 1 and part 2, but the bulk of the encounter is captured on part 3. My trial has been unlawfully continued (postponed) 7 times despite my written Motions of objections. My last trial date was scheduled to commence on the 25th of this month of February 2019, however, it was continued (postponed) unlawfully again, this time for another year until Jan. 21, 2020 because of the attorneys of my codefendants which are my 71 year old mother (whom they added last year because the trial date was in 3 weeks) and they needed another reason to postponed my trial. So they filed a Superseding Indictment and added my Mother and charged her with the same mail and wire fraud because of 2 money grams that I had an employee send to her in October 2013 when I was unlawfully incarcerated for rape and child molestation and I had the money sent to my mom to pay for my bond. In that case, I represented myself and proved my innocence and exposed how the FBI tried to fake my fingerprints to have evidence to place me at the scene of the crime. I exposed this and caught this at my extradition hearing which was video recorded by Dr. Leonard Horowitz, who is a well known author, who wrote the famous book, "Emerging Viruses" and his spouse Sherri Kane, who formerly worked for Fox News, and they uploaded it on YouTube under "FBI Hawaii Conspiracy Part 1" and "FBI Hawaii Conspiracy Part 2". If you have time, please check out that extradition hearing and see for yourselves how corrupt the judge, the prosecutor, the AG's office and the FBI. I had the case dismissed on Sept. 3, 2014 after I filed a

Certificate of Dismissal and Acquittal outlining how it was impossible for me to have committed those crimes because I was 5,000 miles away in Hawaii! The irony was that they charged my oldest son first with the crime, which I had this case dismissed in 3 weeks. Then they charged me with the same charges, which again, I had my case dismissed in 9 months. Three (3) months I sat in a Hawaii jail awaiting extradition and 6 months in Georgia until I got a bond.

- 6. I have always maintained my innocence because everything that I do I make sure that it is according to the divine law first, then the U.S. Constitution and all the other laws that are in harmony with those two. My company has a perfect A+ Better Business Bureau rating and zero complaints in 17 years til now. I had offices in 8 states and only 2 came after me because I exposed the Florida, the Hawaii judges and the FBI offices, as corrupt and was uploading videos of me in the courtroom defending the rights of the people. It was never a problem until they found out I was video recording the proceedings and uploading them on YouTube so the American people could see the corruption themselves, and did not have to take my word for it.
- 7. I do have a few people that support my fight against this corrupt system, most notably William Wagener who has a television show called "On Second Thought," that I appeared on before my incarceration. He has done 2 shows about me since my incarceration, to inform the American people and be aware of the injustices that are being perpetrated against me and my mother.
- 8. I do not mind calling you and having my story recorded and published because people need to know the truth.
- 9. I do have access to email. I now have your email and I will send you a request and we can correspond through email. Also, one of the clients whose home I saved from foreclosure (and still currently helping her stay in her home for the last 6 years), she has become a very good friend to me. I obtained her permission to call Rosy Esprecion at 808-xxx-xxxx. She can tell you her own story of how I am currently helping with her foreclosure. The Judiciary system in Hawaii is unfathomably corrupt to the core in both lower and upper court systems, which I intend to publicly exposed.
- 10. I really don't need anything, however, my greatest desire are for people to know my story and others like me, exposed through the MSM-main stream media, especially in the presence of the right people, in hope that they can help me expose the injustices being committed to the American people, so that justice can finally be administered unto those who are wrongfully accused and wrongfully

incarcerated because of our passion in exposing the corrupt government and judicial system and eventually, the culprits be brought to justice once and for all.

11. I do have a copy of my original indictment, but not transcripts. Rosy can email you a copy of my indictment. I will let her know that it is ok to send them to you.

12. This contains a brief synopsis of what I have been through, thus far. I am not able to call that much because we're only allotted 300 minutes a month. I have people that I am still helping to fight their foreclosures that I need to be able to give instructions to in order to continue to keep them in their homes. I can call probably once or twice a month if need be, if you want to have my story recorded. The calls are only for 15 minutes long. So you might not be able to obtain as much information vs. the email correspondence.

I truly appreciate you both for reaching out to me and the love and support that you have shown to the countless other political prisoners like me, that you shared with me in your letter. May Yahweh continue to bless you and keep you both in perfect health and peace of mind. Shalom.
