I am Amy Gonzalez. I am 51 years old. I have been a federal inmate since August 8, 2013. I was given a LIFE prison term. Since the federal penal system has no parole-LIFE means LIFE. These people want me to die in here. I am a mother of a now 18 year old daughter, a 31 year old son and a wife. I DID NOT COMMIT A VIOLENT CRIME. My case # is 1:13-cr-83-GAM-3 in the US District Court District of Delaware at Wilmington. Here are the facts of my case, that I will make brief.

- 1. I was charged and convicted of cyberstalking resulting in death and conspiracy to commit cyberstalking and interstate stalking along with my brother, David Matusiewicz, and mother, Lenore Matusiewicz. (Posting a video & Polygraph does not result in death equaling a LIFE sentence)
- 2. I was living and working full time as a RN in Edinburg, Texas when the crime occurred.
- 3. My father, Thomas Matusiewicz, was in Delaware with my brother and mother to attend a civil court proceeding regarding modification of child support for my brother.
- 4. When my ex sister in law, Christine Belford and her friend, Laura Mulford came into the lobby of the court house, my father, who was by himself shot and killed both Christine and Laura, then committed suicide. My brother had already gone to the courtroom awaiting the case to be heard. My mother was not at the courthouse at all.
- 5. My father was diagnosed with meningiomas, a brain tumor on the left frontal lobe. There was NEVER an expert witness to testify on our behalf at trial.
- 6. I was never offered a plea agreement. My attorney insisted we go to trial and never tried to do any plea negotiation on my behalf. We were tried together, not separately.
- 7. This is a Precedential case. The first EVER to be tried in Delaware and the United States.
- 8. July 10, 2015, we were found guilty. On Feb. 12, 2016 my mother was sentenced to LIFE in prison at her hospital bedside which is heard via audio on the internet. She was sentenced 10 days after she had brain cancer surgery. She died on May 6, 2016.

I have only one last chance to get this conviction/sentence overturned as Billy Raymond Counterman accomplished with his cyberstalking conviction in the Supreme Court. We argued the exact same issues of Freedom of Speech and intent in our direct appeal. I have been incarcerated for over 10 years without receiving any disciplinary infractions. I am not asking for monetary support. I am asking for political and moral support by looking deeper into the specific facts of this case.

Thank you so much for your time and any consideration you may give this case. I will be looking forward to your rapid response.
