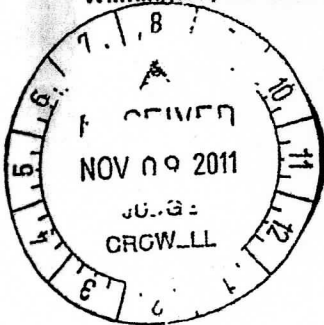

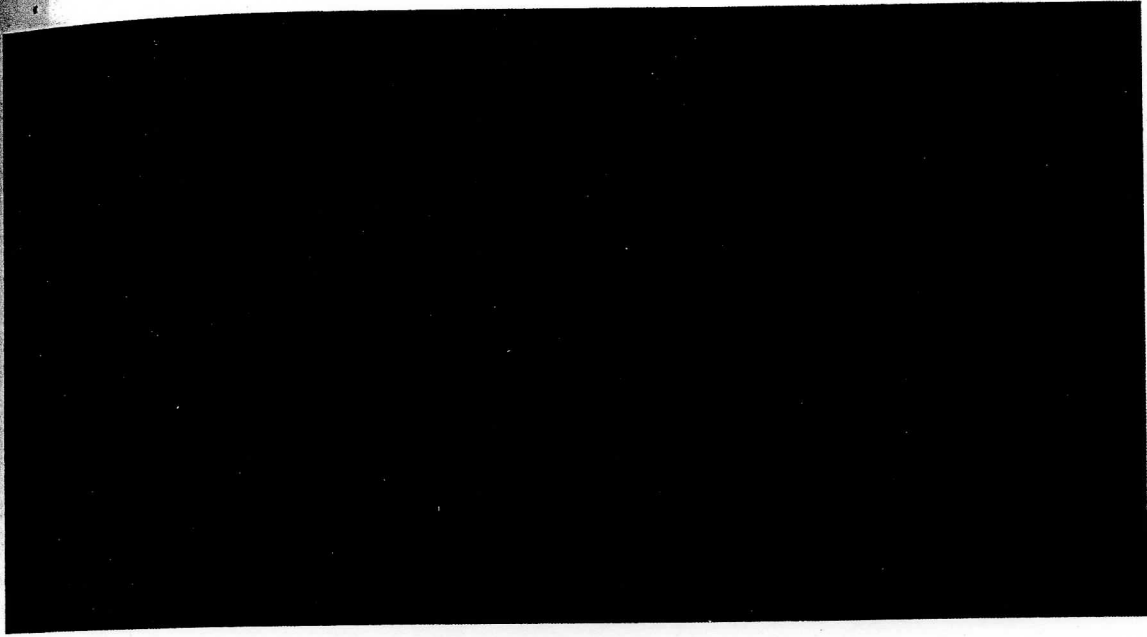
Dear Judge Crowell,

If my brother had actually called off their wedding as he planned to do due to Christine's mental problems, then, we would not have these little miracles that they created together. These have been the most heartbreaking times in my life and in the lives of my family, next to the death of my older brother. Tell me why is it so hard to prove the truth when you've lived it; but the only Other One who knows the truth is God? I hope that with His guidance you can make the right decisions for this family and not further enable the children's mother to distance the girls from us.
2. Until meeting Christine (Belford) Moffa, I trusted almost everyone that I had ever met. Being a nurse I have been present when psychologists have evaluated their patients in the hospital. I find that the mentally ill are the most difficult patients to work with and the hardest to trust. 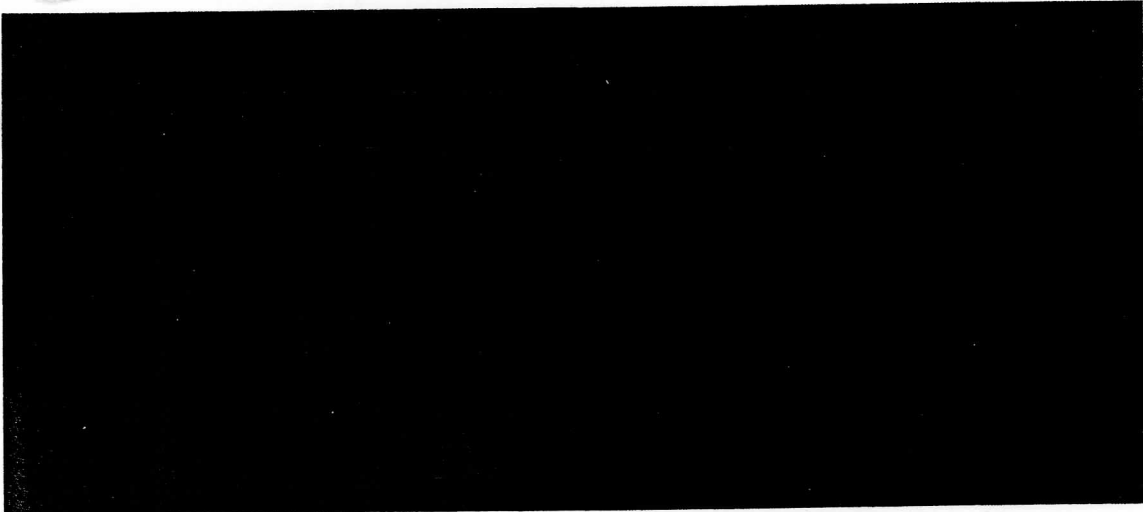

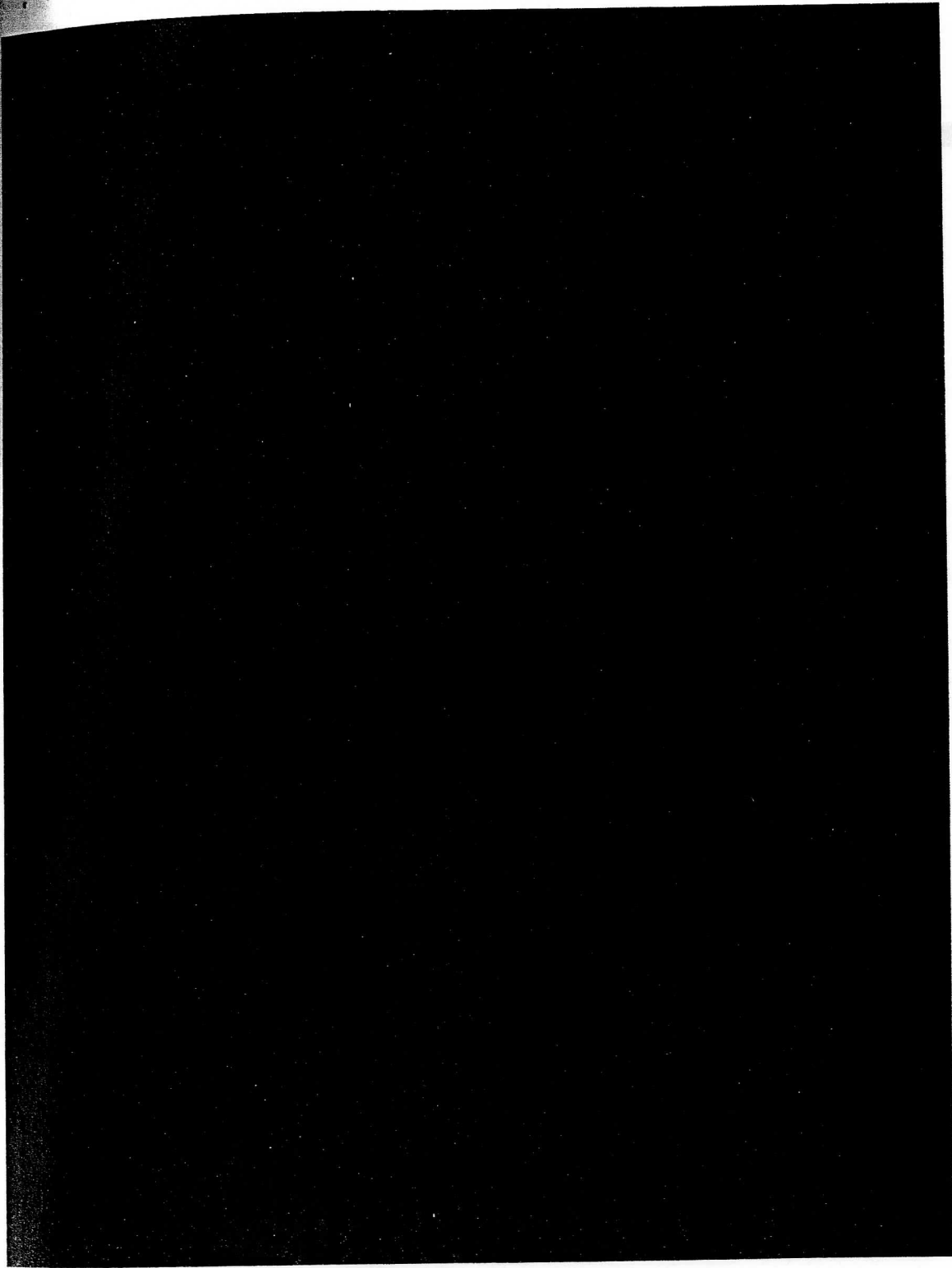

What Christine was actually afraid of, according to the phone transcript, was David's contacting Dr. Blacklock regarding his knowledge of the child abuse by Christine that was witnessed in his office by his staff. When Christine pulled Leigh by her arm, the technician stated that if she ever saw that again that she would contact Child Protective Services. 



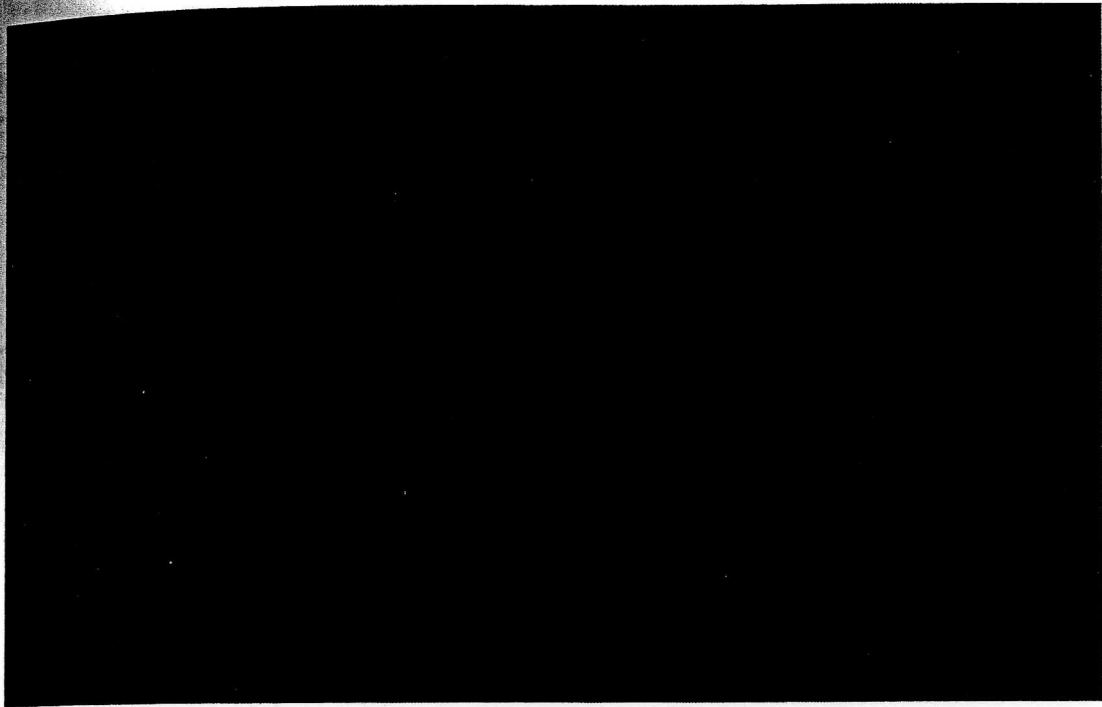
8. Why did Christine kidnap my nieces/her children? She said she was taking them to see her mother, Kathleen Belford, who was dying in the hospital. Her mother was not in the hospital at that time. We spoke to her ex-husband, James Belford; and he said, "Kathy's just fine!" Kathy had been asking what was wrong with Christine because Christine had called Kathy fourteen times that day! Christine said she was weaning herself off of the Paxil with her doctor's supervision. Why did she leave the medicine behind completely?



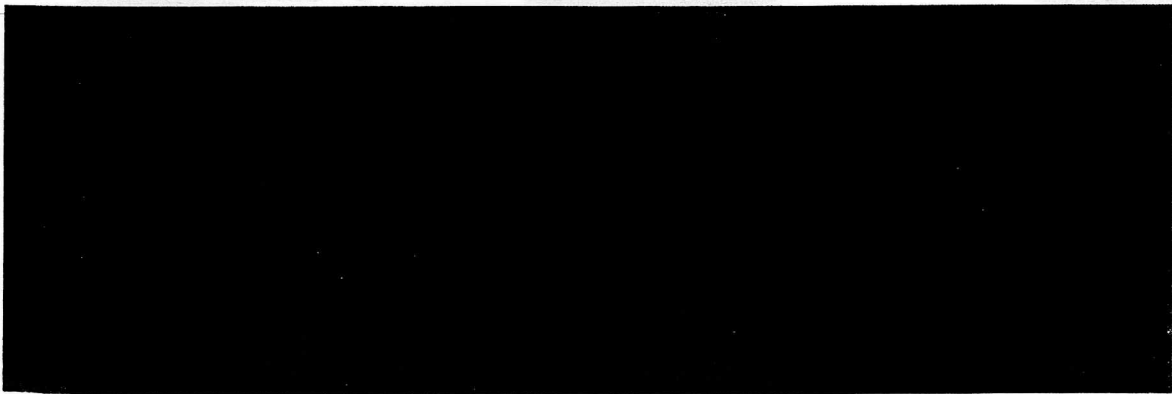



I also am sending you copies of pictures of my niece, Laura and her "Pop-Pop", my father taken by Dr. Monica Bocanegra. They clearly show that Laura is not afraid of us because she is contacting us of her own free will. Please, take this information into consideration.

14. I am providing information to you that was never provided to the courts by the lawyers (polygraph tests, statements to lawyers, media letter, letters to/from Child Protective Services [redacted] Why weren't you given all of the facts in this case? Why would I ever subject myself and my mother to being interrogated for a polygraph test if I was lying about the sexual abuse of my niece? Unfortunately, my niece, Laura, has not spoken out about any sexual abuse at the hands of her mother to anyone other than family to date. She said she was afraid that her Mommy would go to jail/ Who would take care of her needs if you took away Daddy and Mommy went to jail? I am including the Delaware News Journal article titled "Victims of Child Abuse Often Stay Quiet" where Dr. Samuel Romirowsky himself states that, "when children hold it in under coercion, it's sort of like a time bomb. They don't really live with it unscarred. That generally comes out later, almost always in the form of depression, self-esteem problems and difficulties in relationships. You're just damaged." But he agreed that "kids who learn to open up and deal with the problem can emerge from the experience with a strong future. It's important when kids do finally talk about it, even years later, that parents not blame them for not disclosing it in a timely fashion. Parents should say they're sorry that they had to keep it private and suffer with it all of this time; but they're here to talk about it now; and certainly to highlight that "It wasn't your fault". Is this what happened to Christine when her father sexually abused her as a child? This fact Christine disclosed to my husband, Juan Gonzalez, and my father, Thomas Matusiewicz.

The sexual abuse of my niece is just part of what drove my brother and mother to make the decision to give up their entire lives and leave the country with the three innocent children in order to protect them from any further emotional, physical or sexual abuse. We know that this was the wrong decision; and if we had it to do all over again, we would have all come forward and made the authorities listen to us when the children did not want to go for court-ordered visits with their mother. I am providing you with a recording where Laura is saying that she doesn't want to go with Mommy for a visit and Christine replies that she spoke with her lawyer, Timothy Hitchings, and Dr. Sam who have told her that children should not be forced to go anywhere that they did not want to go. This should clearly tell you that this is not the first time that the children did not want to go with their mother but were cajoled and pushed into going to abide by the court's decision. Are the courts' decisions always right? You tell me. Laura is on anti-anxiety drugs (is she really afraid that Pop-Pop is going to kidnap her or is it something else?). Leigh is on sedatives but on the right diet she slept every night from 7:00 p.m. until 4:00 or 5:00 a.m. every night. What is happening to Karen? The children are in their mother's care and only God knows what will happen now!

The decision of the courts whether or not to allow visitation with my nieces and their father's family affects everyone in this case, especially my nieces and my five-year-old daughter. My brother and I always looked forward to raising our children together. I pray that you will realize that this family is going to continue to tell the truth of the facts in this case until our last breath is taken from us. Even though the wrong decision was made by my brother and mother, we will continue to fight to make it right, for the girls' sakes! Wouldn't you?


The Family Court of the State of Delaware is in receipt of your correspondence dated November 2, 2011 to Judge Crowell concerning the above captioned case.

If my brother had actually called off their wedding as he planned to do due to Christine's mental problems, then, we would not have these little miracles that they created together. These have been the most heartbreaking times in my life and in the lives of my family, next to the death of my older brother. Tell me why is it so hard to prove the truth when no one knows the truth, but God? I hope that with his guidance you can make the right decisions for this family and not further enable the childrens mother to distance the girls from us.

Until meeting Christine Moffa I trusted almost everyone that I had ever met. Being a nurse I have been present when psychologists have evaluated their patients in the hospital. I find that the mentally ill are the most difficult patient to work with and the hardest to trust. I have witnessed the psychologist say that the patient is better and ready for discharge from the hospital, but then the patient states to me after the physician has left the room that they are "going to kill themselves as soon as they get out of here." I often wonder who are they manipulating, the doctor or me?

Unfortunately, this is what I have seen to be the case since I have known Christine Belford. Amazingly she attributes her thoughts, words and actions to other people. When Christine filed a false PFA against my brother she stated that "he has made threats about killing her and hiding her body. He has made idle comments about the children being better off dead than with divorced parents" and on 1/1/06 he stated that "he can't stop the voices in his head and his own death is coming. He also owns several guns and she fears for her life and the lives of her children", but ironically in a transcribed taped phone conversation between David and Christine (transcribed by Mike O'Rourke investigations) Christine states that she "is not afraid of David." She "is not physically afraid of him. She doesn't believe that he is going to put a gun to her head. She doesn't believe that he is going to choke her". My family NEVER heard any of these comments out of David's mouth because they never happened. So which is it, was she afraid of him or not? She later admitted that she was lying to the court about David's being abusive but she had gotten what she wanted so it was okay. Is it okay for her to make false accusations and waste the time of the police department and mental health workers in order to further accomplish her goal?

What Christine was actually afraid of according to the phone transcripts was David contacting Dr Blacklock regarding his knowledge of the witnessed child abuse by Christine in his office by his office staff when Christine pulled Leigh by her arm and the technician warned her that she could seriously injure Leigh and that if she saw her do that again that she would contact Child Protective Services. Christine replied to the technician, "do you have any idea who I am? I'm Dr. Matusiewicz's wife". Unfortunately the technician backed off and apologized instead of calling Child Protective Services for the incident. Why does her PFA include that David can buy her a new cell phone, pay for her hotel due to her hiding out, he can give her the check book, pay the mortgage, etc. Was this all about money? My gut instinct says yes.

Dr Cuba evaluated my brother when he was surprisingly picked up at his practice by five police officers and taken for a psychological evaluation of him due to her false allegations. Dr Cuba's evaluation showed that "David did not show any signs of mental illness, but of more concern is the wife who everyone claims was diagnosed as suffering from post partum depression and has been on Paxil for the past 2 yrs and is presently trying to stop taking them. There are very subtle changes in the wife who was said to have in past three months become very involved in church, has been dressing more fancily and going out odd

It was advised by Dr Cuba to make sure the weapons were removed from the house and that Christine should have an assessment ASAP and that the kids should be made until the assessment was completed. Dr Richman was not in the office, but his answering machine's message was to call the Rockford Center. Lenore called the Rockford Center and explained the situation to them. The Rockford Center staff told Lenore to have Christine call immediately or go to the nearest emergency room. This information was provided to Christine to follow through with them. Within just a few seconds of speaking with Lenore, Christine said that she called the Rockford Center and they told her that that was an inappropriate number for her to call. Did she ever really call? Why was she afraid to go for an evaluation if she was acting rationally? She has been under the care of a psychologist or other mental health professional since at least 1991 that we are aware. Doesn't this concern anyone? It sure concerned us when we found out this information as has never disclosed to us from the very beginning. I am sure that if you were to look at the mental health records of Christine Belford from the beginning you would learn a lot. 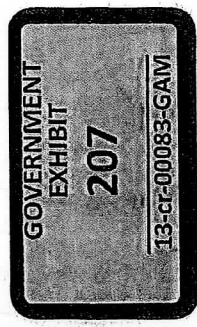

**REPLY TO THE GOVERNMENT'S RESPONSE IN OPPOSITION TO  
DEFENDANT DAVID MATUSIEWICZ'S SENTENCING MEMORANDUM**

Defendant, David Matusiewicz, by and through his undersigned counsel, hereby submits this Reply to the Government's Response in Opposition to Defendant David Matusiewicz's Sentencing Memorandum. For the reasons set forth in his original Sentencing Memorandum, and in this Reply, as well as any other reason this Court finds appropriate, the Court should find that §2A1.1 of the Sentencing Guidelines are inapplicable to this case.

The government's response to David Matusiewicz's sentencing memorandum missed the mark and the core bases for arguments therein relating to the application of the cross reference under §2A6.2(c)(1) and, specifically, §2A1.1, under the circumstances of this case, and the difference in foreseeability as it relates to the resulting in death verdict, versus the application of §1B1.3(a)(1)(B). Counsel will not further expand on the issue regarding the inapplicability of the cross reference under §2A6.2(c)(1) and, specifically, §2A1.1, or due process arguments



made in his trial sentencing memorandum. Rather, Counsel addresses solely the foreseeability issue.

Foreseeability – Evidence

In a dying declaration to this Court, during her expedited sentencing hearing on February 12, 2016, Lenore Matusiewicz said that:

\* As part of his decision to kill Christine, he never told any of us about that. He just did it. And that was the way he was. I don't know if it's from the meningioma. I don't know if it was part of his training, but he just did what he did, and none of us knew what was coming.

(Sentencing Transcript, pg. 12)

Lenore Matusiewicz, with the clear knowledge of her impending death, reaffirmed her religion and requested her final blessing: “That I’m a Catholic and I would like to be blessed before I am disposed of.” *Id.*

Under American Jurisprudence, a dying declaration holds a special place and is accepted as proof of the fact to which it addresses.

\* [T]he ‘dying declaration’ and ‘medical treatment’ exceptions to the hearsay rule are based on the belief that persons making such statements are highly unlikely to lie. . . . [T]he sense of impending death is presumed to remove all temptation to falsehood, and to enforce as strict an adherence to the truth as would the obligation of oath. . . .’ [N]o person, who is immediately going into the presence of his Maker, will do so with a lie upon his lips.’

Idoha v. Wright, 497 U.S. 805, 820 (1990) (internal citations omitted)

There is no doubt, given the expedited hearing initially requested by the Government, that Lenore Matusiewicz is dying and her death could come at anytime, but most likely within the next three to four months. In her answers to the



Court, it is clear that Lenore Matusiewicz understood the urgency and pressing issue of her death as the basis for the expedited, hospital-bedside, sentencing hearing.

Enclosed are pictures and school updates for Laura, Leigh Nicole, and Karen. I believe this will give you some of the information you are seeking. Leigh Nicole's school pictures have not arrived yet, so I substituted her Halloween picture.

While it is my understanding I am under no legal obligation to respond to your request or provide you with this information, I made a statement under oath that I would be willing to provide you with such updates. Having personally known the pain and suffering associated with not knowing anything about our daughters for 19 months, I know I cannot lower myself to that type of behavior and deny you what you seek.

Laura played soccer for St. John's team this year and scored a goal at the last game of the season. She is also playing clarinet and as you can see, missed straight A's by one grade. Laura's teachers continue to remark she is a sweet and kind girl who thinks of others and is a good friend and responsible in the school setting. She has many friends and has an active social life. She shows a natural artistic talent and I am seeking art lessons for her with the goal of her possible acceptable attendance to Cab Calloway School. She must be accepted after testing and have two "talents" - hers being music and art.

Thank you for taking the time to read this. I am searching for any assistance you may be able to offer me and my daughters. As you may recall, in 2006 we discussed the changes that my ex-wife, Christine Belford, underwent when she discontinued her depression medications. You disclosed to me a similar incident in your own history while you were caring for a close friend. Few people can understand my perspective as you can and why I chose to take the steps I did in an attempt to protect my children and to avoid incarceration for my ex-wife.


I was abused, terrorized and threatened by the woman I loved and the mother of my three beautiful daughters. I approached attorneys, psychologists, counselors, friends, and the Delaware courts in an attempt to ascertain what had gone wrong in the mind of my wife. In the meantime I also searched for specialists who could aid me in my care of my child with autism. After I realized that I could not force Christine to return to the care of her psychologist and that the court was unable to see what had happened to her from my perspective, I attempted to "move on" and focus on the care of my daughters. This, coupled with the apparent anger from which my ex-wife still suffers, triggered in her a desire to hurt me in the only other way she saw available; she began sexually molesting my daughter, [REDACTED]. When my then 6 year-old daughter embarrassedly divulged to my family and I that her mother was playing certain sex games with her and that she had to wear two pairs of underwear when she had visitation with her mother, I took the only steps I could see at the time to protect my children while avoiding incarceration for my ex-wife who I still believe suffers from mental illness.

In researching the mania that sometimes ensues once anti-depression medications are abruptly discontinued, I discovered that a bipolar state and sometimes schizophrenia can be triggered. I believe that one of these diagnoses fits the changes I see in my ex-wife. I brought these diagnoses to the attention of the psychologist who evaluated Christine and was baffled as to his finding that she had been appropriately weaned from her medicine and was acting rationally. If I am correct she has since been diagnosed with bipolar disorder.

Please allow me to stress to you that I understand that the actions I took while attempting to protect my daughters, myself, and my ex-wife were the wrong ones. If I was able to return in time I would more strenuously attempt to find help for the woman I loved. I still fear for the mental and physical well being as well as the safety of my daughters but hope to find some way to make my ex-wife realize the mental changes she has gone through in the absence of her medications without having to see her incarcerated as a child molester.

Any assistance that you may be able to offer me in this matter will be greatly appreciated.

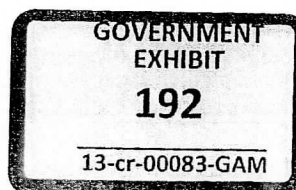
