ORDER

The Petitioner filed a Petition for Permanent Guardianship of a Minor on March 11, 2013. Petitioner filed against the Department for Services for Children, Youth and Their Families ("DSCYF") as Respondent. The Department has custody of the three minor children, Laura Matusiewicz, Leigh Matusiewicz, and Karen Matusiewicz. Respondent was served with a copy of the petition on April 10, 2013 and filed an answer on April 24, 2013.

The Delaware permanent guardianship statute was "intended to create a relationship between a child and caretaker which is permanent and self-sustaining, and which creates a permanent family for the child without complete severance of the biological bond."¹ Only a blood relative or foster parent(s) may serve as permanent guardians of a child.² In this case, Petitioner does not meet the definition of relative and therefore lacks standing to proceed with the petition for permanent guardianship.

Petitioner is the sister of David T. Matusiewicz, the biological father of the three children whose parental rights were terminated by Court order dated September 18, 2011. That Court order was affirmed by the Delaware Supreme Court on April 11, 2012. "[T]he effect of such [a termination of parental rights] order shall be that all of the rights, duties, privileges and obligations recognized by law between the person or persons whose parental rights are terminated and the child shall forever thereafter cease to exist." If the parent-child relationship is severed, by extension, the relationship with the relatives of that parent is also severed.

¹ 13 Del. C. § 2350

² 13 Del. C. § 2351 states that "[a] blood relative, foster parent or parents may serve as permanent guardian of a child. A blood relative, foster parent or parents may petition the Family Court for a permanent guardianship order regarding a child not his, hers or theirs. The Department, the Division, a licensed agency or guardian ad litem may petition the Family Court for a permanent guardianship order so long as the proposed permanent guardian or guardians consent to the appointment."

Petitioner's legal standing as the aunt, or blood relative, of the three children for which she seeks permanent guardianship has been terminated.

This Court finds that Petitioner lacks standing as either a blood relative or a foster parent to petition for permanent guardianship pursuant to 13 Del. C. § 2351. Therefore, the Petition for Permanent Guardianship of a Minor is hereby DISMISSED.

IT IS SO ORDERED this 25 day of May, 2013.

While stroking Karen's hair, she said, "When I sell David's three, blonde, white, American girls, I'm going to get \$50,000.00 each. With \$150,000, I'll be sitting pretty; and they'll never be found because I have connections to the local crime family!" ... but Christine has four daughters! Dave's three daughters would be separated, used for pornography, prostitution, only God knows what and then....
2. Christine lost Laura in a garage full of dangerous machinery, sharp tools and lawn, garden, swimming pool and automotive chemicals/poisons. Laura was around one.
3. Christine did not react though she was standing not 3 feet away when Katy (aged 8) knelt on Laura's (aged 1 1/2) back and twisted Laura's arm and wrist up behind her back. Laura was screaming!!!
4. Christine trained Leigh to eat independently by throwing food on a filthy rug in the living room and having Leigh, not only, pick it up to eat, but fight off the muddy dog as well.
5. Christine said, "If Dave's children should be injured or become seriously ill, as their mother, of course, I'll be sad; BUT David will be devastated." Then, Laura had the MMR vaccine and broke out in huge red spots only on her torso. When she got tired, her forehead would turn alabaster white, the area around her eyes turned deep purple and her cheeks turned red. According to Dr. Han DeShain (sp?), it couldn't be tied to the vaccine! Christine was very calm!
6. When Katy was in the shower at the age of 8, she moaned and said, "That's the spot!" Katy was experimenting with sex at that time...not unusual....**BUT WHAT SPOT WAS SHE TALKING ABOUT?**
7. Christine reacted in the extreme to everyday behavior (crying, cuts and scrapes, vomiting, etc.).
8. Christine told at least two different stories about how Leigh's (at around 8-10 months of age) collar-bone got broken. (Was it on the trampoline or by the swimming pool excavation sight or was it another way?)
9. Christine became extremely angry with me (LEE) when I started avoiding Katy because she kept lying to me (not unusual for 8-year-olds but not to this extreme) especially since Mommy n seemed to condone it!!!
10. Christine said that she could get rid of me at any time without implication because of her connections to the local crime family and then she (with Katy's help) made me a cup of tea that made me sick for five days afterward. Barbara Dixon didn't get sick from her tea!
11. From time to time, Christine looked "stoned"! Was she tired?... or drinking (After the PFA, she very pointedly commented that she doesn't drink anymore [in her diary she wrote that she was drinking since she was 12]... or was it from her stash of prescription meds (paxil, wellbutrin, xanax, lexapro and codeine)? I don't know what combination(s) she used or whether or not she took them; but she did say she needed them to "take the edge off"! She stated that she doesn't drink anymore when she noticed unopened containers of food and drink in the trash after the PFA hearing.
12. Christine and our three girls (all three years old or less) would nap just about every afternoon for an hour or more. Chris was known to give Leigh cough syrup at times to "help her sleep".
13. In the wee small hours of the morning when she was three, Laura sat up in bed yelling, "NO, MOMMY! STOP IT! DON'T DO THAT!" and whimpering like someone who knew something

bad was going to happen but was powerless to stop it!

14. Laura said that she knew all about the "G-spot" because, "Mommy taught us all about it when we were in the bathtub!" She wouldn't describe how to play "lick the lollipop" but she played it with Mommy! Laura and Mommy had a secret about what Laura had (has?) to do to Mommy to make her feel good even though Laura didn't want to do them. It/they made Mommy happy! BUT, "IF I EVER TELL, MOMMY WILL GO TO JAIL!!!" Jail is a terrible place and Laura doesn't want her Mommy to go there! When Laura was five she had a tom hymen/an open vagina. She didn't ride a bike. She didn't skate. She played on the computer, jumped on the trampoline and swam!

15. Christine stopped taking her anti-depressant (PAXIL). She said she and her doctor had been weaning her off them; but, my understanding was, she stopped them "cold-turkey"!

16. In November 2005, Christine said that BIG CHANGES were coming so she'd have everything belonging to David (house, cars, money, optometric practice) and his "PRECIOUS CHILDREN"!!!!

17. Christine was unable to control her rages. She took "the blame" for Laura's (age 2 or so) breaking the double or triple paned living room window. There was a hole in the wall made with no explanation. "Lucky", the dog, jumped through the double or triple paned dining room window. The dog showed no scratches, bruising or signs of distress afterwards!

18. Christine gave up my grandchildren, kidnapped them the next day, returned them that night, demanded their return two days later but said I could take them to a kiddie play-land first! After she'd had a good night's sleep, she brought a policeman with her to help get them back again. At that time, I told him and her I thought she was going to hurt them (possibly kill them like Susan Smith); and in good conscience, I could not return them again! The policeman threatened me with being charged with kidnapping!

19. Christine ran to the street and back screaming something about being so afraid because David was near her. She was in the presence of a DE state trooper. She drove away erratically/frenziedly with three babies three years old and under turning almost on 2 wheels in her van, a Honda Odyssey!

20. Officer Thompson (sp?) told me, "It doesn't matter what you say. She got to the courts first!"... what a great justice system... make up anything... get to the courts first because you know what you're going to do... and you win!!!... BUT WHAT ABOUT CHILDREN WHO ARE INVOLVED????!!!

21. Officer Thompson stated that there's nothing wrong with Mrs. Matusiewicz... she's fine after sitting with her for two whole hours... she's "perfectly normal"! BUT he didn't live with her!

22. H. Fred Truant, David's custody lawyer, stated that he was glad he could keep the he said/she said stuff out of the courtroom after I described abuse that I had witnessed!

23. After Leigh suffered the broken collar-bone, Christine allowed her to slide head-first down the carpeted steps in the front hall to the ceramic tiled floor below! I heard the crack Leigh's head made when she hit the sides!

24. Someone (I think it was a nurse) at Newark Pediatrics Association and Dr. Gotthold from Appoquinomink Pediatrics Association threatened to report Christine to DFS (Division of Family Services in Delaware) when they saw how she handled Dave's children according to Chris. She was livid. She said they backed down when they found out she was a doctor's wife. It's must be okay to man-handle children if you're married to a doctor!

25. After we re-entered the house after the PFA hearing, we found LOTS AND LOTS OF PILLS in every size, shape color and color combination everywhere where children could pick them up and eat them ... they looked like candy!

26. Christine stated that she had a list of pedophiles in her neighborhood. I thought it was for the children's protection until 2007!

27. When Christine brought Karen back to the house after the PFA hearing, she stormed out of the house... we were all going to my house in Smyrna so that I could come back to clean and remove the pills (Some may still be under the dishwasher if it hasn't been replaced!). As she strode out she thundered, **"TAKE THE DAMN KIDS"!!!**

28. Chris didn't bond with David's children. She only claimed Katy from her first marriage.

29. In 1996, Chris gave custody of Katy to her ex-sister-in-law, Jen Puglisi (sp?) and then complained about having to pay child support. She gave David full custody of Laura, Leigh and Karen! Then she filed for joint custody in 2007!

30. Christine said that she knew there was something wrong with her... something really wrong... and she left to find out what that was(is). When she came back for a visit, she said that they'd found that she had ADD or ADHD... AND.....?

31. Christine bought a very extravagant Christmas (2006) present (an iPod) for Katy (\$200.00?) but spent maybe \$30.00 total on Laura, Leigh and Karen!

32. Christine accused co-workers at Simon Eye Associates of putting lots of contact lenses into her purse to get her fired for stealing. Dr. Stan Strauss vouched for the honesty and integrity of the employees in the office where Chris worked.

33. David found \$10,000.00 missing from Vision Center accounts when he tried to get information for his accountant together to figure that quarter's taxes.

34. Christine has the ability to get people to do/believe whatever she wants... Laura, Lee, David, the police, doctors, patients, co-workers. Is it the training she received at Hollander Associates, Inc. or Brandywine Counseling? Is it multiple personality? Is she a con-artist?

35. After Leigh was diagnosed with autism, Chris came for a visit and Leigh spread her arms, smiled from ear to ear and went to greet her Mommy. Chris pushed her aside saying, "She doesn't even know who I am." Leigh was crushed at about 2 1/2.

36. Christine insisted that Leigh return to the Brennan School for Autistic Children even after Leigh came home bloodied several times with no explanations from the teacher of aide.

37. Christine would not follow the advise given by Dr. Prociuk (whose specialty or sub-specialty [I think] is children with autism), Gertie Hillman an RN who specializes in diets rich in natural foods, vitamins, minerals and homeopathic remedies, or anyone else. She said that Leigh doesn't need a gluten free/lactose free diet and would not give her the special vitamin/mineral supplements formulated for autistic children. **Now Leigh's teacher at the Brennan School says that Leigh is losing language!!!**

38. Charlotte Stubbins, a close friend who worked for a long time at the Delaware State Hospital, stated that she told Christine to leave her house and never come back. She said that Chris is like her daughter, Mary, with severe psychoses and she (Chris) knows how to manipulate psychologists/psychiatrists, etc. Charlotte died before she could give her deposition. Ask Mike O'Rourke or one of his detectives about the timing of the deposition.

39. After hearing about my niece's extreme abuse and molestation by her step-father, Amy, my daughter, said that the child abuser/rapist should be castrated without benefit of anesthesia. Christine was visiting at the time and at Amy's words fell onto the couch as if shot! WHY?

40. The expert psychologist, Sam Romirowsky, after interviewing Christine and David and visiting each of them while they had the children with them for an hour or so each said that both parents could interact appropriately with their children. Was that truly enough time for a valid evaluation of the relationships? Even investigators from supposed child protective agencies aren't around when abuse and molestation take place!

41. **EVERYTIME** Christine would come to pick up the girls for a visit, Laura would run away from Mommy screaming, **"PLEASE, DON'T MAKE ME GO! PLEASE, DON'T MAKE ME GO!"** Leigh, would run across the neighbor's yard screaming, **"NO! NO! NO!"** She knew who Mommy was!!! Even Karen who was only one year old +/- would cry whenever

Mommy came for her!

42. Children and people who are mentally retarded put on extra layers of clothing to thwart their molesters/rapists, Laura started putting on extra layers of clothes especially panties!

43. In 2006 (?), Christine started receiving religious instructions from the Roman Catholic Church. According to her, she had grown up *without* religion!

44. Christine, knowing that Laura had had a bad reaction following injection of the MMR vaccine and Leigh developed autism following the MMR vaccine, stated that Karen was going to get the MMR vaccine also and there wasn't anything David could do about it when Chris had her with her after their custody determination! Why not put Karen at risk as well as the rest? Why not give all three of David's children mental and physical problems?...two isn't enough!!!!

45. Chris tried to set Tom Matusiewicz up for a false claim of assault... jumping up and down and rocking back and forth while he held her arm to steady her.

46. Christine threatened to kill or have me (Lee/Lenore) and Tom Matusiewicz killed several times. She and her daughter Katy made me a cup of tea in 2004 that made me sick for 5 days though I forced myself to vomit and drank several glasses of milk and water to dilute whatever it was!

47. Laura's recurring nightmare was that Mommy was coming to get her and Laura said, "I'm so afraid!"

48. Christine's friend and neighbor Beth (? Last name...lived on Churchmen's Road [?] and Route 15...SW side in Middletown) said that Chris cannot handle her children...they make her frantic!

49. Christine had been seeing Dr. Mark Richman, psychologist, from Summit Bridge Road for over 15 years. (She told Tom [after she'd been drinking] and Juan Gonzalez at another time she'd been molested by her father when she was young! She told me that her father had been molested by his father when he was young? Was her father ever arrested and convicted? Was her grandfather? She went to the Crossroads Program for Troubled Youth? Was she referred to the program or just waiting for someone to come out?...BUT she was referred to Brandywine Counseling! Was it for addiction? Was it for mental illness? Her ex-next-door-neighbor, Laura Ridgley said, "Ask my sister. I think it was both! Her whole family's fucked up!" Is this a valid excuse for abusing/molesting your own children? Did she abuse/molest Katy as well? What about her new husband's little girls? Are they in danger?...OR WERE DAVID'S CHILDREN HER ONLY TARGETS? SHE'D SAID SEVERAL TIMES THIS WAS THE WAY TO HURT HIM!!!

Dear Judge Crowell,

In July of 2007 my daughter, Laura Emily, told members of my family and me that her mother, Christine Belford, was forcing her to play certain sex games with her and that if Laura ever told anyone about these games that her mother would go to jail. This statement by my daughter came at the tail end of a 1 1/2 year period during which my wife had discontinued her medications for mental illness, had an affair with an employee of mine in my practice, filed a false police report stating that I had been threatening to kill her (a story she later recanted before Judge Mark Buckworth), called the police a second time in an attempt to have me arrested and humiliated before my colleagues at a continuing medical education meeting I was hosting, and lastly, threatened my life in front of my children. (This testimony can be found in the transcripts of our PFA and custody hearings). I have been trained in the management of emergency situations and have triaged eye injuries that might turn your stomach. But, when my daughter, whose health and well-being means more to me than my own life, stated these things to me, I panicked. Clearly I took the wrong steps in an attempt to protect my children. I live everyday with the knowledge that a simple phone call to the appropriate authorities might have protected my daughters and gotten Christine the help she needs. Please do not allow one moment's wrong decision to cause my children to suffer. Obviously Christine cannot be expected to confess to the abuses of her daughter but Laura will never forget what her mother did to her. Should you have need to discuss my statements herein I am available at your convenience.


The Family Court of the State of Delaware is in receipt of your correspondence dated December 14, 2011 to Judge Crowell concerning the above captioned case.

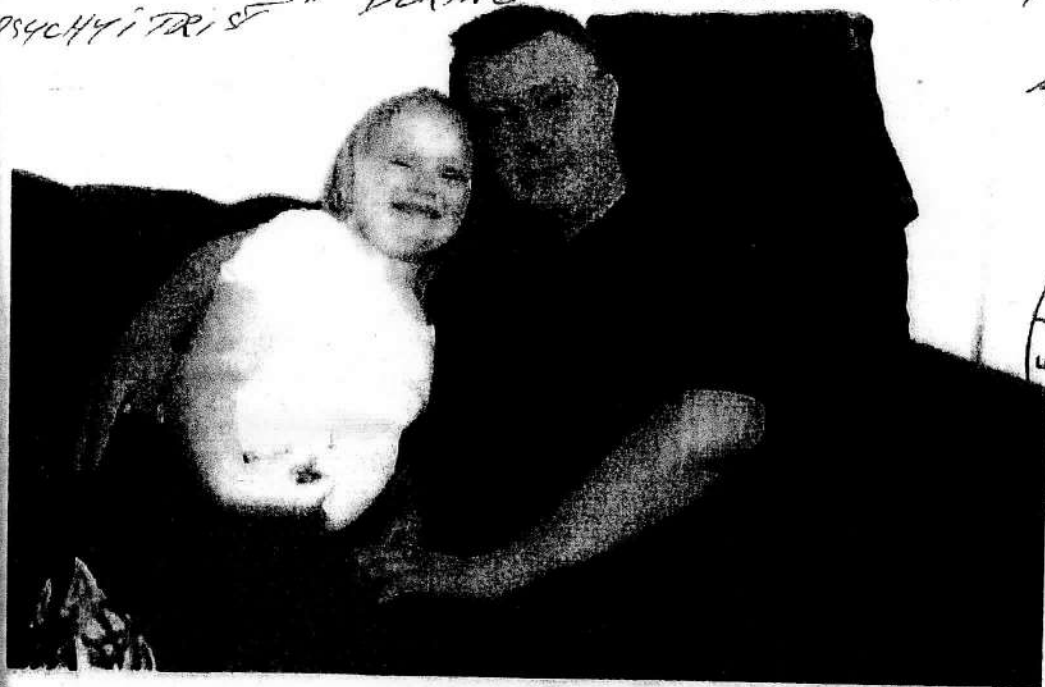

The short answer to what's happened is as follows: My now ex-wife, Christine Belford, after the birth of our third child on 7/13/05 discontinued the depression medicines she had been taking for 2+ years.

The "last straw" was when my 6 year old, Laura Emily, began wearing multiple pairs of underwear on visits with mommy that were assigned by the DE courts. When questioned by me and members of my family Laura stated that her mommy had been teaching her where her G spot was, inserting things and fingers into my daughters vagina, and demonstrating to her how she liked to be pleased sexually. I decided to take my daughters away from the situation rather than trust the DE courts who had consistently failed me and my children miserably. I am David Matusiewicz's sister, the Newark DE Optometrist who fled the country with his three young daughters, Laura, Leigh and Karen Matusiewicz to protect them from their mother, Christine Matusiewicz Belford, who sexually and physically abused them. Your letters to the Attorney General, the most recent dated February 25, 2011, have been forwarded to me for response.

The sexual abuse allegations that you reference have been investigated by the Division of Family Services and law enforcement agencies, including interviews of your granddaughters through the Child Advocacy Center. The investigations determined that no sexual abuse occurred at the hands of your former daughter-in-law. Further, the Family Court of the State of Delaware has conducted hearings between your former daughter-in-law and your son, resolving custody and visitation matters in favor of your former daughter-in-law. Lastly, as a result of your own criminal prosecution and/or the Family Court proceedings, there is a no contact order between you and your grandchildren.

As for the identity theft and credit allegations, you need to start by addressing those claims through the companies that issued the credit cards, as was suggested by the Hidalgo county Sheriff's Office. For your reference I have enclosed additional steps you should take to report your concerns.

When it occurred, Dr. Ott told his company's CEO, a 32nd Degree Mason and the former leader of all Masons in his former state that he had lived in for years, Dr. Ott's CEO became so ill, and took the rest of the day off. (He'd just sold his home and moved to Utah a couple of weeks earlier; so no doubt he was wondering if he had moved to SLC, and would be forced to move again, soon.)

Most Mormons and Masons know that the Mormon Church was founded by Masons, and the first five world leaders of the LDS Church, for at least 100+ years, were Masons. Also, until a few short years ago, from the beginning of the church, when it was founded by Joseph Smith, his father, uncles, brother and Smith had been Masons in New York.

And the Mormons' secret temple hand shakes, hand signs, and oaths, since the church was founded, were the same ones the Masons have used for centuries.

Bill Schoebelen told me, when we met in Washington State in 8/93, as I recall, that the reason he co-authored a booklet exposing the secret oaths of the Mormon Church's temple ceremonies, was due to the fact that he had been a member of several top secret, evil national and international organizations, before becoming a Christian. Eventually, he renounced each of them and exposed them in several books he wrote or co-authored.

Since I had purchased two of Schoebelen's books, *WICCA: Satan's Little White Lie* and *MASONRY: Beyond the Light*, months prior to calling him, I wanted to meet him and look into his eyes, as I asked, "What Masonic degree are you in, before you learn that your national and world leaders are Lucifer worshippers? Is it the 30th, 31st or 32nd Masonic degree?"

Without hesitating, he answered that a Mason can learn about this issue of Lucifer worship by reading Gen. Albert Pike's book, *Morals and Dogma*. Later I learned that there are two versions of it, and Pike was not only the leader of the Masons' Southern Jurisdiction, but was also the Confederacy's general in charge of military intelligence, due to his secret Masonic network throughout the South, North and worldwide. (Eventually, Pike became the third world leader of the Illuminati, as he served the Rothschild banking family subverting all nations of the world; so they could create a one-world religion of Lucifer worship, as disclosed in the Illuminati's secret documents confiscated in the late 1790s.

Schnoebelen was told by the #1 Druid in America, that if he ever got in trouble, he should contact the local Mormon Church leadership and give them certain secret hand signs and oaths. Then they would give him a get out of jail free card.

While in Utah, he joined the LDS Church, and was asked to teach there, due to his occult training elsewhere. When he became a Christian, he began writing books about Mormonism, and as a former 32nd Degree and 90 Degree Mason who had joined the Church of Satan and eventually joined the Illuminati, he's awakened hundreds of thousands of Americans, due to his many books, including *Lucifer Dethroned*. In it, he duplicated his Church of Satan membership certificate signed by Anton LaVey.

Since Dr. Ott had been a proud fifth generation Mormon for more than four decades, until he began reading U.S. Marshall Porter Rockwell's, his great-great grandfather's, secret journals, regarding the, until recently, unpublished and untold Territory of Utah history, Dr. Ott was the one making waves, by asking his church's world leaders questions in his letters to them. Therefore Dr. Ott said he knew Brad's death threat on his door was meant for Dr. Ott, not his friend.

Brad told us he overheard police detectives in the small town south of Salt Lake City speaking to each other about the odd "X," and one declared that it was the first red "X" he had seen in the past five years.

I was able to persuade Dr. Ott to spend a couple of hours with two of us and give his testimony on camera, before he drove the four hours from his new Salt Lake City office to his home in Cedar City in southern Utah.

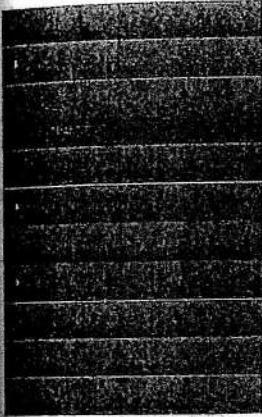

Dear Dr. Matusiewicz:

Firstly the mechanics of the application process: the Board, by state law, must deposit a check within three days or return it. Because of questions regarding your eligibility, we are returning you application with the money order. Once the check is deposited by the Board, refunds cannot be given. If you decide to resubmit the application, the deadline is still months away (January 4, 2013).

Secondly, your eligibility for the License Without Exam application procedure: based on your graduation date, we assume that you did not take Part III of the NBEO after May of 1994. If you did, please let me know because you would then apply under the "normal" application process.

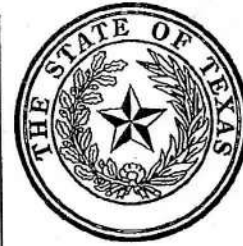
Your eligibility is in question because the License Without Exam application procedure is governed by Section 351.2595 of the Optometry Act. That statute has these restrictions:

The board may issue a license to practice therapeutic optometry without requiring the applicant to pass all or part of the examination required by Section 351.253 if:

- (1) the applicant is licensed in good standing as a therapeutic optometrist in another state;
- ...
- (3) during at least five of the seven years preceding the application date, the applicant has been:
 - (A) actively engaged in the practice of therapeutic optometry; or
 - ...
- (5) the applicant's license has never been suspended or revoked.

According to the information provided in your letter (and confirmed on the website for the State of Delaware), you do not meet the requirements in subsection (1) and (5). It is difficult to tell from the information you provided with your application, but you also may not meet the qualification in subsection (3).



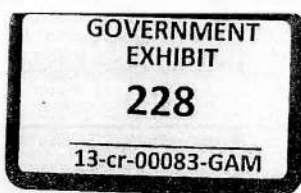

stopped him saying that it would only make matters worse. David is very non-confrontational. Katy Moffa testified to this incident in court with a much different memory at least 8-10 yrs later.

Chris started jumping up + down, while my dad still had a hold of her arm, Chris causing a scene. Mom + I realized what she was doing so we told my dad to "let her go - don't touch her." Christine got out her cell phone to take pictures for the police to show my dad "abused" her.

She was setting him up to be arrested, but he didn't realize it. As she started to walk outside with my dad she threatened to kill my mom + my dad. Dad was going to the police station to report her when David

She's not happy! Says she's going to tell Gramma & she doesn't want phone calls or visits & they'd better get her out! Why would you cut your connections with someone and then expect them to help you? She's steaming! After talk with Gramma, she's calmed down. Says Gramma's a drama queen. Says she's got to give up Dre though she likes him. Told her sometimes you have to do what you have to do "not what you want to do."

3-2-70 CD called me at 4:30 for shower & med. run.

Tues. I asked if I'm supposed to eat. She's not allowed to know my condition, where I'm going, etc. because of HIPPA. I said "I'm going for surgery; I shouldn't eat." She called B+R & Garley didn't know. She called in Air merge. They said "go ahead & eat." I ate pancake & a cup of milk around 5:30. Then they rushed me to B+R where I waited until around 6:00 am. Mr. Mills & Mr. Cortes took me to St. Francis hospital in Wilmington. We went to outpatient surgery where I changed into a hospital gown, booties & a hair net.

Maybe I should stop all the medicines and add one back at a time to see what they do! They're experimenting on my body. Why can't I? Tom, Laura, Chris have an appointment today with Laura's psychiatrist. Tom has to be extra good and remember not to call Christine "the whore-bitch" and don't touch her! Please God! Give Laura the strength and courage to tell the doctor what Mummy's done to her and make Laura do to her "to make her feel good". Why did Angel "see" Laura, Leigh, Karen & me together but not David? He wasn't helping me in my dream either! Was he there? Where? Angel kept having the dream about the blonde-haired blue-eyed little girl sitting alone on her bed. We figured Laura, but maybe Leigh or Karen... or does she represent all three? Angel said Chris is going to be prosecuted for what she's done - what good would that do? They've got to come back to the love of my family so we can start the healing. I asked Angel if she could forgive someone who mistreated or abused Michelle (not even her favorite Emily) and she immediately said "yes" BUT whenever

Dr. Matusiewicz:

Were you disciplined by the Delaware Optometry Board? The Texas statute lists as one of the qualifications:

(5) the applicant's license has never been suspended or revoked

Optometrists have been licensed that have a felony conviction. Each case is a unique situation, and I certainly do not make the decision (meaning I cannot give you a definitive answer).

David trying to get h's optometric license in TX

There are two ways to do this:

1. Request a criminal history evaluation letter under Rule §271.7. Cost is \$125. Board will issue a decision that is most likely binding on future board decision regarding an application for license. Will also need to submit fingerprints (~\$40) and copies of court documents. Board has 90 days to issue letter; or

2. Apply for License Without Exam: \$300 (plus fingerprint charge, court documents, transcripts). Board will directly make the decision on whether you may be licensed.

Dear Dr. Maschauer;

A lawyer we know discussed David's case with Sam Nickerson who is the lead investigator for the Division of Professional Regulation without using any names. He was told that:

1. There is no obligation to report any criminal allegations or charges until convicted.
2. Once David were to self report or a complaint is filed, allow 60 days to investigate, charge and schedule the matter for a hearing. He said in reality allow 6 months.
3. David would be free to continue to practice during the investigation unless the attorney General seeks an immediate suspension. He felt that since the criminal charges do not involve his practice or patients, immediate suspension was not likely.

The real concern is the penalty. He believed that it was unlikely that the Board would revoke his license, since the crimes do not involve his practice per se. A short suspension or probation was more likely. We can offer "safeguards", reporting requirements or perhaps someone can agree to mentor David... assuming he has friends in the business.

He thought also that as part of the plea agreement that the Fed/State would not be looking to have his license pulled for the reasons outlined above. He suggested some language in the plea agreement that the prosecutor does not oppose David's being employed/working in his field. By allowing him to work, he can earn money to pay his fines and restitution, and more importantly, his obligations. Otherwisew, it will only harm his children.

We have sent a copy of the research done by our friend showing that a doctor who had sexual contact with at least two of his patients without consent is currently practicing in Delaware. Is David's crime of taking his children out of harm's way and preventing his wife from following while trying to help/protect his ex-wife worse?

Finally, Mr. Dennis Deters' organization from Minnesota has found excessive punishment metered out by the court in David's case and motions have been filed.

Please, take all of these things into consideration while you are trying to make your
