I pray that you are all well. Thank you so much for the money that you put on my account. It will definitely come in handy to buy stamps, coffee + cream, especially when I am not working at my regular job in the chapel right now due to the lockdowns. I worked only from sun to wed in the kitchen + ran around like a work horse while I watched the 20 yr olds run + hide to get out of working. Even one of the bosses there had to snag some of the girls that were hiding to come + help me who was turning pallets of dinner bags from one side of the cafeteria to the other after I got done serving the entire compound breakfast + lunch. I haven't been on the schedule to go back to work since then, but I believe ~~my boss in~~

the chapel tried to get me out of the kitchen. I am just so ready to get back to my job in the chapel because I really miss my Sundays having the pleasure of doing service 4-5x that day - it brings tears to my eyes each time I see it even though it is the SAME service. What I am even more ready for is to GO HOME!!!

BTW I did send a letter & packet to Mira Terada. I don't know if she received it or not because I haven't heard anything back from her.

so I wanted to share with you all of the craziness that has been going on in my life lately.

- On 12/30 Thurs on my home unit of 3 south, 3 people tested positive for COVID so they mass tested the entire unit where we all tested (-)
- on 12/31 Fri 3 more ladies tested (+)
- on 1/1 Sat 2 more ladies tested (+)
- On 1/2 Sun 4 more ladies tested (+)
- on 1/3 Mon we were told that we were getting roommates.

We were also told that 3 south would be mass tested & it was not done. Instead 3 south was moved to 1 North where 1 person tested (+) & was taken to SA (quarantine unit). Unit 1N was not mass tested. 1 North bottom bunks on 1 side of the unit was transferred to 2N so 3 south bottom bunks could move into those bunks.

spread the infection

That night 6-7 people from 3 south tested (+) & were transferred to 1 south (quarantine unit)

- on 4/4 Tues all of 1N mass tested & approx. 50 of us tested (+) & were transferred to 1S (quarantine unit)

- on 4/5 sat Transferred back to 3 south after 10 days of quarantine.

- on 4/6 Put in kitchen to work even though I already have a job in the chapel.

- on 4/21 Fri all of 3 south pack up AGAIN to move to 2S - mattress loaded with

all "worldly belongings" that will fit  
in a locker to drag across the  
compound - fingernails bent backwards,  
cuts on hands where knuckles  
scraped across the cement. Lady  
seized in front of me during  
transfer. This is how herd  
immunity super spreader begins...  
Who knows where we are headed  
to next or when. I hear my old  
unit of 35 is going to be LCP  
Life connections Program unit. They  
have been trying to get that unit  
for a while now. I just hope  
to either transfer back there where  
my legal locker is located or  
get a dolly to transfer my entire  
locker over here because there  
is no room for 1 more paper.

Please continue to pray for  
some much needed justice, grace  
& mercy. Thank you for all that  
you are & all that you do.
