

support! we could never get through all of this without you! My God is Bigger + stronger than ALL of this! Court prayers

Hello, My name is Amy Gonzalez. I never had a criminal record until I was sentenced to life in prison with no chance of release for a crime my father committed. I write today to share my plight and hopefully enlist your help in overturning my unjust issued term of imprisonment. I am a wife of 23 years, a mother of a 17 year old daughter, and 31 year old son, who have been without me for 10 years, and prior to this unfortunate conviction I was a Registered Nurse for 25 years. I am a person dedicated, committed, and qualified to save lives, not take them. In addition to being a wife and mother, I am a sister to David Matusiewicz, who before this was an Optometrist who owned a thriving business doing what he loved, helping people see and enjoy a greater quality of life.

When he went through a messy divorce, as they often are, with his wife Christine Belford, things began to take a turn. We soon suspected that the three daughters he and Christine shared were being both physically as well as sexually abused by her. While seeking professional advice, our family became involved with a National Organization known as Unite4Justice to implore their assistance in getting help for Christine who had known mental health issues which in turn would deter further injury to my nieces. We were advised by their CEO, Doug Millar, to put our story on the internet to aid

in achieving this goal.

Out of further desperation, which led to the beginning of the unraveling of our lives, my brother and mother fled the country with his three daughters. I can not see my brother, an intelligent career driven individual, making such a drastic decision without truly believing in his desire to protect the children he loved. He believed so much in his justification that he ultimately relinquished his entire profession to ensure their protection. Yet, and even though there was no malintent, my brother and mother were both apprehended, charged and convicted. My brother with International Parental Kidnapping and my mother with Endangering the Welfare of a Child.

What led to the serious extreme next event no one may ever know, but on February 11, 2013 my father, Thomas Matusiewicz, who had a left frontal lobe meningioma brain tumor (since 1990) shot and killed my former sister in law, Christine and her friend, Laura Mulford prior to committing suicide at the Delaware Courthouse. Clearly, he was unstable and to say the very least, made a terrible judgment call. An expert that was to speak at our trial regarding the impact or influence his tumor could have played in this was never admitted to testify.

My father's actions that day resulted in a ripple effect which has gone on to further destroy the lives of many. Were it possible for me to change the events of that day, I would do so for everyone involved, but that sadly is not within my power.

Before my mother, brother and I could fully process this terrible blow we were indicted and charged with cyberstalking resulting in death, conspiracy to commit cyberstalking, and insterstate stalking, along with aiding and abetting my father. We elected to exercise our rights as citizens of the United States and took the matter to trial. Unfortunately, we lost and each of us received a federal sentence of life in prison which at no point during your incarceration offers the availability of parole. LIFE IS LIFE. LIFE IS DEATH IN FEDERAL PRISON.

My mother, Lenore Matusiewicz had an "emergency" sentencing at her hospital bedside only 10 days after she had undergone brain tumor surgery. Thus, to be ensured she would be sentenced in the event she became unresponsive or died. She was further humiliated and pained by knowing the audio version of her sentencing was on the internet for all the world to hear. She seemingly gave up on life and later on Mother's day weekend in 2016 she suffered an unmerciful death resulting from brain tumors while

lying in a prison bed.

My brother and I continue to fight for justice relief. The primary reason our battle is met with such resistance in the courts is because of the politics involved. We have what is classified as a precedential case, meaning it sets the tone for others to follow. Essentially, should our case be reversed it would benefit others with similar bearings. Therefore, tragicly once again my brother and I are casualties of an unforseen war.

Please, as a woman, a mother, a human being that is broken, I beg you to please help us. Enough is enough. There has to be someone somewhere that recognizes the brutality and significance of our trial. To say nothing of the unjustified terms of imprisonment imposed upon us for a crime we did not solicit, condone, or commit.

I have been incarcerated now for 10 years. Most employee jobs I have held during this time are clerk positions, which put me working in close proximity with staff and a leader to fellow inmates. I strive endlessly to keep hope alive that I will soon be reunited with my husband, daughter, son, and brother so that we can finally

respectfully grieve our losses.

Again, there is NO way for me to go back and change my father's actions and I am beyond SORRY for the loss of lives that resulted. But I NEVER INTENDEDOR EXPECTED for anyone to be hurt much less murdered. I have heard of countless crimes on television in which people beat, rape, rob, and murder someone and receive less time than I was given. I do not say this to take away from the tragic death of Christine or Laura. I only mention this to bring awareness to and shed light on the level of injustice surrounding my circumstances.

Our trial documents can be viewed on pacer. Also I have a webpage which exposes the untruths told by the government prosecutors to gain a conviction against my

We are closing in on the end of possibilities, as we have repeatedly been denied in the higher courts. Without help and bravery of someone to support our cause, we, like our mother, will die alone in prison. Thank you for your time. I will be praying for your response.
