Dear Mr. Price,

My name is Rosy Esprecion, on behalf of We the People of the Republic of the United States, and one of Mr. Anthony Troy Williams' client, thereby, humbly sending this letter to you. Inauspiciously, Mr. Williams was falsely accused, unlawfully incarcerated and continues to be prosecuted by the prosecutor's office, for crimes he never committed. What disturb us the most is that, your office erroneously claimed that I am one of the victims of Mr. Williams, when I made no such complaints. What is even more disturbing is that your office included some of our names in your indictment, as if we made a complaint personally, to your office, against the services of Mr. Williams, which we have not filed such complaints, neither, verbally or in writing. The FBI came to some of our homes unsolicited, unannounced and unwarranted. These are the FBI's malicious tactics that they used to intimidate, to coerce and to inflict fear, knowing that the innocent, undereducated, older and culturally inhibited local people of Hawai'i, could be easily intimidated by these so called "authoritative figures," from the FBI, the bankers, the US Attorney's office and or the judiciary officials, who used and abused their so called "power and entitlement," to take advantage of our innocence.

None of the interviews did we allude to the notion that Mr. Williams misrepresented his services to us. On the contrary, Mr. Williams personally, notified the local FBI office and reported that it was his former employees namely: Edna Franco, Henry Malinay, Rowena Valdez, Hep Guinn, among others, who colluded because of their greed, jealousy and lust for money. These named individuals not only colluded, but also open a copycat company called "Mortgage Enterprise," which they intentionally made, similar to Mr. Williams' "Mortgage Enterprises, Investments,," to deceive the innocent local people of Hawai'i, that would not know or take notice of, the difference between the two companies. These named individuals were the people who scammed us and defrauded us, yet, your office, turned a blind eye and did nothing to prosecute them for their fraudulent crimes. Rather, your office chose to prosecute Mr. Williams because of your office's animus agenda against Mr. Williams. Of course, you would rather catch the "big fish" vs. the "little fishes." Another metaphor: "an elephant vs. a flea."

Mr. Williams has never misrepresented his services to us, in fact, he was honest and dedicated in assisting us the best he could, in fighting our illegal foreclosures to keep us in our homes. Because of his unlawful indictment by your office, he has been unable to continue to assist us with our foreclosures as effectively as he had done before. As a result, most of us lost our homes without the requisite trial by jury, before our homes are foreclosed on as mandated by the 7<sup>th</sup> Amendment of the US constitution. The corruptions by the banksters, the mortgage lenders and their lawyers, in collusions with the venal interests on some of our local judiciary officials, had gone on for so long and must be stopped.

Mr. Williams is just a "flea," who dared to question and to challenge the "status quo." He made it his personal passion to assist the "downtrodden," as many people as possible, to keep us in our homes. However, because he is a Pro Se, Black defendant, these "powerful ring of wealthy, elite group of people," cogitated to shut him up, and to assure that he will not ever receive his fair trial in court. Multiple violations of his civil and constitutional rights that has been in continuance, to date, by the BOP system, the Prosecutor's office and the judiciary system, and that is the 6<sup>th</sup> Amendment of the U.S. Constitution which states: "In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defense."

Mr. Williams have been unlawfully incarcerated for three years thus far, without his due process of a "speedy trial," to date. Mr. Price, we ask you this question: How could a defenseless, Pro Se, Black defendant, could ever fairly receive justice? We the People, believe that we live in a democratic country and not a country that practices despotism. However, with the human rights violations that are being and continues to be perpetrated against Mr. Williams by our own judiciary officials, the prosecutor's office and the FDC-Honolulu officials, that these officials are and have been abusing their power to date. Mr. Price, We the People, believed that these, so called, "powerful, elite group of people" are and have been carrying out 'despotism' against the incarcerated inmates inside FDC-Honolulu, especially against Mr. Williams. Tell us Mr. Price, who could "We the People" turn to, to obtain justice against these atrocities that are being committed by these so called "powerful, untouchable officials of the law"? Will you turn a 'blind eye' as well? We are humbly asking you to do what are rightfully moral and ethical, in the eyes of the law. See Exhibits A, B, C and D. Please note that the excerpts from the personal letters in these Exhibits has been edited and only the pertinent statements in regards to Mr. Williams' issues were copied, to preserve personal privacy contained in these letters.

We the People can no longer sit idle and continue to allow the prosecutor's office to destroy the lives of an innocent, honest and a decent man and his 72 year old mother. The prosecutor's office unlawfully indicted and incarcerated the wrong person. The names of the fraudulent people who committed these fraudulent crimes should have been all indicted and prosecuted and NOT Mr. Williams.

On behalf of "We the People," we are demanding to dismiss Mr. Williams' case, with prejudice, and to dismiss the animus prosecution against Mr. Williams and his 72 year old mother. We are also demanding that the names listed at the end of this letter, be removed from your office's indictment as "victims of Mr. Williams."

As the appointed Interim Chief Federal Law Enforcement Officer, we implore that you investigate this case and we expect nothing less from you, to implement your "Oath of duty," as our public servant. Mr.

I have not had my DHC hearing because they keep postponing it because they know I'm going to beat the bogus charge. So they are making me sit here as long as possible waiting on this damn hearing. I was finally able to go to the law library today but I could only be there for 2 1/2 hours and had to be taken back to my cell. They still haven't allowed me to have access to my legal bins so I can't get to the documents that I need to submit for my evidence list. I have been as patient as a man can be whose right have constantly been violated.

They gave us a new commissary form for the SHU yesterday and these bastards took off the list writing pens so now after my ink runs out with the pen I have now I will no longer have a pen to write with and will have to use the half cut pencils with no erasers on them to write now. This is against the law because no matter where we are in the jail we are supposed to have access to a pen and paper. They put a legal pad on the list now to have paper but took the pen off the list.

Since it seems they won't be having my hearing soon can you re-subscribe to the USA TODAY newspaper to be sent to me. Oh I forgot to mention also that we can't order batteries no more for our radios while in the SHU so once these last batteries die I won't be able to keep up with the news or sports unless you subscribe for me the newspaper. Thanks. I wrote Phifer yesterday asking him to find an attorney that's in one of our schools and see if they will help me. That's the only way I will trust an attorney at law if he believes in Yahshua and is a member of our school. I'm hoping that there is one because I know that they would help me. Honggeay Sa muli. IDK!

He said that Kobayashi has stopped approving the subpoenas and he don't know why. She had approved the first 25 or so but hasn't approved the others yet. I will question her at the hearing the reason for the delay.

The unit manager Kohl came and told me they were going to try to have my DHO hearing today if they could get him on the phone. I guess they didn't connect with him because I didn't have the hearing. I wrote my Standby and sent him 3 more motions that I wrote for him to file. I also wrote Mr. W today so he'll probably get that letter either Saturday or Monday.



Dear Mr. Williams,

In regard to the above-referenced case, we are in receipt of your letter dated November 17, 2019 enclosing requests for additional witnesses and requesting me to file more motions on your behalf. We have prepared over 35 *ex parte* motions for fact witnesses and have requested, or are in process of requesting, a large number of expert witnesses to testify at your trial. This is on top of the filing of over 100 motions on your behalf and requests from you to assist in obtaining discovery and materials for you.

My firm's resources are not unlimited. It is my estimation that at this point, we are at, and have probably far exceeded, my firm's capacity to attempt subpoena and handle this many fact and expert witnesses in your case. Thus, I can no longer prepare and file any new *ex parte* requests for witnesses, both lay and expert, in your case, that you designate after your November 17, 2019 letter.

I have enclosed a letter that I received from my standby basically telling me he will not file any more of my subpoenas because his firms resources are not unlimited. However, he gets funding from the government so that he don't incur any expenses. I guess they didn't expect me to have this many witnesses to come and testify on my behalf and now they want to curtail and hinder my defense. This is very frustrating because not only am I being deprived access to the law library and my law work, now I'm being told that he is overwhelmed with helping me. It baffles me because all he has had to do is have his secretary scan and e-file my motions, print out a few documents that I needed and send out template subpoenas. He has not had to draft not one motion on my behalf or do any real research or work so what in the hell are you overwhelmed with?

Anyway, I will just send you my motions to file. If he doesn't send me those CD's that you gave him then I'm going to send him a letter to have him send the CD's back to you or to have you pick them up. If need be Mr. W. can send them to me and I will get them because he is the media and media mail is special mail. He would have to send it certified so I would have to sign for it and that would ensure I received it when it arrived here at the facility. Oh I just remember Sherri is a journalist and part of the media and she could send it from their media company to me as special mail. They would have to label the outside - SPECIAL MAIL - OPEN ONLY IN THE PRESENCE OF THE INMATE - and send it certified mail so I have to sign for it.

On October 22, 2019, pro se Defendant Anthony T. Williams ("Defendant") filed a document titled "Notice to the Court that Private Attorney General Anthony Williams Will Have Documents Filed by Anyone Whom He Designates." [Dkt. no. 616.] This filing is HEREBY CONSTRUED as a request to have two individuals – William Wagener and Rosy Thomas – be granted permission to file documents on Defendant's behalf ("Request"). See Request, Decl. of Counsel, Exh. A.

First, Defendant is proceeding pro se, with Lars Isaacson, Esq., as his standby counsel. Mr. Isaacson has been dutifully filing documents on Defendant's behalf. Second, William Wagener and Rosy Thomas do not appear to be attorneys who are licensed to practice in this district, and therefore they are not permitted to represent Defendant. See Local Rule LR81.1(a) (stating that persons appearing pro se "must appear personally on behalf of themselves only and may not delegate that duty to another who is not authorized to practice in this court"). Defendant's Request is therefore DENIED.

The Clerk's Office is DIRECTED to refuse to file any documents submitted by William Wagener, Rosy Thomas, or anyone other than Defendant or Mr. Isaacson.

COURT ACTION: EO: COURT ORDER DENYING DEFENDANT'S "MOTION FOR PLEA OF MISNOMER"

Before the Court is pro se Defendant Anthony T. Williams's ("Defendant") "Motion for Plea of Misnomer" ("Motion"), filed on August 14, 2019. [Dkt. no. 553.] The Court finds that: the Motion is suitable for disposition without a hearing pursuant to Local Rule 7.1(c); and it is not necessary for Plaintiff the United States of America ("the Government") to file a response to the Motion.

Defendant asks this Court to dismiss the charges against him because they are brought against "ANTHONY TROY WILLIAMS," who Defendant contends is a "legal fiction . . . with a demonic social security number." [Motion, Decl. of Counsel, Exh. A at 2.] In contrast, Defendant contends he is "a sentient living being known as Private Attorney General Anthony Williams who is devoid of a Social Security Number or any government issued Identification card(s) or any governmental identifying numbers." [Id. at 1.]

Defendant essentially seeks dismissal of the Superseding Indictment, [filed 3/28/18 (dkt. no. 154),] on the ground that he is not the person identified as the first defendant therein. Defendant's argument is rejected. Defendant has already filed a motion seeking the dismissal of the Superseding Indictment. ["Sworn Motion to Dismiss Superseding Indictment" ("Motion to Dismiss"), filed 7/20/18 (dkt. no. 294); Order Denying Def.'s "Sworn Motion to Dismiss Superseding Indictment," filed 10/1/18 (dkt. no. 330) ("10/1/18 Order").] In the 10/1/18 Order, Defendant's challenge to the sufficiency of the Superseding Indictment was rejected. [10/1/18 Order at 11.] The Motion did not argue Defendant is a different person from the person identified as the first defendant in the Superseding Indictment.

Further, Defendant has previously admitted to some of the facts in the Superseding

---

Indictment. For example, the Superseding Indictment states "Mortgage Enterprise Investments (MEI) was a business owned and operated by defendant, Anthony T. Williams." [Superseding Indictment at ¶ 1.] Defendant's statements in other filings have admitted his role in MEI, but Defendant argued the Government has misrepresented the nature of MEI's services. See, e.g., Order Denying Def.'s Motion for Suppression of Evidence & Def.'s Motion for Evidentiary Hearing on Motion to Suppress, filed 7/26/19 (dkt. no. 533), at 10-11 (discussing Defendant's challenges to statements in the affidavit used to obtain search warrants).

On the basis of the foregoing, the Court rejects Defendant's argument that he is not the person named as the first defendant in the Superseding Indictment. Defendant's Motion is DENIED.

COURT ACTION: EO: COURT ORDER DENYING DEFENDANT'S "MOTION TO NOTICE OF DIVINE WARNING AND SUPERIORITY OF YAHWEH'S SPIRIT LAW"

Before the Court is pro se Defendant Anthony T. Williams's ("Defendant") "Motion to Notice of Divine Warning and Superiority of Yahweh's Spirit Law" ("Motion"), filed on August 12, 2019. [Dkt. no. 552.] The Court finds that: the Motion is suitable for disposition without a hearing pursuant to Local Rule 7.1(c); and it is not necessary for Plaintiff the United States of America ("the Government") to file a response to the Motion.

*This is illegal and shows bias.*

The Motion asks this Court to enter an order stating that Yahweh's law supersedes the United States Constitution and all other forms of federal law. [Motion, Decl. of Counsel, Exh. A at 2.] To the extent Defendant seeks a ruling that, as a matter of faith or religion, Yahweh's law is higher than all federal legal authority, this Court has already informed Defendant that this is not a form of relief which this Court is able to grant. See EO: Court Order Denying Def.'s "Motion for Exposition of Spiritual Warfare," filed 9/28/18 (dkt. no. 324), at 1-2. Defendant's request is therefore DENIED.

In light of the denial of Defendant's first request, his request to have the Government's attorneys "removed immediately and terminated from their position and forever barred from holding any other public office" if they refuse to recognize the supremacy of Yahwah's law, [Motion, Decl. of Counsel, Exh. A at 2,] is also DENIED. The Motion is therefore DENIED in its entirety.

COURT ACTION: EO: COURT ORDER DENYING DEFENDANT'S "MOTION IN OPPOSITION TO ORDER DENYING MOTION TO SHOW ADMINISTRATIVE REMEDY PROCEDURES AT FDC HONOLULU ARE A SHAM, FARCE AND NO AVAILABLE MEANS FOR REMEDY"

On June 1, 2019, pro se Defendant Anthony T. Williams ("Defendant") filed a "Motion to Show Administrative Remedy Procedures at FDC Honolulu Are a Sham, Farce and No Available Means for a Remedy" ("Administrative Remedies Motion"). [Dkt. no. 493.] On August 7, 2019, an entering order was issued denying the Administrative Remedies Motion ("8/7/19 EO"). [Dkt. no. 540.] On August 15, 2019, Defendant filed his "Motion in Opposition to Order Denying Motion to Show Administrative Remedy Procedures at FDC Honolulu Are a Sham, Farce and No Available Means for Remedy," which is construed as a motion for reconsideration of the 8/7/19 EO ("Motion for Reconsideration"). [Dkt. no. 554.] The Court has considered the Motion for Reconsideration as a nonhearing motion, pursuant to Local Rule 7.1(d), and the Court finds that it is not necessary for Plaintiff the United States of America ("the Government") to file a response.

This Court has previously stated:

Although there is no rule in the Federal Rules of Criminal Procedure expressly authorizing the filing of motions for reconsideration, this district court has recognized that many courts – including the Ninth Circuit – allow motions for reconsideration to be filed in criminal cases. See, e.g., United States v. Hee, Cr. No. 14-00826 SOM, 2015 WL 6510345, at \*11 (D. Hawai'i Oct. 27, 2015) (listing cases). "[M]otions for reconsideration in criminal cases are governed by the rules that govern equivalent motions in civil proceedings." Id. (alteration in Hee) (citations and quotation

marks omitted). The 8/20/18 EO was a nondispositive order, and Local Rule 60.1 would govern a motion for reconsideration of a nondispositive order in a civil case. Local Rule 60.1 states that such motions for reconsideration "may be brought only upon the following grounds: (a) Discovery of new material facts not previously available; (b) Intervening change in law; (c) Manifest error of law or fact."

[EO: Court Order Denying Def.'s "Motion for Reconsideration of Court's 8/21/18 Electronic Order Re: 'United States's Motion to Extend the Deadline to Respond to Defendant's Motion to Dismiss,'" filed 10/1/18 (dkt. no. 329) ("10/1/18 EO"), at 2 (alteration in 10/1/18 EO).]

The Motion for Reconsideration argues Defendant has proven that, although he has been following the administrative remedy procedures, he has been wrongfully denied administrative remedies that he is entitled to. [Motion for Reconsideration, Decl. of Counsel, Exh. A.] The Motion for Reconsideration fails to address the bases of the 8/7/19 EO: 1) Defendant's general challenges to the alleged defects in the grievance process should be addressed through other actions; and 2) even where Plaintiff the United States of America has argued that this Court should not consider Defendant's arguments that the actions of Federal Detention Center - Honolulu ("FDC Honolulu") have impaired Defendant's ability to prepare his defense, this Court has considered Defendant's arguments. [8/7/19 EO at 1.]

Defendant's Motion for Reconsideration does not identify any newly available evidence or intervening change in the law. Further, Defendant has not established any manifest error of law or fact in the 8/7/19 EO. Defendant's Motion for Reconsideration is therefore DENIED.

IT IS SO ORDERED.

Before the Court is Defendant Anthony Williams' Motion to Order the Government to Provide Medical and Dental Services to Private Attorney General Anthony Williams, filed on September 16, 2019 (Motion). See ECF No. 578. The Court finds this matter suitable for disposition without a hearing pursuant to Rule 7.1(c) of the Local Rules of Practice of the United States District Court for the District of Hawaii (Local Rules) and that it is not necessary for Plaintiff to file a response to the Motion.

In his Motion, Defendant asserts that he has been denied teeth cleaning while he has been held as a pretrial detainee at the Federal Detention Center Honolulu (FDC). See ECF No. 578-2 at 2. Defendant states that being

denied teeth cleaning constitutes deliberate indifference and is a violation of the Eighth Amendment. See id. Defendant also states that inmates at FDC are required to discuss their private medical issues in front of other inmates, which violates the inmates' right to privacy and confidentiality. See id. at 3.

"As several courts have recognized, the proper procedure to redress a defendant's grievances regarding treatment within a jail or prison is to file a civil suit against the relevant parties pursuant to 42 U.S.C. § 1983, rather than a motion in his criminal case." United States v. Luong, No. CR 99-433 WBSGGH, 2009 WL 2852111, at \*1 (E.D. Cal. Sept. 2, 2009) (citations omitted). This procedure prevents pretrial detainees from bypassing the Prison Litigation Reform Act's exhaustion requirements, which apply to pretrial detainees and detainees awaiting sentencing. See 42 U.S.C. § 1997e (requiring administrative remedies to be exhausted prior to filing suit regarding prison conditions); see also See Ontiveros v. LA Cnty., 611 F. Supp. 2d 1090, 1094 (C.D. Cal. 2009) ("Requiring exhaustion allows prison officials an opportunity to resolve disputes . . . [and] has the potential to reduce the number of inmate suits, and also to improve the quality of suits that are filed by producing a useful administrative record." (quoting Jones v. Bock, 549 U.S. 199, 204 (2007))). Defendant has not established that any exception to the exhaustion requirement applies. See Terrell v. Brewer, 935 F.2d 1015, 1019 (9th Cir. 1991) ("Exhaustion is not required if: (1) administrative remedies would be futile; (2) the actions of the agency clearly and unambiguously

violate statutory or constitutional rights; or (3) the administrative procedure is clearly shown to be inadequate to prevent irreparable injury.”).

In prior orders, the Court has provided information to Defendant regarding the available administrative procedures. See ECF No. 132, Order Denying (1) Motion For Order To Show Cause, And (2) Ex Parte Application And Motion For Funds To Purchase Legal Supplies At Government’s Expense, at 3-5, *aff’d* by ECF No. 326; see also ECF No. 346, Order Denying Defendant’s Motion for Injunction Against FDC for Retaliation (stating that Defendant “must follow the appropriate administrative procedures and/or file a civil rights action or a 28 U.S.C. § 2241 petition” regarding his requests related to his treatment at FDC).

Defendant Anthony Williams’s Motion to Order the Government to Provide Medical and Dental Services to Private Attorney General Anthony Williams, ECF No. 578, is DENIED.
