Dear Rudy and Erin,

January 6, 2021

I received your Christmas card on December 28, 2020 although you mailed it out on 12-11-20. They held this mail for over 2 weeks before giving it to me. I really appreciate both of you for your unwavering love and support. This past Sunday I was finally allowed to start having bible study with the other inmates and the studies were going very well and for 2 days more inmates attended. Then on Tuesday this black devil named officer Silvestre told us that he didn't go to church therefore we can't have our bible studies. I told him that we had already had gotten it approved and had been meeting for the past two days. This black devil not only prevented us from having our bible study, but he took down the schedule put up by the Chaplain which stipulated the times we could have our bible study and put up a sign that said the Chapel was permanently closed due to COVID-19 and to ensure social distancing which is a bunch of hogwash. When we are let out of our cells for the 2 hours per day we do

not social distance so that excuse to close the Chapel because of social distancing for COVID-19 is a blatant lie. I requested to speak to a LT and he disregarded it. Then this morning when I asked him why would he take the Chapel schedule down and deny us our religious rights he told me to go in my room. I then requested a LT again and told him that he has an attitude problem and acting like one of the female inmates on the 5th floor. He then threatened me and asked me did I want to fight him. I told him no because I know he'd get on his walkie talkie and call for back up and have 20 officers jump me. He then told my cell mate Rodney Rackley to step out the room and took a stance to fight me and said, "You got 5 minutes and I'm gonna rape you." My cellmate stepped back in the room to ensure that he didn't try nothing. He then closed our door and locked us in. I spoke through the door telling him to call a LT so that I could report

what he did and no CT still hasn't been called. We don't come out until 6pm tonight so I won't be able to report this incident on the email to the warden to notify him what this black devil threatened me with this morning. This officer is approximately 270 lbs and looks like the son of King Kong. The other inmates whose cells are adjacent to mine and in the surrounding area also witnessed what happened. This same officer seems to be high on drugs when he comes to work and some of the inmates have said that he is one of the officers that brings the drugs in for them to smoke. On the 29th of December 2020, the medical button was pushed by the inmate in the cell next to ours which is cell #12 and the medical emergency was because his cell mate was so high on drugs he started throwing up blood and shaking. When the officers came a female officer had a video recorder to record the incident. They took the inmate out and placed him in the SHU. The dope smell from their cell was so prevalent that my cellmate and I had to put on our face masks and get under the covers to avoid inhaling the fumes. A few days before this incident the smoke was so prevalent and unbearable that I had to push the medical emergency button to have the C.O. come

to our cell. When he asked what was going on I told him that I can hardly breath with this dope smell permeating through our vents, under the door and the crack in the wall that the smoke from the next cell comes through and that it was giving me a headache. I asked him, "I know you can smell that right?" He said what do you want me to do. I said let me out this room so that I can get a break from this smoke and get some air. He opened our door and let me and my cellmate out so we could go to the dayroom to escape the drug smell that permeated through the whole bottom corner of the unit. The officer's name who showed this kindness and human decency to us was officer Alvarez. He is a fill in officer and not our normal day today officer who is sylvestre. Sylvestre was told by several of us to do something about the drugs being smoked in this unit especially when it's coming in my cell and affecting me and his response is to just deal with it. I have tried to just keep quiet and not say anything because someone doing dope is their business

but when it is affecting my health and my safety I have to say something. If the warden doesn't do something about this officer threatening to assault and rape me and about these drugs, then I'm going to write Washington, D.C. Headquarters and make a complaint and add this to the lawsuit that I filed just last week.

As you can see the devil is really busy and doing everything to make my incarceration as miserable as possible but my faith in Yehshua is what sustains me and I know that no weapon formed against me shall prosper.

In other news, I wrote my case manager to ascertain when the State of Florida would be coming to get me and she wrote me back and said that there is nothing in the system about a hold from Florida, only a hold from the US Attorney's office. She said that their system sees everything and that there is nothing from Florida. If this is true this means my Florida conviction has been overturned but they haven't notified me of this. I will try to get my appeal attorney to look into this for me.

Thank you for the transcript of that lying hypocrite Henry Malinay. It was appalling how they made it look like he had a bad childhood and illiterate, and that's why he scammed folks

and then blamed me and said he was a victim and lost his house because of me. It was laughable because the pett. fogger-persecutor Gregg Paris Yates exposed himself as the lying white devil he is by contradicting himself in his address to the court regarding Malinay. MOTION TO SHOW FDC WITHHELD MOTION FOR VARIANCE AND BLATANT LIES OF DARSIE ING DODSON AND THAT PRIVATE ATTORNEY GENERAL Anthony Williams DID HAVE A LEGAL OBJECTION TO THE UNLAWFUL SENTENCE BUT WAS CUT OFF BY KOBAYASHI WHO ENDED THE VIDEO HEARING

Private Attorney General Anthony Williams, a servant of the Most High Yahweh Elohim Yahshua, submits this instant motion to obtain relief. In support to this motion the undersigned state the following facts.

1. The undersigned sent a Motion entitled "BLATANT LIES DARSIE ING-DODSON PLACED IN THE PRESENTENCE INVESTIGATION REPORT TO ASSASSINATE THE CHARACTER OF PRIVATE ATTORNEY GENERAL Anthony Williams on 10-14-20 but was held by the FDC mailroom for 8 days before mailing it out on 10-22-20 and received at 3:05 pm on 10-26-20 after the sentencing hearing was concluded.
2. The delay of this motion being mailed timely adversely affected the sentencing of the defendant because this motion was not before the court to consider as it should have been.
3. The undersigned sent out a MOTION FOR VARIANCE to his standby counsel Lars Isaacson by email on 10-13-20 and mailed a printout copy of this motion to Mr. Isaacson on 10-14-20 and was also held 8 days before mailing it out on 10-22-20 and electronically filed by Mr. Isaacson on 10-26-20 under Document No. 1110 the day of the sentencing hearing as was not before the court to consider before sentencing the defendant. Mr. Isaacson made a note of this late mailing by the FDC in paragraph 5 of his Declaration of Counsel.
4. The Motion For Variance had the legal reasons why no sentence should be imposed which was not before the court because of the FDC's intentional withholding of mailing the undersigned's legal mail when given to its staff. The law is very specific that when inmates hand their mail to prison staff, the mail is considered mailed on the date the inmate delivers the mail to staff for mailing.
5. The FDC's failure in mailing the undersigned's motions caused immeasurable harm in that the undersigned did not have his written legal reasons before the court to consider not giving the undersigned any time at all.
6. There is no justifiable reason for legal mail to be held for 8 days before mailing to the court which has denied the undersigned the opportunity to have his legal objections on the record.
7. This court adopted all of the Pre-Sentence Report Investigation recommendations without going through the report at the

hearing in order for the undersigned to show how the report was false and fabricated.

8. The undersigned was not given the opportunity to dispute the pertinent findings in the report that would have shown that no sentence should have been imposed because of the fabrications in the report and misapplications of the law.

CONCLUSION

Based upon the foregoing facts, the undersigned is entitled to have the sentence vacated and a new sentencing hearing scheduled with both of the above mentioned motions before the court in order to make a proper ruling or in the alternative, the unlawful sentence vacated and the undersigned be set free.

On December 10, 2020, Defendant Anthony T. Williams ("Williams"), acting *pro se*, filed a motion raising various challenges to the sentencing hearing and his sentence ("Motion"). [Dkt. no. 1140.] Williams signed the Motion on November 3, 2020. [Id. at PageID #: 13737.] He appears to have sent the motion to someone living in Hawai'i who mailed the motion to the Clerk's Office. See dkt. no. 1140-1 (copy of the envelope the Motion was sent in). After Williams wrote the Motion, Deanna Dotson, Esq., was appointed as his attorney, effective as of November 9, 2020. [Appointment form, filed 11/17/20 (dkt. no. 1131).]

The Judgment in a Criminal Case was entered on October 30, 2020, and Williams filed his Notice of Appeal the same day. [Dkt. nos. 1115, 1118.] Williams's Motion is DENIED because this Court no longer has jurisdiction to consider issues related to his sentence. See *Griggs v. Provident Consumer Discount Co.*, 459 U.S. 56, 58 (1982) (per curiam) ("The filing of a notice of appeal . . . confers jurisdiction on the court of appeals and divests the district court of its control over those aspects of the case involved in the appeal." (citations omitted)). This Court makes no findings or conclusions regarding the merits of the issues raised in the Motion.
