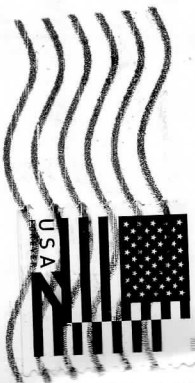

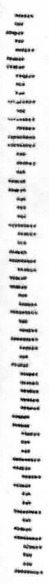

They have transferred me to another prison because of the grievances I wrote against several officers. I was given to bogus disciplinaries and placed in Solitary confinement again. Before I could appeal the bogus write ups, they got rid of me and sent me to Okeechobee Correctional Institution. I'm still in solitary confinement because your disciplinary follows you. I have written to the Secretary of the Dept. of Corrections to get these bogus disciplinaries expunged and be released from Solitary Confinement. The officers here won't give me any grievance forms and I guess the last facility told them how much of a headache I am with writing grievances because I know the law and I confront them with it which necessitates them having to do things that they particularly want to do. I told one of the officers who was overweight that he was in violation of Chapter 33, Section 208.002 paragraph (3)(a) which states all officers must be physically fit. He gave me the middle finger and said, "F---k you". LOL! I got a kick out of his response.

I'm enclosing a copy of one of my grievances that they never responded to. Please make a copy and send back to me as this is my only copy. I haven't received the Hebrew Dictionary or Concordance and it's probably due to them transferring me and will either be sent back or take a month to forward it to me.

My appeal attorney wrote me and told me that the government asked for an extension to June 28, 2021 to submit a response to my initial brief. I hope that the Court don't give them another extension because I know I'm going to win my appeal and I don't want any more delays.

Some attorneys came before I left and interviewed many of us in confinement because they are in the process of suing the D.O.C. for inhumane and cruel and unusual punishment to inmates in confinement. It's about time somebody does something to stop the nefarious ways of these sadistic children of the devil.

I'm doing wonderful despite the plots and schemes of the satanic forces. I read the Bible and lectures most of the day and write out the revelations that Yahshua reveals to me. This is the one thing that I do enjoy about solitary because I get to read and study in peace and Yahshua shows me many things that I know I wouldn't have been shown because of all of the distractions when you in population. If they would let me have my phone calls and email everyday, access to the law library and be able to keep my tablet and commissary food, I'd prefer to stay in solitary until I am released because as long as I got Yahshua with me I'm content and my understanding of his purpose, pattern and plan increases immensely in solitary, that's why I don't make a big fuss even though I didn't do anything to be here, there is a great benefit spiritually so. When you know the truth, you are free indeed, even behind prison walls. This is the peace and freedom Yahshua has given to those of us who know and believe in him.

Take care my brother and as always keep up the good fight!

Your Admin LT A.T. Dougherty blatantly lied on the disciplinary report by stating I said to him in his office about officer D. Smith "If you don't get her off my complex, I will take care of her." This was a blatant and outright lie. The grievance that I wrote against officer D. Smith did not contain any threats and so Dougherty concocted this lie that I threatened her in his office when he interviewed me, so he could write me a bogus disciplinary and put me in confinement. I am requesting a copy of the grievance that I wrote against officer D. Smith and also a copy of all of the other grievances that I wrote to you and haven't received a response. I'm appealing both bogus disciplinaries and need Form DC1-303. I need two copies. Under Chapter 33 103.001, Inmate Grievances - General Policy paragraph (3) states: Inmates can file complaints regarding the following matters: → [Turn on Back]

All requests will be handled in one of the following ways: 1) Written Information or 2) Personal Interview. All informal grievances will be responded to in writing.

Informal Grievances and Inmate Requests will be responded to within 15 days, following receipt by staff.
You may obtain further administrative review of your complaint by obtaining form DC1-303, Request for Administrative Remedy or Appeal, completing the form as required by Rule 33-103.006, F.A.C., attaching a copy of your informal grievance and response, and forwarding your complaint to the warden or assistant warden no later than 15 days after the grievance is responded to. If the 15th day falls on a weekend or holiday, the due date shall be the next regular work day.

- a) The substance, interpretation and application of rules and procedures of the department that affect them personally;
- b) The interpretation and application of state and federal laws and regulations that affect them personally;
- c) Reprisal against inmates for filing a complaint or appeal under the inmate grievance procedure, or for participating in an inmate grievance proceeding;
- d) Incidents occurring within the institution that affect them personally;
- e) Conditions of care or supervision within the authority of the Florida Dept. of Corrections, except as noted herein.

Specifically and in reference to subsection (c) above, your officers retaliated against me for filing complaints about the actions and behavior of your officers that is in violation of Chapter 33, 208.002 paragraph 8. Furthermore, they wrote me two bogus disciplinaries with the first one I outlined above and the second one they planted a phone in my absence and charged me with possession of a phone that I never had. I requested that the surveillance camera be reviewed because it would show that they didn't get a phone out of my locker, as was written up in the disciplinary reports. When the investigation officer looked at the cameras, the story changed to it was now discovered in the officers station. I do not appreciate being lied on by your officers and contraband being planted and false charges filed against me. Not only am I filing an appeal, I will have my legal team contact Tallahassee and contact the media to expose what your administration has done to me and attempting to do. I was informed by the hearing officer Ms. Reed that they have recommended me for a transfer. This is also a form of retaliation because of the grievances I have filed in the month I have been in this facility. Transferring me is not going to stop me from filing my grievances and my federal lawsuit against this facility and its officers. Furthermore, I am demanding to be transferred from this facility because you have a host of dishonest officers who are devoid of integrity. I do not wish to stay here to continue to be harassed by your officers continuing to write bogus disciplinaries against me. Let your officers know that they will be held accountable for writing up false disciplinaries and planting contraband to write me up a bogus disciplinary. If my appeal is denied, a federal lawsuit will be forthcoming. Guide yourselves accordingly, Anthony Williams
