I will go through this ridiculous post line by line to expose these lies to show that they are blatant and done with no regard for the truth.

### Career Highlights of Anthony Williams

First Place - There were no homeowners targeted because ALL homeowners sought my help after being scammed out of thousands of dollars by attorneys at law such as Paul Sulla. You can contact Dr. Leonard Horowitz, Sherrri Kano and Joyce Benoit to name a few who can testify to this. Not one client lost their home due to my assistance and only 3 out of over 400 clients were foreclosed on and that was only after my unlawful incarceration and I couldn't appear in court to defend their property or respond to the motions filed because I was not forwarded any motions from any clients with the exception of Rosy Thomas and Milagros Pastro who are still in their homes because of my assistance from jail. Both have submitted affidavits to this fact and written letters on my behalf stating how I have assisted them.

Second Place - I did not sue myself, I sued the legal person or legal fiction created by the U.S. Government fraudulently through a Social Security number and birth certificate. I was unable to prosecute the case because of my unlawful incarceration and the jail would not transport me to any civil hearings so the case was dismissed.

3rd Place - This false Aggravated Rape of A Child was dismissed after I submitted my Motion for Certificate

of Dismissal And Acquittal and provided exhibits which proved the DNA was not mine and approximately 50 alibi affidavits which proved I was in Hawaii the whole time. The extradition hearing for this bogus charge is on youtube under FBI Hawaii Conspiracy Part 1 and Part 2 where I exposed how the FBI tried to fake my fingerprints to make me the perpetrator and Mel Horner attempted to provide the court with documents to prove I was innocent of the charges and the court refused to allow them to be submitted on the record. Contained in the documents were my flight itinerary and affidavits from clients I had been with ~~doing~~ during the time the alleged I was in Georgia committing this crime. Robbin KraftKauer actually was the one who picked me up from the airport and submitted an affidavit to the fact that I was in Hawaii from April 1, 2013 - April 13, 2013 when they alleged I was in Georgia committing this crime. This case was dismissed on September 3, 2014 and unlawfully ordered sealed by the court over my objection because I wanted the public to see what they did to me and tried to do. I had the case against me and my son dismissed.

4th Place - There could not possibly be a charged filed against me for Felony Family Violence with Battery, Obstruction of Justice or Hiding From Law Enforcement Authorities because I was incarcerated in early 2005 and was in prison wrongfully for allegedly violating probation. I was released from Prison July 14, 2008 and immediately filed a civil suit against pseudo Judge Julian King and the State of Alabama for false imprisonment, kidnapping, deprivation of rights and because I was a pro se litigant they dismissed case stating the judge had immunity. This case was also ordered sealed to hide from the public what these devil worshippers did to me.

5<sup>th</sup> Place - Never charged, arrested or convicted in Florida for Criminal Battery upon and tampering with a witness/juictim. This is a blatant made up lie or is another man named Anthony Williams.

6<sup>th</sup> Place - I did not write to an Indiana woman ordering her to post photographs, names and addresses of Judges, prosecutors and law enforcement officers, this was a phone conversation asking her to expose these devils and never was there any talk of killing them or threatening them. However, after this phone conversation some devil name Stan Salas who claimed to be with the U.S. Marshals called and threatened my female friend that if she tried to help me expose these devils that they would come after her and show up at her door. She audio recorded the conversation and sent it to Rudy, who posted it on youtube and on the yearofjubile.com website.

7<sup>th</sup> Place - In June 2016 I did not threaten government officials with deadly force without justification. I specifically stated that anyone who tries to violate my constitutional, divine rights and common law rights would be met with deadly force as was my right to do. If this was a crime and against the law to protect my rights with deadly force if necessary I would have been arrested and charged for threatening a government official, yet there were no charges filed.

8<sup>th</sup> Place - The bogus Grand Theft and unlawful filing of documents charge was because I protected a client from foreclosure and pseudo detective John Calabro filed these bogus charges. At trial the State Attorney refused to call him to the witness stand because they knew I would prove he was a racist and how he previously filed over 30 other bogus charges against me which I got dismissed or dropped. I demanded that he be called as an adverse witness and pseudo judge Andrew Siegel

denied me the right to face my accuser as it is outlined in the 6th Amendment. No witness that the State called testified against me that I grand theft a house or unlawfully filed document. This was a civil foreclosure I was fighting bank of America on behalf of William Hatchett, the homeowner who had been living in the house for 8 years. I successfully stopped the Sheriff from evicting him on June 8, 2015 but after I was incarcerated on November 8, 2015, a year later while I was still incarcerated Bank of America foreclosed and evicted him out in September 2016. Three (3) months later I was charged with Grand Theft of the house which is absurd.

9th Place - In April 2001 I was never arrested, indicted, convicted or imprisoned in Georgia for Theft By Taking. This is a blatant lie. The only time I spent in jail in Georgia was 6 months for the false rape charge that I got dismissed on September 3, 2014.

10th Place - I was arrested in December 2011 for Criminal impersonation of a police officer. However, when I was able to fax Capt. Anderson a copy of my Sovereign Peace Officer Oath, the charge was dismissed. The State somehow reissued the charge in August 2012 but I was never arrested for it again and it shows that this case was dismissed and later put in the system as still pending which is a lie. I posted a copy of the dismissal on my [USACommonLaw.com](http://USACommonLaw.com) website which has since been taken down by the government.

11th Place - I was tried twice for the unlicensed practice of law. The first trial I won 5 to 1 and pseudo judge Andrew Siegel unlawfully declared a mistrial. I was retried 24 days later and was prohibited from submitting the same exhibits submitted in the first trial and forbidden to ask the same questions and threatened that if I attempted

to do so my pro se status would be revoked and I would be removed from the courtroom and my standby attorney would take over and finish the trial. I was convicted in 45 minutes by an all white jury of police officers, attorneys or relatives of cops and attorneys, I did not have a jury of my peers because I am not a peer of cops and attorneys at law. These are some of the most wicked, evil, dishonest and greedy people in the world.

12th Place - The driving on a suspended license charge never was disposition because the State of Tennessee refuses to give me a trial by jury because I will expose the whole driver license fraud. Instead they have kept this case and about 4 others pending for over 9 years. I have repeatedly sent motions to be taken to trial or the case resolved and dismissed. I have yet to receive an answer from the state of Tennessee nor the courts.

13th Place - Never had a criminal case in 2015 for Aggravated Battery and Tampering With A Witness. This is a blatant lie and must be someone else with the same name as mine.

14th Place - The prosecutor was not being sympathetic towards me but was being sarcastic by filing a motion for psychiatric examination and done to delay the trial which was suppose to commence in 2 weeks so this motion was done to delay the trial to give the government more time to concoct more lies to utter at trial. I filed a motion to have the prosecutor undergo a mental examination which was denied by Kobayashi, even though I presented valid arguments and proof that the pettifogger prosecutors are mentally retarded and deranged.

15th place - I showed by divine Numerology that the pseudo judge Kobayashi and the pettifogger prosecutors

### The Legal History of Anthony Troy Williams

1. State of Alabama v. Anthony Troy Williams - The reason that no information is available because this bogus case was dismissed and like all the other cases I have won this corrupt system either hides them, seals them or outright get rid of the case as if it didn't exist.
2. State of Georgia v. Anthony Troy Williams - This is a blatant lie because I have never been to prison in Georgia and this is someone else with the same name as mine.
3. State of North Carolina v. Anthony Troy Williams - This is a blatant lie because I have never driven to North Carolina and never have been issued any citation in the state of North Carolina.
4. State of North Carolina v. Anthony Troy Williams - This is another blatant lie and must be another person with the same name as mine.

5. State of Georgia v. Anthony Troy Williams - This is another blatant lie because from October 2005 until July 2008 I was in prison in Alabama because the State of Alabama lost my records of my completed probation for a bounce check charge that I had already paid and took them over 2 years to find the records that I did in fact pay and I was released from prison. IF this is a real charge then its someone else with the same name as mine.
6. State of Tennessee v. Anthony Troy Williams - This is a case I was unlawfully convicted of driving while license suspended when I never even had a Tennessee drivers license to be suspended. I was still learning the right to travel laws and didn't know how to properly fight the charge yet.
7. State of Tennessee v. Anthony Troy Williams - This is my case and occurred also in 2010 while I was still learning the right to travel laws.
10. 21, 24-28. State of Tennessee v. Anthony Troy Williams - These are all driving on a suspended license cases that were duplicated. Look at the case numbers and you can see they were duplicated to make my record appear longer than it really is. IF you notice most of them says "No outcome or disposition date reported." The reason for that is I either won the case and they got rid of it or they kept it pending when I demanded a trial by jury. By law if a case is not resolved within 5 years it must be dismissed. However, Tennessee doesn't want to put on the record more cases that I won or had dismissed because then the people will see the truth in black and white.
- 22-23. State of Tennessee v. Anthony Troy Williams - This case was dismissed as it is outlined in their bogus report

but the Tennessee created the same charge again under a new case number but I was never arrested or charged with it again. I wrote the court to either give me a trial by jury or dismiss this case as the first one was dismissed but I haven't heard from the state or the court since 2016.

- 29,31. State of Tennessee v. Anthony Troy Williams - These two are the same arrest warrant for a false capias issued by pseudo Judge Holt even though I was standing before him in court. He didn't like that I would not be a surety for the legal fiction and told him that I was the executor and beneficiary of the estate of ANTHONY WILLIAMS. He issued a warrant for my arrest for failure to appear even though I was in court. I was taken to jail 3 days later and I told the deputy to tell the judge he might want to check out youtube where he has been recorded breaking the law by issuing a false capias when I was in court. I was released within 3 hours and no charges filed against me. This video is uploaded on youtube. I can't remember the name I called the video but should be easy to locate.
32. State of Georgia v. Anthony Troy Williams - I was falsely arrested for Aggravated Child Molestation and proved my innocence and the case was dismissed and the police file and court file was ordered sealed because they didn't want the public to see how they tried to frame me and my son and how I exposed all their lies through DNA, medical records and alibi affidavits.
33. I was arrested by Broward County Sheriff's office not Brevard but all of these charges for invalid license plate and driving without a valid license was dismissed when I filed my Memorandum on the Right to Travel.
34. This is the same case as #33 above and these charges were dismissed.

35. This unknown case is not mine.

36. Anthony Troy Williams v. State of Florida - This is not my case. I have never been charged with Aggravated Battery and Tampering with a Witness or Victim. This is a person with the same name as mine. However, this person won their appeal but this Snoop 4 Lies idiot still dont want to give the person credit for winning his own appeal.

37. State of Florida v. Anthony Troy Williams - This is my case and I was charged unlawfully with Resisting Arrest and Obstructing An Officer without violence but I got the case dismissed because I didn't commit no crime. Snoop 4 Lies conveniently left out the dismissal part and simply puts "no further details from source." Of course they don't want you to have any details of how I beat another bogus charge.

38. I was not arrested for fraud and Impersonation or Misrepresenting Myself as Qualified to practice law. I was arrested for the unauthorized or unlicensed practice of law.

39. State of Florida v. Anthony Troy Williams - This is the case I was charged with Unlicensed practice of law and Fraud In Simulating Legal Process. I got the fraud in simulating Legal Process dismissed but was unlawfully convicted of unlicensed practice of law even though at trial I made the Florida Bar manager, Jacquey Plasner Needelman admit under oath that no attorney have a license to practice law and that the Florida bar is a private corporation and not a part of the Florida State Government.

40. State of Florida v. Anthony Troy Williams - This is my case where after being unlawfully convicted of unlicensed practice of law, I was forced to register as a felon or be placed back in jail.

43. United States v. Anthony Williams and Anabel Cabebe - This is my Hawaii case that I was charged with mail and wire fraud alleging I lied or misrepresented my services to clients through the email and mail.
- 41-42. State of Florida v. Anthony Troy Williams - This is my case where I was unlawfully convicted of Grand Theft of A House but this case is still pending in court and I'm waiting on a ruling on my Rule 3.850 motion for Post Conviction relief because I didn't Grand Theft a House and no crime was ever committed. This was a foreclosure proceeding they converted to a Criminal Case.
44. United States v. Anthony Williams - This is the same case as #43 above.
- Civil Cases
45. Anthony Troy Williams v. King - This is not my case. I have never had any Civil cases in Texas. In 1996 I was living in Anniston, Alabama.
46. Unknown v. Anthony Troy Williams - This is not my case. However, whoever it was got the case dismissed.
47. Miller, et al (includes Anthony Troy Williams) v. Head - This is not my case. Don't know who Miller or Head is.
48. James v. Boone, et al (includes Anthony Troy Williams) - This is not my case. I don't know either of the parties and I was living in Alabama at the time and not Georgia.
49. Bavaria Apartments v. Anthony Troy Williams - This is not my case. I never lived in a Bavaria Apartments in Georgia.

50. Regent of the University of California v. Anthony Troy Williams - This is not my case. I was not in California in 2003. I didn't open an office in California until 2014.

51-52. Anthony Troy Williams v. Focus Receivables Management - This is my case where I sued a former employer for not paying me the commissions owed to me. The case was settled and I got my commissions.

53. Anthony T. Williams v. State of Florida - This is not my case. I was not in Florida in 2009. I didn't come to Florida until the end of 2014.

54-56. Bavaria Apartments v. Anthony Troy Williams - This is my case. I had lost my job and was 2 months late on my rent but got another job and caught up my rent. Snoop4Lies conveniently list "outcome not reported" when he knows the case was resolved.

57. Anthony Troy Williams v. Daron Hall - This is my case. I filed a suit against the warden for false imprisonment via a Habeas Corpus and was released from jail afterwards. The case was dismissed because I was released from jail.

58-59. Anthony Troy Williams and Robyn Kelley v. State of Tennessee - This is my case I also filed while incarcerated in the County jail. The jail would not provide me with my inmate account printout to show my indigency and that's why this case was dismissed.

60. Anthony Troy Williams v. Darren Hall, same as #57 but this idiot spelled the warden's first name wrong.

61. Anthony Troy Williams v. State of Tennessee - This is the same case as #58-59.

62. Henry Malinay v. Rhonda Nishimura - This was a suit I filed on behalf of Henry (before I knew he was a liar and scammer) and pseudo judge Nishimura refused to recognize my right to assist them in filing a lawsuit. This is baffling because this same pseudo judge allowed me to appear and give oral arguments in their foreclosure case. So much for consistency of the law.
63. Anthony Troy Williams v. State of Florida - This is not my case. This is someone with the same name as me.
64. Anthony Troy Williams v. Fulton County Jail - This is my case. I sued for my unlawful incarceration. The case was dismissed on 9-10-2014 because I was released a week earlier on 9-3-2014 so there was no reason to continue the suit. This was not a loss but a win because I gained my freedom.
- 65, 68. Anthony Williams v. Edna Franco - This is a suit I filed against my former employees for defrauding me and scamming consumers. I was not able to properly serve them because I didn't have their new correct addresses to serve them the lawsuit.
66. Anthony Williams v. Duval County - This is my case I filed against the Clerk for refusing to file our affidavits on the record which is actually a crime for a clerk to refuse to file a sworn document. I also sued Duval for the submission of their County financial records, budget, etc. They finally sent me all the files including how many employees they had, their salaries, their annual budget and all. This was not a loss and I got the info I sued for.
- 67, 69-70, 72. Donna Hickenbottom and Anthony Williams v. Citimortgage, Judge Cynthia Imperato, Judge Barry Stone, Judge Lynn Rosenthal - These were cases I filed on behalf of Ms. Hickenbottom outlining the fraud perpetrated against her by the Bank and the Judges, in which I had to remove 2 of the judges, Imperato and

Rosenthal because they both had previously been intoxicated presiding on the bench. Imperato's recusal was video recorded by me and uploaded to youtube. Rosenthal came to work so drunk one morning that she ran into the Sheriff's deputy car upon entering the courthouse building and was arrested. It made the local news but she was given a skip on the risk instead of jail time like any other citizen would have gotten.

73. Canidad Marquez, P.A. v. Anthony Williams v. Judge Beatrice Butchko - I sued this judge on behalf of my client for not allowing me to assist her at her hearing and for disregarding all the evidence of fraud we presented in our motion including a hand writing expert who testified that my client's signature was forged. We got 4 different hand writing experts and all 4 concluded the same that her signature was forged.

75. Anthony Troy Williams v. ANTHONY TROY WILLIAMS - This is the case I filed against the legal fiction. The suit was not dismissed for lack of service but because the court stated it didn't have federal jurisdiction because both addresses were in Florida. I have re-filed this case and it is currently pending.

74. Anthony Troy Williams v. Fernandez - This is my case that I sued several guards for wrongfully placing me in solitary confinement with bogus disciplinaries. After I filed the suit I was released from confinement. I got the relief I was seeking.

76. Anthony Troy Williams v. Scott Israel - I sued the Sheriff over the prison conditions. After I filed the suit the jail started ameliorating the conditions. I saw no need to continue the suit and it was dismissed. Not a loss but a win for changing the conditions of the prison

77. Lenore Albert v. Anthony Troy Williams - This is the suit an attorney at law filed against me because she said I ruined her life by getting her license suspended, car repossessed, evicted from her home and embarrassing her on my web page. Contrary to the lies of Snoop 4 Lies, I filed to get the case dismissed and the judge granted it. She then filed an appeal to the Ninth Circuit and they told her to voluntary dismiss it or they would sanction her and so the appeal was also dismissed against me but Snoop 4 Lies says the court dismissed it unrelated to me and that I never filed a dismissal. Anyone can look up the docket and download the motion that I filed to get the case dismissed.

78. Anthony Troy Williams v. Hiromichi Kobayashi - This is a suit I filed against the Warden in Honolulu for the conditions and depriving me of access to the law library. I got a court order from Judge Richard L. Puglisi ordering the FDC to give me an e-discovery computer in the empty room in the Unit and access to the computers 2 days a week a minimum of 2 hours per day. You can download the order from my case docket.

### Bankruptcy Related Cases

79. Anthony Troy Williams and Kelly S. Williams - This is not my case as I have never lived or been to the state of Michigan.

80. State of Hawaii v. Anabel Cabebe - This has nothing to do with me. This was Anabel's bankruptcy and they erroneously mentioned my name as being in complicit with Anabel and her copy cat company Mortgage Enterprise, that she Edna Franco and Henry Malinay and Anabel set up behind my back. After I found out what they did I reported them to the FBI who did nothing. I recorded and uploaded the video to youtube where I went to the FBI office and made the complaint.

81. State of Hawaii v. Henry Malinay - This bankruptcy case has nothing to do with me. They tried to include my name with the fraudulent copy cat company Malinay, Franco and Cabebe set up behind my back. My services were fully guaranteed and all customers signed a Foreclosure Disclosure Form which specifically stated if they were facing foreclosure and already was in court, then I couldn't guarantee getting their home free and clear because of the corruption of the courts. The initial set up fee was to cover the cost of filing all the paperwork and for me to appear in court. The fee for fighting the foreclosure was half of what their mortgage payment was and if they couldn't afford that they could fill out a hardship affidavit form and submit proof that they couldn't afford it and their payment would be adjusted even if it had to be adjusted to \$0 in which many of the clients didn't have the money to pay but I did the work anyway at my own expense and have many client to testify to this and Rosy and Elelva both testified to at my sentencing hearing. Attorneys at law get outrageous exorbitant fees upfront without doing any work and are never charged with scamming people. I work for free for many clients and that is considered scamming people? Ridiculous!

82. Trial Court Criminal Case - This has nothing to do with me and these idiots didn't even have a case number or name for this so-called case but according to Snoop4L's its a case against me that I loss.

83. Trial Court Civil Case - This has nothing to do with me and again these idiots don't have a case number or name for this so-called civil case

84. Trial Court Civil Case - I did sue the Tennessee Dept. of Revenue for fraud and misrepresentation. This has

nothing to do with no child support and Linda Kelley is not one of my children's mother but was the Director of the Dept of Revenue that I sued. This Snoop 4 Lies is an uneducated idiot to print these retarded unfounded allegations with no truth to them.

85. Trial Court Civil Case - This has nothing to do with the case in # 58 because that case was about my conditions of incarceration in the County jail, and had nothing to do with foreclosure or property.
86. Trial Court Civil Case - This has nothing to do with me if it is an appeal from #63 above because that case is not mine.
87. Hot Check Case - I did not admit to no criminal conviction because I never had a 2015 mental competency hearing. The bogus examination they forced me to take was in 2011 by Dr. Michael Brannon.
88. Failure to Appear Case - This is not my case and again I never had a competency hearing in 2015.
89. Unknown Criminal Case - The 9 months jail time was for the bogus rape case that my son and I was falsely charged with and I got both cases dismissed after proving our innocence and showing how the FBI tried to frame me by taking my fingerprints.

### Hickenbottom Cases

90. Hickenbottom v. BAC Home Loan - This is a client who I assisted for free after her attorney took most of her money and did nothing to help her fight her foreclosure. This case was filed before she met me.

91. Donna Hickenbottom v. Choice Legal Group - This case was filed by this client before she met me but after I got involved I stopped the foreclosure and eviction. She lost the property after my incarceration.

92. Hickenbottom v. Nationstar Mortgage - This case I stopped her eviction and auction multiple times. After I was incarcerated they evicted her.

93. Donna Mae Hickenbottom v. CitiMortgage - I stopped this foreclosure and eviction multiple times also. After I was incarcerated she lost the property.

94. Donna Hickenbottom v. FNMA - I fought this foreclosure and stopped the auction and eviction multiple times. After I was incarcerated she lost the property. \*Note\* She ended getting another attorney after my incarceration and he was not able to stop the foreclosure and she lost the property.

2. If my Private Attorney General ID is fake and a crime, why has all of the law enforcement agencies such as the FBI, US Marshals, Sheriff's office and other agencies accept my ID including the TSA allowing me to fly all over the country with my own Sovereign ID and badge?
3. If I scammed all of these clients why haven't one client ever filed a complaint or a sworn affidavit against me?
4. Why did Snoop 4 Lies include other peoples criminal and civil cases as if they were mine to make it appear I lost 90 consecutive cases when that is a blatant lie?
5. If I committed mortgage fraud, why was I never charged with mortgage fraud?
6. Why couldn't the government find anything in any of my bank accounts to charge me with bank fraud or money laundering?

1. Why are you hiding behind an internet name of Snoop 4 Truth instead of showing people who you really are?
2. How can you know so many details about Anthony Williams cases that only the FBI or US Attorneys office would know or have access to?
3. Of the Sovereigns you have targeted and slandered like Anthony Williams, Rod Glass, Carl Miller, Debra Jones, Eddie Craig, Deborah Tavares and others, which ones have sworn complaints filed against them by clients?
4. Why do you slander and blatant lie and call Anthony Williams a violent criminal when he has no violent charges he has ever been convicted of?
5. If you are Snoop 4 Truth then tell the truth about what your real name is and where you are located like Anthony Williams has always done and made videos to prove what he was saying is correct and never hid his identity even though he was threatened to be murdered by the FBI if he didn't stop posting his youtube videos?

### Fact check

Of the so-called 90 consecutive cases Snoop 4 Lies says I lost, here are the facts.

Twenty-Two (22) of the cases listed are not my cases but someone with the same name.

The Five (5) Hockenbottom cases were already in foreclosure before I got involved and I fought the foreclosures and defended the properties and they were not lost until I was incarcerated and no longer able to defend the property.

Twenty-Three (23) of the cases were driving on a suspended license and were duplicated multiple times in this

false report. I eventually won the driving on a suspended license and got the case dismissed. When they charged me again they refused to take me to trial again because I knew how to win now and so they have kept those cases as pending for over 9 years now.

The other forty (40) cases are civil actions which have nothing to do with any criminal actions on my part but most were suits I filed on behalf of the people or clients for the corruption in the government, courts, and law enforcement agencies who refused to follow the law.

Most of the clients I defended in foreclosure are still in their homes due to the work I did in protecting them. Those that were evicted were tricked into being evicted.

The only cases I have been unlawfully convicted of are:

1. Unlicensed Practice of Law - 6 months jail time
2. Grand Theft of A House and Unlawful Filing of documents - 15 years
3. Mail and Wire Fraud - 20 years

My appeal was sabotaged on my Unlicensed Practice of Law and Grand Theft and the 4th DCA to this day has not issued an opinion as to how my conviction was lawful and where I was wrong in my conduct.
