DEEP STATE COUP D'ETAT # 16; GENOCIDE BY ANY MEANS:

A. GENESIS OF COVID-19 GENOCIDE BY DR. FAUCI:

*** In OCTOBER 2014: Elected President Barack OBAMA prohibited Gain of Function (GOF) research on viruses because such manmade virus may cause disasters or be used for warfare. Unelected Director Anthony FAUCI of the U.S. National Institute of Health (NIH) vetoed OBAMA by funding 3 grants to the Wuhan VIRAL INSTITUTE (WVI) of China for the prohibited GOF virus research. At WVI, 2 different types of BAT VIRUSES were COMBINED WITH a HUMAN COVID VIRUS to create COVID-19. In FEBRUARY 2021, Investigation of WVI files proved COVID-19 has exact genomes of 2 different bat viruses collected from caves 5-miles from WVI and a human virus WVI had in stock. To wit, Dr. Anthony FAUCI has been committing GENOCIDE with his unlawful experiment that caused the COVID-19 Pandemic (NUREMBURG CODE (1945)).

*** Regarding aforesaid, in 2017, Xi Sheng Li did GOF research at WVI funded by the NIH. In FEBRUARY 2020, British MI6 DISCOVERED:

- (a) the WUHAN VIRAL INSTITUTE had RECOVERED BAT VIRUSES from 2 miners who got ill in bat caves; and
- (b) the first persons to get ill from the manmade COVID-19 WERE WUHAN SCIENTISTS who passed it to the general public. On 10 FEBRUARY 2021, China refused to answer WHO questions on this.

B. GENOCIDAL MODUS OPERANDI OF DC DEMONRATS:

*** Huey LONG, a moderate and financially conservative Democrat said: "If the U.S. ever ends up with a fascist government, it will be under the guise of anti-fascism". This can also be applied to MISOGYNY, RACISM, SEXISM and LEGISLATION.

*** For 4-decades, SLEEPY JOE BIDEN created RACIAL division and GENOCIDE under guise of LEGISLATION:

- (a) In 1994, BIDEN pushed the Clinton CRIME BILL, that INCREASED MINORITY IMPRISONMENT by about 90,000, WHICH President TRUMP CANCELLED in 2018 with the First Step Act to release prisoners;
- (b) In 1996, BIDEN voted for the draconian PRISON LITIGATION REFORM ACT (PLRA) THAT ELIMINATED HABEAS CORPUS for the wrongfully imprisoned; and
- (c) the PLRA allowed ACTIVIST DEMONRAT JUDGES to END PRISONER right of COURT ACCESS needed to protect from CIVIL RIGHTS ABUSES. Such DEMONRAT

WRONGS have CAUSED DEATHS OF MANY prisoners for which there is NO RECOURSE OTHER THAN the LAWFUL RIGHT OF SELF-DEFENSE. JOHN BAD ELK v U.S., 177 US 529, 535 (1900) (@ "SELF-DEFENSE"). During 8-years of the OBAMA ADMINISTRATION, DEMONRATS did not help minorities but did anything possible to ENSLAVE people UNDER 13TH AMENDMENT GENOCIDE.

*** In 2017, at Charlottesville, President TRUMP said: "Not all of those people were NAZIS. Not all of those people were White Supremacists. Both sides [protesting about the statutes] had some very fine people, but not the KKK, White Supremacists nor NAZIS. In 2020, Joe BIDEN redacted said exclusions by saying TRUMP said only, "Both sides [protesting] had some very fine people", to falsely accuse TRUMP of White Supremacy.

*** On 16 JUNE 2020, Representative James CLYBURN rancorously called President Trump's EXECUTIVE ORDER upgrading police department standards inadequate. CLYBURN INCRIMINATED himself and DEMOCRATS because, since the 1970s, DEMONRATS have never done as much as President Trump in his one day signing of EXECUTIVE ORDER thereon. In Trump's first year in office, he did more for minorities than DEMONRATS did in DECADES. *** ILLEGAL IMMIGRATION CAUSES 7.2% OF BLACK UNEMPLOYMENT (U.S. DOJ, 2015). Such IMMIGRATION is how DEMONRATS keep Black families poor and ENSLAVED on the DEMONRAT WELFARE PLANTATION. DEMONRATS blame Housing Discrimination on alleged White Supremacists (DEMONRAT name for NON-DEMONRATS & Black Republicans). However, on 26 JANUARY 2021, DR.
