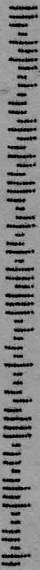

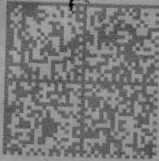

Greetings Rudy & Erin,  
And Yahweh's blessings to you,

Thanks for Jpays; I got 5 pages today dated 1-31. Very important info re the CA vax-wars, and satanic tyrant Senator Pan. Can you get his address for me? I've been banned from the law library, starting the very day I got access which took 4 years to get. By the time my CTQ (Confined to Quarters) 24/7 ends, my library access will have expired.

Normally, by policy, I don't do covid tests, for several reasons. But since I was locked up for it anyway, based on no reason, I took their simple test, putting a sealed, sanitary Q-tip near the end of my nose. They say it showed a positive result, so they've begun a terror campaign on me again, the first in a few years. Because they had told<sup>me</sup> there would be NO POSSIBLE adverse consequences if the test was positive, but let off the CTQ immediately if it came negative. Big mistake by me to trust their word. They lied. Nothing new. Now they told me I must move to a different prison within the prison, for a couple weeks, or get a serious RVR which guarantees no parole for years. But since they invent ways to perpetually deny me parole anyway, and because they lied to me about not having to move or be disturbed in any way to get me to take the test, I'm not moving. I can't get water there, because my means to let it air out the chlorine wouldn't be available (plastic bottles). For that and other, equally compelling reasons, I elected to stay where I am. And major change of that sort, almost always brings new horror consequences that would result in RVRs anyway, and potential bad cellmate, violence, etc., so I felt I had to elect to stay in this cell I've been in for years now. Tho they say they wouldn't touch my things, while gone for weeks, I can picture coming back to a cleaned out cell, many priceless things gone, "disappeared," and other catastrophes. So I had good reasons to stay, even at the price of another RVR. If I can avoid being executed in the next handful of months or less, I'd have to win court lawsuits to get relief against BPH anyway; so a new RVR or string of them (which usually follow), can maybe be remedied in those lawsuits. I just don't know if I have the mental steel to push thru LEGAL ABUSE SYNDROME to take a lawsuit to conclusion.

As a result of the new "positive" result, they are probably starting my lockup count all over again; another lie. That's what one guard now says. But if able, shoot for a visit on Feb 13, just in case they stick to the original promise of me being let off this 24/7 CTQ on Feb 7 or 8.

I do feel some significant throat/lung problems from covid, and the primary goal of CDCR re covid is to PREVENT US FROM ACCESS ~~TO~~ CURES (and prevention, which I'm already past), <sup>so</sup> they could kill me at this stage instead of waiting for a forced vax. But I'm feeling a bit better in other respects, besides the lungs/throat.

The info you sent is VERY IMPORTANT; and alarming. Necessary for me to know. There are a number of good people in the article, about 6 Or 8 names, I think. I hope I can get someone else to get to some of the websites /names and get contact info for me. I want to get <sup>contact</sup> info to all such protesters/activists. They might be the ones who keep me from execution, because my situation is unique

within the bigger umbrella of their/our cause, so I think they may be very interested in being in contact with me. Try to get the word out about me to all those sources you can. I know your limited time must be applied to other things too, so I don't want to lay on you much in the way of requests for these needs. If you read all that text you sent me, you'll see the destroyers age going after EXEMPTIONS to vax-rape, to rescind them all, as THEIR CORE GOAL now.

I feel I may be rambling. Which means there are other things I'm forgetting...

No response from Mira. When you next communicate, please ask if she got my ltr. It's been a few weeks now, I think.

Let me know if that beautiful songwriter Erin played me the songs from, would want to hear from me, and if so send me an address. And what is her facebook address? I assume that's not private.

Do you see any kind of an address, even an indirect one, for Clint Eastwood? Also Sylvester Stallone?

It's late; my energy is waning. So, all for now.
