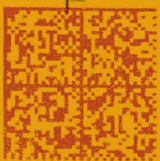

I habitually & by personal policy don't ask this of friends & family, ~~but~~ unless they've invited first, but going online w/ it is something I feel more comfortable doing.

I've drafted the ~~form~~ ltr form ltr explaining the BAH denial crime & what supporters should do now. I must type & copy it. Copies now are hard to get, but I'll manage. It's probably going to be 3 pages. I did get this copy of my ltr to MIRA, but it takes some real doing & being in the right place at the right time - & answered prayer.

RE: REFERRED TO YOU BY RUDY DAVIS

I hope this finds you well. Rudy Davis speaks most highly of you, of your concern for tormented political prisoners, especially in the US, and has urged me for a few months to reach out to you. He has told me you, yourself, were mangled up for a while in the belly of this vicious beast. Thank you so much for reaching back to help others.

Rudy is scheduled to visit me in about 15 minutes or less (1 hour on a video screen), and since I must make EVERY SECOND of life count, I'm squeezing in this letter, at least a start on it, before I get called from my outhouse crypt to get our virtual visit.

There's a lot that I don't know about you personally, and about your history with our injustice system; so I would love to hear anything you'd like to share. In CA (California) prisons, we don't have access to the internet, outbound emails, etc., although for a few years now we've been promised "any day now" that we will be issued "tablets" where we'll have limited emailing and limited/controlled information access such as for legal matters, music, etc. But under very onerous restrictions by the control freaks. If it's more convenient for you, YOU CAN SEND ME emails, via "Jpay.com" for much less than the cost of a postage stamp. Go to that site for info, and/or Rudy can explain more, as that's the way he always writes me now.

You are probably way to overwhelmed with too much mail to have much time to devote to my cause, but just a little tip of the iceberg about me/my case: Four days ago I was again denied parole by one of the most vicious, evil people I've ever encountered in my life, EVEN THOUGH THE LAW MANDATED THAT I "MUST" BE RELEASED ON MAY 1, 1992! -yes, 30 years ago. (And every day since). My sentence was fully served on that date; an 8 1/2 year sentence. This is absolutely kidnapping, human trafficking and false imprisonment by some of the most heinous criminals on the face of the earth, comprising the Calif. parole board (BPH). It has been operated as an ACTUAL kidnapping ring since about 1979, holding thousands of prisoners decades after our court-issued sentences were fully served. If you want proof, ask, and I'll send it. They've stolen my whole life, 39 years.

But here's the even worse punch line: they may execute me by lethal injection in the next few months or less, because I am FATALLY "allergic" (chemically-hypersensitive-adverse reactive) to vaccines and to most drugs/chemicals commonly used and ingested by millions daily with no problems. There is presently a court order to force-vaccinate us Calif. prisoners (momentarily under a brief "stay") and I know it will be carried out eventually; probably soon. All exemptions will be rescinded. They used to violently drag me in shackles & cuffs on my bare chest almost 1/4 mile to the clinic to have the medical-tech. jam the tuberculosis needle in me during the 1990s/2000s. They'll do it again; I'll die there, or the suffering of the horrors it does to my body that go WAY beyond my coping threshold will force me to take my own life. That's the hardest part, because I have such a strong survival drive in me, that it will be very hard to end my life, but the horrors it will do to me will almost certainly force me to do so if the potion doesn't do it for me.

On Jan 10, 1983, a maniacal madman (nephew of the man I bought my house from) snuck into my home, got to my back bedroom which has an automatically locking doorknob, and in a horrifically violent rage crashed the door down with about 12-15 feet & body blows, and swung a meat cleaver through the door almost chopping my head in half. I shot him with a legal, registered gun, from inside my bedroom, wounding him, then called police and ambulance to save him — still on his feet, disoriented, when they got there. They helped kill him hours later.

There is no other criminal trial case like mine in California history, and probably in US history. It took 18 years to gather and present the UNREFUTABLE EVIDENCE, 100% PROOF, THAT CANNOT BE REBUTTED, that the prosecution team, AND MY OWN PAID ATTORNEY SECRETLY WORKING WITH THE D.A. TO FABRICATE A MURDER AND SEND ME TO PRISON, planted, manufactured/fabricated, materially altered, destroyed (what was exonerating), forged, etc. EVERY SINGLE PIECE OF EVIDENCE used to convict me — almost 30 items. The corrupt Calif. courts/judges, and those in the federal courts over Calif. are even more corrupt than that prosecution team, and have me SPECIALY TARGETED to assure I don't get any relief, not even to have my issues ruled on, on the merits. Never yet, and I've never stopped trying for 39 years. There are thousands more things to be shared, but I need to shorten this as it is.

I've been in prison 39 years for that. I've never been involved in crime in my life; not even a j-walking ticket. In prison, they've actually tortured me every day for fourteen thousand twenty-eight days (=over 39 years); though I don't seek sympathy nor pity for that — that's not my style. Every day, I'm dying, not only from that stolen day, but I'm forced to drink water (the only thing I ever get to drink) from plastic that I'm super-reactive to, I'm awakened EVERY night of my life many times with a desert-dry throat, gasping for air. I'm similarly allergic-reactive to most "food" items served, and am attacked with screaming-level body pains regularly (almost daily, many times a day and night); it's the regular part of daily events for me. ALL OF WHICH would vanish if only I could get natural food, nutrition, and non-toxic water. But imprisonment prevents that, and the SOLE purpose for the medical system in here is to OBSTRUCT access to health remedies, to damage our health and lives, and to supply drugs, which I can't tolerate, and wouldn't take if I could. (Except when screaming in pain sustained for days on end). Were I not in prison,

even at my age, my body would be like a top athlete about half my biological age. That's just the way my body works. And I'd NEVER get sick, unlike now, as long as I avoid unnatural chemicals/drugs, including the thousands of unnatural chemicals in all packaged foods we get.

Please tell me more about you, Mira. I only know you suffered unjustly in American prison(s), and that you are from Russia. Do you speak a Russian language? As your first language? Is there only one main dialect? The lying US media says Putin is a terrible man. Other media I trust say he is not. Please tell me your view, from your "front row" seat, so to speak. I'm open-minded, and stand with the truth wherever it leads, NO MATTER WHAT.


Apologies this is so long. Hope I haven't rambled. It would actually take another 500 pages to tell even just the main things. I was expecting my ticket to freedom four days ago and one of my first goals was to connect with Clint Eastwood (I have ways), to try to persuade him to do the first movie (of several I expect) of this stunning case and my otherwise interesting life. Not merely to expose my story or the problem, but as a tool, the catalyst, to bring attention to the hidden horror system of OFFICIALS' criminality which IS the US prison system (political prisoner system). I believe this could make a huge dent in this monstrosity that needs to be replaced.

I hope you've read all of this, though I imagine your time is spread thin and must be at a premium. BTW, you have my permission to publish anything and everything in this letter, including the entirety, if it could be helpful to our cause.

Blessings to you, dear soul, and thank you for your care and efforts for so many others.
