MDOC is vaguely updating us on number and location of COVID-19 infected prisoners in belated emails. MDOC'S 01 APRIL 2020 email said 122 prisoners were infected but the news said more than 160 prisoners were infected. The number of infections nearly doubles every 2 days, especially in the pole barn dormitories.

We have no infections at JCF. I discussed proper sanitation with the Warden a month ago and he agreed. We are also wearing masks.

An unused housing unit attached to but outside of JCF was recommissioned for COVID-19 prisoners from other prisons. Its 90 rooms filled up within 5 days. Now, MDOC must find an empty housing unit somewhere else. Based on available statistics, it appears that 15 to 30 at JCF will die if COVID-19 ever gets in here. MI is dueling with CA for 3rd place in the COVID-19 race for most infections.
