DEEP STATE COUP D'ETAT #9:

A. MORE OF THE SAME OLD COMMUNIST TYRANNY:

In late 2016, Representative Nancy PELOSI and Senator Chuck SCHUMER had dinner with RUSSIAN Ambassador KYSLIAK. Then, on 23 DECEMBER 2016, KYSLIAK made a telephone call to incoming Nat'l Security Advisor General Mike FLYNN who spoke to 30 other Ambassadors; a standard procedure to get incoming White House Administrations started on foreign affairs.

At a 05 JANUARY 2017 White House Conference: Vice President JOE BIDEN, CIA Director John BRENNAN, NSA Director James CLAPPER, UN Ambassador Samantha Powers, Security Advisor Susan RICE, Deputy Attorney General Sally YATES and 34 others discussed outgoing President Barack H. On 09 MAY 2020, the remainder of 53 transcripts of the 2018 through 2019 House Intelligence Committee hearings, lead by ADAM SCHIFF, were released to the public. NSA Director JAMES CLAPPER testified, "I never saw any empirical evidence that the Trump Campaign, or anyone in it, colluded/conspired with Russians". CIA Director JOHN BRENNAN, SUSAN RICE, Sally YATES and every witness called by ADAM SCHIFF testified to the same. However, in 2017 through MAY 2020 when they spoke on Public Media, they all FALSELY said the Trump Campaign was colluding with Russians.
