Dear Rudy:

The enclosed Coroner's Report is about a friend who was helping me. 6-months before he was killed, 2 FBI Agents "visited" him near the place where his "ACCIDENT" occurred and asked him, "Why are you writing Northington?" These feds also asked him why he was writing a common friend who I write every 6 to 12 months who had asked the Parole Board to release me in 2004. (Some had attempted to cause an "accident" to the common friend in 2002 and the same type "accident" simultaneously to my brother in a location 100 miles away from the friend's "accident".) John Woelfel's help was offering me a place to stay upon release. John was the 3rd friend helping me to be killed in the last 36 years.

My first friend who was killed while helping me had been visited by a fed or police before he had an "accident" caused by "mechanical failure" of his transportation vehicle. "Mechanical failure" deliberately done by someone was the modus operandi in the 2002 events of attempting to cause an "accident" to the common friend and my brother. My 2nd friend who was killed while helping me was assassinated. See enclosed Jackson Citizen Patriot news article. My first late friend would have been a witness to prove my innocence at trial. My 2nd late friend would have helped me get released and with a place to stay and job.

There is a 4th friend helping me who was "T-boned" by someone not stopping at an intersection. I don't have enough info to call this anything but a regular accident but it feels a little like PTSD in regards to those who help me.

My youngest sister died from [?] [?] accidentally being given penicillin to which she was allergic. A prison guard told me a story about this before it happened in a very strange manner. She was in a 3 month coma, then died on 21 JUNE 2017 from poor health after the coma.

I am doing well since God repaired the 100% blockage on my Right Coronary Artery. My paralyzed Left Leg is next after the blockage of blood flow behind my ~~leg~~ Left Knee is fixed. I hope you all are doing well.

Father of two ID'd as victim in slaying

A body found inside a Norvell Township home up for sale was identified as the owner and a murder victim.

Curtis Gilbert Smith, 49, of Manchester died of a gunshot wound likely administered by someone else, authorities said.

"The evidence we've uncovered so far leads us to believe it was a homicide," said Capt. Dave Luce of the Jackson County Sheriff's Department. "Right now, the detective bureau has a couple of tips they were working on but nothing in particular."

Smith was dead at least five days, according to a medical examiner's report. Due to decomposition, officials waited until an autopsy Monday to confirm the identity.

On Saturday afternoon, two prospective buyers looking at the home at 2233 Collingwood Court called authorities after making the grisly discovery.

Smith owned a construction company. Survivors include his wife, Lisa, and daughters Shannel, 15, and Shana, 9, all of Manchester.

"He was a loving father, a dedicated husband and a friend to everyone," said Sheila Butler, his sister who lives in Myrtle Beach, S.C.

During the past year, Smith kept busy with construction projects, which included fixing up the Vineyard Lake-area home, family members said.

He also may have been staying there, Luce said. No missing person report was filed in connection with the case.

Authorities declined to disclose further details.

The victim's surviving siblings, which included two brothers, Charles and Keith, gathered at the home of their father, Cecil Smith, in Brooklyn. Arrangements are by Eagle Funeral Home, 109 East St., Jonesville.

"Right now, we're holding up," his sister said. "At this point, we just want to see our brother respected and buried, and see justice served."
