I need Special Accommodation for:

- (1) Daily EXERCISE periods on cycle in the GYM so blood does NOT STAGNATE in my left leg (I often cannot walk the yard);
- (2) A carry BAG on my Rollator-Walker (It's unstable when used with one hand while carrying (Chronic Dizziness);
- (3) AIR MATTRESS because severe back pain of multiple fractured vertebrae prevents sleep (& I get bedsores);
- (4) EXTRA PILLOW to prevent Nocturnal Fluid accumulation in lungs of Congestive Heart Failure & for GERD;
- (5) New AFO BRACE with longer heel to fit my long heel spur;
- (6) 1.5 inch DEEP TOE BOX SHOES/Boots with High Top to fit my long heel spur;
- (7) Long-sleeve T-SHIRT to protect my cancer-prone skin from sunlight;
- (8) Transport only by WHEELCHAIR VAN between prisons;
- (9) To use the bathroom during count when coming out of atrial fibrillation so I don't defecate, urinate and/or vomit on myself (01 JUL 2019 MED Record) per WARDEN CONNIE HORTON.

- (10) Will you send me to Henry Ford Allegiance for my FEBRUARY 2020 FOLLOWUP with my Cardiologist on my JUNE 2019 Surgery?
- (11) Will you send me to Henry Ford Allegiance for my scheduled back surgery regarding my JULY 2019 MRI? (left leg paralysis)
- (12) What will you do about me NOT SLEEPING at night due to Nocturnal ANGINA, Nocturnal DYSPNEA, Nocturnal HYPERTENSION after using the bathroom, and 80-decibel RINGING IN MY EARS with dizziness and nausea?

- (13) What will you do about my Daily exertional ANGINA where I must take 2-4 nitroglycerine tablets? Going to chow, etc.
- (14) What will you do about daily severe PAIN in my Right Temple, Right Hearing Loss, Right Ear Pain, Right only Sinus Blockage and pressure, itchy-fungal-tasting drainage from Right Eustachian Tube, Right-sided difficulty swallowing, and often Right Vision Loss?
- (15) What will you do about my near 50% loss of blood flow to and nightly NEUROPATHY in my left leg?

(16) What will you do about my Right-Sided Chronic Fungal Mastoiditis

30 SEP 2019 Dear Rudy & Erin,

The above is a copy of my handwritten note to Nurse Practitioner Susan H. Wilson who I was scheduled to see at 1150 hours on 20 SEP 2019. They cancelled the appointment at 1000 hours. (I believe her husband is a doctor at War Memorial Hospital in Sault St. Marie.) On 24 SEPTEMBER 2019, they rescheduled me to see NP BRENDA L. BUCHANAN to whom I gave the same note.

Nurse Practitioner Brenda L. Buchanan put in a request, based on my 31 JULY 2019 MRI, for a "neurosurgeon consult" on back surgery. On 24 JUNE 1996, a jailhouse snitch working for then Deputy Warden Allen Gary Haigh (who lost his job) did an assault and battery that fractured 3 of my Thoracic Vertebrae and ruptured 3 Lumbar Discs. I may finally get corrective surgery after years of pain and dysfunction caused by this.

NP Buchanan also put in for surgery on an inguinal hernia that occurred in FEBRUARY 2018 aroung 0200 hours while I was sleeping. This showed up as an inguinal hernia during the 31 JULY 2019 MRI on my Lumbar Spine. Dr. Charles S. JAMSEN (Jackson, MI) refused to request surgery in 2018. An inguinal hernia can turn into GANGRENE within 6-hours when it pops out. I pushed the hernia in many times from FEBRUARY 2018 to SEPTEMBER 2019 to avoid getting GANGRENE and IMMINENT DEATH therefrom. JAMSEN endangered my life but, hopefully, relief is soon to come. Thank You, Jesus.

The 27 to 29 AUGUST 2019 transfer was intended by the PUBLIC OFFICE MAFIA, inter alia, to delay or deny me surgery for the hernia, back and left leg, and possibly to cause my death. MATTHEW 7:12; LUKE 6:38; PSALM 91 & 105:15.

I'm thoroughly enjoying the BLESSINGS with my Friends and Family of Christ who are here. PTL!!!
