

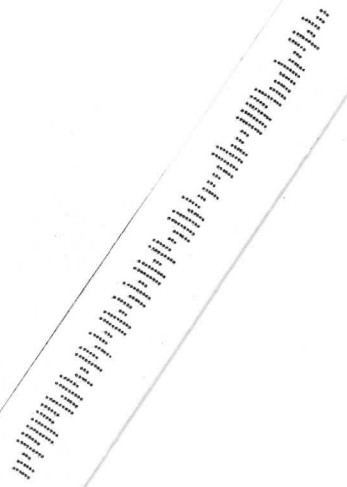

12-27-19

I have been meaning to write this letter since 12-19, but have been amazingly busy.

First, I remembered what I forgot in the last letter I sent to you. ~~the~~ failed its accreditation last summer (^{The prison} Aug/2019?); so ~~we~~ ^{FCL} had another one Dec 17-19. ^{Sept} Many of the ^{Aliceville} women here were called to the Lt's office for UA's (Urine Analysis), including myself, more than once within 2-4 weeks time (I was called at a 2 week interval). But, on the 2nd trip over, I noticed something... the officer did not date the paperwork. I don't know if they were playing "catch up", or it has been suggested that they wanted clean

UA's on record for possibly dirty? When I think back on it I do not think they dated the 1ST ones either. The only other UA I have have since I have been here was 2 weeks after I arrived.

Now, for the reason of this particular letter... see the enclosed memo. I do not know if any other prisons do this (paragraph 2). I am told they use PREA to get away with it. But, here's the thing... we have men working here, some are tall. When we go to the restroom, or change clothes, we can close our doors. Most of the men will not look over the 'wickies' (paper we put in the window to allow roommates and/or officers that we are not decent), but some do, as I had happen to me on Dec. 19th by Mr Wilder. Fortunately, I was clothed

and not on the toilet. My roommate had just gotten back in bed and left the wickie up for me. I was climbing down from my bunk and he looked over and said the door needed to be open. I told him I was just getting out of bed and needed to dress. Officers have peeked over before quickly, but there was nothing quick about what he did. Finally he did walk away and I was able to do my business.

Here's the thing, they allow women to hug, hold hands etc in other places around the compound (even in the church), and say nothing most of the time. Some officers even turn a blind eye when someone comes

in from another unit to see their girlfriends. So, as I see it, and many others, this door open thing is no more than a form of torture. The units, ours in particular, are quite loud. So, no one can get any good rest or relax. The officers (most) do not enforce 'quiet times'. Then you have inconsiderate women whom wish to yell across the main room while standing ~~at~~ outside "our" door, things can get ugly quickly. It has not served it mentioned reason, and I believe makes people more apt to fight due to lack of rest and just plain aggitated states.

Also, I want to add that I heard one of the Unit Managers, Ms Jenkins, state to ~~others~~ other officers at lunch one day "You have to make them as uncomfortable

MEMORANDUM FOR INMATE POPULATION

SUBJECT: Increased Safety and Security

Measures are being implemented to increase the safety and security of both staff and inmates. These measures are in compliance with Prison Rape Elimination Act (PREA) standards and are aligned with the Bureau of Prison's goals.

Effective immediately, all cell doors must remain open from 6 am to 10 pm, during the workweek, weekends, and holidays. Doors can be temporarily closed for the purpose of using the toilet and/or changing clothes. If inmates are found inside a cell room where they are not assigned, they will be considered out of bounds and subject to corrective action. To prevent theft of personal items, inmates should ensure property is secured in wall lockers.

Effective June 24, 2019, unmonitored areas on the north side of the recreation yard will be temporarily closed. These areas include three basketball courts, inmate toilet area, and a softball field. Out of bound signs will be posted. Inmates found in these areas will be considered out of bounds and subject to corrective action.

Effective Monday, July 1, 2019, all inmates will be required to wear jumpsuits prior to proceeding to the visitation area. Additionally, all food items purchased from vending machines must be removed from the packaging and placed on a paper plate, prior to the visitor exiting the vending machine area. **Vending machines are provided for visitor use only.** Inmates are not authorized to purchase items from the vending machines and are not allowed in the vending machine area.
