

Advocacy Grants \$250 Still Available

There are many organizations that work within or with the Criminal Justice System to help individuals.

When a Chapter engages with an organization in their community that provides a service or services within the Criminal Justice System helping adults or juveniles, Alpha Phi Sigma will donate \$250 to the organization.

GUIDELINES

- 1. Locate an agency in your area that provides a service within the Criminal Justice System: Adult or Juvenile.
- 2. The Chapter must engage in an activity with the agency.
- 3. Send Headquarters a brief write-up about the organization, full name and address of the organization, name of a contact person, and a photograph of Chapter members engaging in an activity with the organization.
- 4. Submit all of the above by email to <u>Headquarters@alphaphisigma.org</u>. Please type <u>ADVOCACY GRANT</u> in the subject line.
- 5. Once the information is approved, the Chapter Advisor will receive an Alpha Phi Sigma check for \$250 payable to the Advocacy Organization.
- 6. Alpha Phi Sigma members must return to the organization and present the check on behalf of Alpha Phi Sigma through their Chapter.
- 7. The original story and photographs of the activity along with the photograph of the funds presentation submitted to Headquarters will be featured in the Docket.

9. Only one check per Chapter will be issued per calendar year. Chapters petitioning for a second advocacy grant the following year must choose a different advocacy group from the previous year.

The Advocacy Grant is NOT the same as a Chapter Grant.
The Advocacy Grant <u>cannot</u> be used as the Theme of the Year or a Chapter Goal.

If you're a person of color who is shopping for items such as hair care products, access to items is limited at best.

"It can be a challenging to find hair care for people of color, especially in communities like Tiffin, including finding someone who knows how to cut your hair" says Criminology Professor Dr. Sarah Lazzari, who is also the mom of a child of color.

Sarah is also the advisor to Alpha Phi Sigma, the criminology honorary here on campus. On the heels of Martin Luther King Jr. Day in January and Black History Month in February, Alpha Phi Sigma members were motivated to do a service project relative to people of color and at the same time, connect with the local criminal justice system.

After brainstorming several ideas, Alpha Phi Sigma kicked into action and launched a month-long donation drive on campus in February to collect hygiene items – with an emphasis on kids of color -- for youth incarcerated at the Seneca County Youth Center.

They quickly found out they were not alone in their efforts. "As we were thinking through how we wanted to gather items, we decided to reach out for help," Sarah says.

As a chapter, they received a \$250 grant from the national Alpha Phi Sigma organization, which they designated partly for supplies. Additionally, a connection that Sarah has with fodada, a clothing company in California, proved valuable. Founder of fodada, Bobby Barzi, provided 25 sets of shampoo, conditioner, and leave-in treatment toward the effort.

And then, the Heidelberg community came through. Students placed donation boxes around campus. Parkhurst Dining GM Tony Ippolito arranged for donations of toothpaste, body wash and deodorant, about 100 items in all. Heidelberg's Disability Advocacy Division also pitched in, helping to post flyers, check donation boxes and gather items at the end of the drive.

On Thursday, March 11, members of Alpha Phi Sigma, along with Sarah, delivered the collected items to the Youth Center, with more to be delivered this week. Along with Sarah and Alexa, students Courtney Bryson, Fletcher Grey, Mya White (Alpha Phi Sigma vice president) and Jessica Voitko presented the items to Sarah Canalos, director of the Youth Center. Also assisting with the donation drive were Jessika Costmire (secretary) Haley Cruikshank (treasurer), Brooke Franz, Kendall Wright, Madison Leiser and Ainsley Tucker.

The pandemic and the resultant remote operations were certainty challenges, but challenges that were met head on- and successfully- by an engaged chapter demonstrating: Academic Excellence, Leadership, Service, and Unity.



Here is also a little information about this organization:

Wiregrass Angel House advocates for victims' rights and services for victims of violent crime, providing direct services to victims and their families, and providing public education and awareness.

Our staff members are available to assist the family and loved ones of a homicide victim. Advocates assist survivors in communicating with Police, Attorney's General office, and Governor's Office and provide emotional and physical support throughout the course of your case. Advocates work closely with the staff in all phases of the Criminal Justice System. There are nearly 45,000 homicides annually in the United States. This effects between 150,000 and 200,000 relatives and other survivors. The trauma and grief experienced by survivors cause emotional scars that last a lifetime. We assist with Death Notification, Media Coverage, Funeral Arrangements, Victim's Compensation, Trial Attendance, Insurance Claims, Crime Scene Clean-up.
