

Alpha Phi Sigma Extends Chapter Advocacy Grants \$250

There are many organizations that work within or with the Criminal Justice System to help individuals.

When a Chapter engages with an organization in their community that provides a service or services within the Criminal Justice System helping adults or juveniles, Alpha Phi Sigma will donate \$250 to the organization.

GUIDELINES

- 1. Locate an agency in your area that provides a service within the Criminal Justice System: Adult or Juvenile.
- 2. The Chapter must engage in an activity with the agency.
- 3. Send Headquarters a brief write-up about the organization, full name and address of the organization, name of a contact person, and a photograph of Chapter members engaging in an activity with the organization.
- 4. Submit all of the above by email to <u>Headquarters@alphaphisigma.org</u>. Please type <u>ADVOCACY GRANT</u> in the subject line.
- 5. Once the information is approved, the Chapter Advisor will receive from Headquarters an Alpha Phi Sigma check for \$250 payable to the Advocacy Organization.
- 6. Alpha Phi Sigma members must return to the organization and present the check on behalf of Alpha Phi Sigma through their Chapter.
- 7. The original story and photographs of the activity along with the photograph of the funds presentation submitted to Headquarters will be featured in the Docket.
- 9. Only one check per Chapter will be issued per calendar year. Chapters petitioning for a second advocacy grant the following year must choose a different advocacy group from the previous year.

The Gamma Rho chapter hosted a guest lecture on Friday April 9th. With the Chapter Project Grant the chapter received from Headquarters we were able to provide Quan a honorarium for his talk. We promoted this speaker event to the entire Criminal Justice Department as part of our Education Leadership. It was an incredibly enriching experience for students to hear Quan's story since many of the students in attendance are seeking careers in criminal justice.

In 1999, Quan Huynh shot and killed another man in a gang-related shootout in Hollywood, California. He was sentenced to 15 years to life in prison and the circumstances made it unclear that he would ever get out. He ended up serving 22 years. Even within the hostile environment of prison, Quan sought his own healing, transformation, and self-discovery and earned his release in 2015. Quan spoke about his experiences and answered student questions.

The organization stands with those victims of sexual assault and condemns any sort of sexual assault offenses, regardless of gender, race or socioeconomic status.


The Omega Phi Chapter is proud to showcase the design created and invites other chapters to support this cause or other causes that stand against any sort of violence in our communities.

ALUMINUS Dr. JOHIN MCLAUGHILIN

Alpha Phi Sigma Alumni, former Council member, and Advisor to receive NLPOA Award



Dr. John E. McLaughlin, director of Criminal Justice Programs, will receive the 2021 National Latino Peace Officers Association (NLPOA) Alan Alvarez Legacy Lifetime Member Award at a banquet in Houston, Texas in September.

"You have 'Bridged the Gap between Latinos and Law Enforcement' and your hard work has not gone unnoticed," said Greg Gonzalez, NLPOA vice president and awards chair, in a letter to Dr. McLaughlin. "You were selected for your leadership and commitment to serve the mission and goals of the National Latino Peace Officers Association for more than 20 years."

Dr. McLaughlin has been with SFSC since January 2021. Previously, he honorably retired as lieutenant after serving 26 years with the Miami-Dade Police Department and served as chief of police in Rivesville, W.Va.

McLaughlin first met members of NLPOA while working for the Miami-Dade Police Department. "I worked for five years at the Miami-Dade Police Academy and did the training/coordination for the specialized classes and educational classes," he said. "NLPOA was having a conference and members of the organization stopped by and indicated that they needed a presentation on racial profiling. So, I did the presentation. Then, they asked me to join the organization. Ever since, I've attended most of their conferences on a yearly basis."

To receive the Legacy Lifetime Member Award, an individual must have been a member for over 20 years. Dr. McLaughlin has been a member of NLPOA for 21 years. He served on the National

Board of Directors as parliamentarian for two years and has been the national editor for the organization's newsletter for past seven years.

The NLPOA was founded in 1972 to eliminate prejudice and discrimination in the criminal justice system, particularly law enforcement; reduce community juvenile delinquency; and lessen citizen tension in predominantly minority communities. It is the largest Latino law enforcement organization in the United States and has chapters nationwide.




GOLDEN ALUMINA TAMARA WIILKINS, Ph.D.

More recently (Dec. 2017), she earned another master's degree in Experiential Education from Minnesota State University Mankato. She has experience as the Director of the Law Enforcement Program at MSU and was the Minnesota Peace Officer Standards and Training (POST) Coordinator for numerous years. She became a member of Alpha Phi Sigma as a graduate student, and has been serving as the Chapter Advisor since her hiring date in the fall of 1999. She has experience as a National Advisor and Executive Council member, and takes great pride being a Golden Alumni member of APS. Her primary areas of scholarly interest are victimology, multicultural training, people with disabilities, and deviant and criminal behavior. Local Marine Corps veteran William Nay from American Veterans Post 55 in Sonoma will attend "Rolling to Remember" on Sunday May 30.

Veterans from around the country will be participating in a demonstration ride to raise awareness of issues facing American veterans and demand action for the 82,000 service members missing in action. The event is also intended to raise awareness of the 22 veterans who die by suicide each day.
