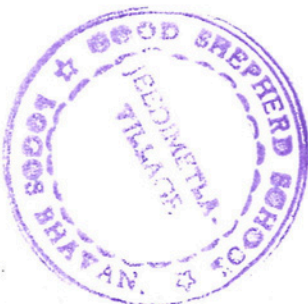

Framed Structure in Ground, First, Second and Third floor only.


It is well planned and spacious classrooms are provided with

classrooms. The estimated life of the building is another 15 Years.

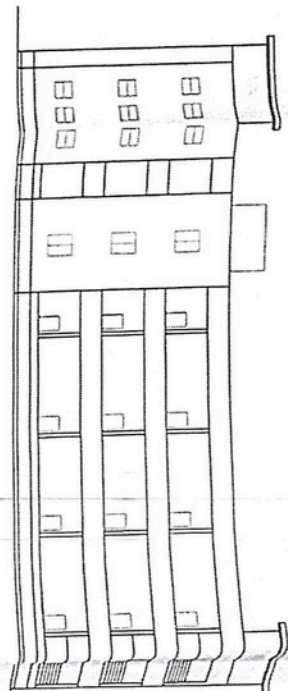

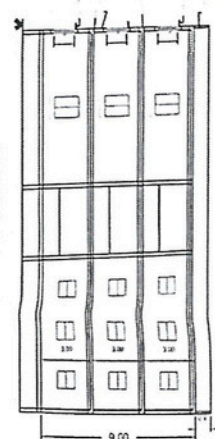

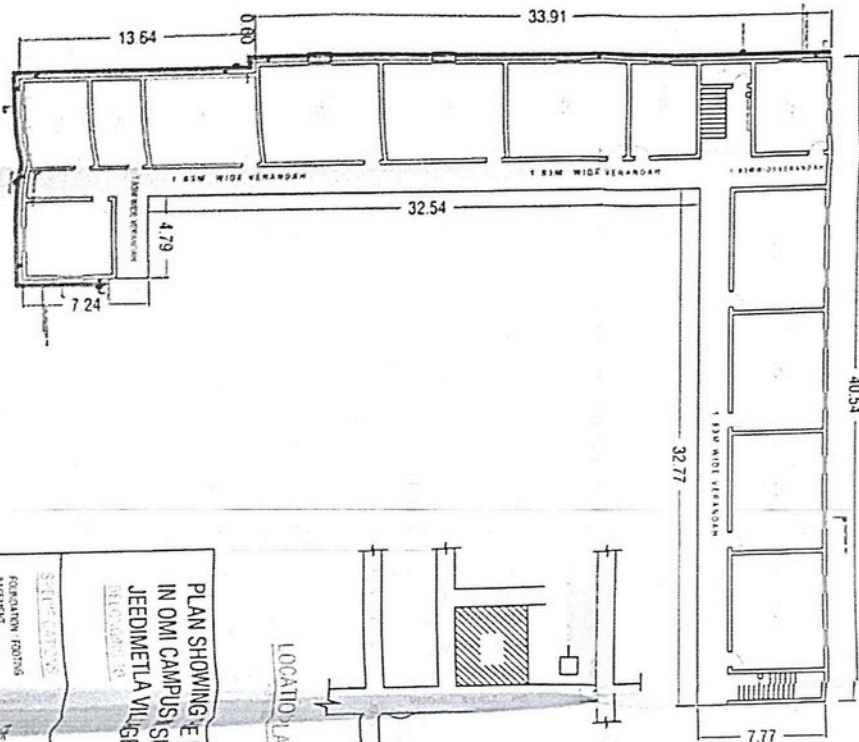




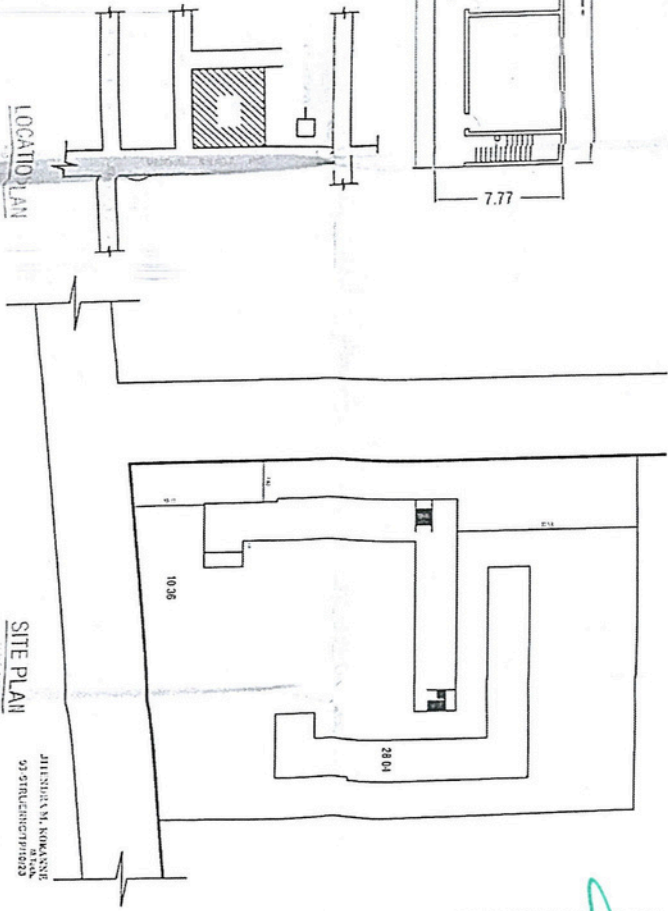
