With reference to the subject cited, Mrs. Shipra Sanyal, Principal, Good Shepherd School has submitted an application requesting for School traffic NOC to Good Shepherd High School, Plot No. 154, Meenakshi Estates, Jeedimetla village, Medchal District, Hyderabad - 500067.


Accordingly, the matter has got enquired and I hereby recommended to Issue School traffic NOC to run the above school, subject to the following conditions.

1. The School Management should not obstruct general traffic.
2. The school management should deploy traffic marshal to ensure free flow of traffic.
3. The management should ensure the safety of the children while crossing the main road.
4. The boarding and unboarding of school children should be within the School Premises.
5. The management has to erect all the necessary road signages in the school premises as per IRC specifications.
6. They should permit the vehicles coming to the school to drop the children only.
7. The class rooms shall not be located in the road side block.
8. Proper safety measures shall be adopted by children or crossing the road before and after school.
9. The visitor vehicles, parents' vehicles, etc should be parked in the earmarked parking area.
10. The School Management shall depute Traffic Marshalls for the maintenance of free traffic flow during school opening & closing times & also monitor the traffic.
11. Sufficient Parking place shall be provided & proper signages be put up for the same.
12. Parking boards earmarking at outside area shall be displayed.
13. Under-aged school children shall not be allowed to drive automobiles.
14. Maintain deficient parking place always.
15. The School management should maintain Zebra Crossing In front of the school entrance & exit gates for children safety.
16. The School management has to provide speed limits signage boards, pedestrian crossing in the school premises.
17. First Aid Kit, Medical Staff should be kept available as the kids age group up to 15 years.
18. Parking of any school related vehicles like school buses, students pick up vehicles etc., on road shall not be allowed. It is the duty of the school Management to ensure the same for better Road safety & smooth traffic regulation.
19. The School premises shall have separately earmarked ENTRY & EXIT Gates which shall be equipped with CC Cameras for Surveillance and also at parking place.
20. The Physical Director of the school should supervise the security guards.

21. All the construction should be enough strong. No sharp items laid down in school premises area.
22. The school management should instruct stricter the bus drives of their school buses to follow all traffic rules and regulations & scrupulously.

Further, it is requested to communicate a copy of proceedings with regard to permission/license granted to the above school to this office for record.
