The board reviewed several EMR appeals for the below accounts:

256PV0000021- This appeal was denied, the homeowner will be informed that they must reapply with the condition that all the fencing would be of the same materials.

2560400065- This appeal was denied, homeowner will be informed that they must resubmit with the lot survey, showing the easements for both the play structure and the gazebo.

2560100096- This appeal was denied based on the lack of information for the pool. The homeowner was informed to reapply with the following: Pool Contract, Topography Report, Lot Survey showing the distances to property line, and the written approval from the utility district.
