The Board of Directors meeting of River Plantation Community Improvement Association, Inc. was held on the above date via conference call.

Call to Order: Due notice having been given and a quorum being present, the Executive Session was called to order 6:03 p.m.

EXECUTIVE SESSION

The Board reviewed the Crest AR Report and the Enforcement Action Report/Deed Restriction Violation Report.

A motion was made, seconded, and carried to adjourn to Open Session at 6:32 p.m.

OPEN SESSION

Executive Session Summary: The Board adjourned to Open Session at 6:32 p.m. and Director Goodman summarized what was discussed in Executive Session. The Board reviewed the AR Report from Crest and the Enforcement Actions Report for deed restriction violations. Director Goodman discussed the status of ongoing litigation with owner of Accounts #25605000046 and #2560500068. The recent damage to the RP bridge was more extensive than originally thought. Repairs are still ongoing.

Approval of Minutes: Minutes of the Board of Directors meeting held on October 14, 2020 were approved as written.

Financials: The October 31, 2020 financials were reviewed. The Operating Accounts totaled \$264,603.70 and the Reserve Accounts totaled \$155,223.05.

BUSINESS:

Townhall Meeting Update: Director Goodman thanked everyone who called in to the Townhall Meeting in October.

Enforcement Actions:

The Board reviewed the Accounts Receivable Report as presented from Crest.

A motion was made, seconded, and carried to approve sending 419 late notices.

A motion was made, seconded, and carried to approve attorney action for 54 owner accounts.

Enforcement Action Report/Deed Restrictions. A motion was made, seconded, and carried to refer 3 owner accounts to Hoover Slovacek to pursue a failure to comply with deed restrictions if not corrected by next inspection.
