## **NEW BUSINESS**

- Wendy made a motion to make the Area, Division, and District contests virtually. Steve seconded the motion
  - Christina Evans asked if this is a final decision or is there an option to change the position later
    - Dan Kyburz answered that TI has determined that this decision will be final for this year
  - o Christina Evans asked if we felt that virtual contests resulted in fewer participants
    - Dale Posont and Christina Evans reported that he has heard from several that they will not participate until contests are in-person
  - Bonnie Tippey felt that contestants might feel they could not apply their contest speeches to their Pathway projects
    - Dan Kyburz replied that this information might be passed on in contest training
  - Wendy Pesavento felt we need to increase focus at club level on contest participation.
     Jana Hergert suggested that the Area Director could do this during visits, with enthusiasm
  - Bonnie Tippey pointed out that if one contest is held in person it means all Area,
     Division, and District contests must be in person and that will require many
     functionaries
  - Dan Kyburz reminded all that the Club level contest can be held in person. It is not affected by this ruling
  - Christina Evans suggested that a committee be formed to determine how next year's contests could be held in-person
  - o Wendy Pesavento withdrew her previous motion
  - Wendy Pesavento made a new motion to adopt virtual Area, Division, and District contests for 2023-2024
  - Steve Vaccaro seconded the motion
  - The motion passed
  - Bonnie Tippey moved that we establish a committee, including some DEC members, to determine the best way to move our contests to in-person next year
  - Second by Christina Evans
  - Motion passed by a majority
  - Dan will work with Christina Evans to assemble that committee with Christina Evans as Chair.
