- Jury fees can be paid by credit card, in person, at the front desk at the Pavilion.

ELIGIBILITY

This juried exhibit is open to all fine artists, 18 years and older, living within a 50 mile radius of Elk Grove Village, IL.

All work must be for sale, and not previously exhibited in an Art Centre exhibition. We reserve the right to reject any art that does not meet our expectations or conforms to the norms of the community.

- All work must be original, conceived and executed solely by the artist, and completed in the last 2 years.
- All work must be framed and ready for delivery if sold.
