After the 10<sup>th</sup> of the month a **late fee of \$25.00** will be enforced. If your account at the end of the month is not paid, you may incur legal fees if your account is given to the lawyer for collections.

## Getting to know Michelle David Meadows Mail Lady By Bill Jeffries

She knows your name, your address, and when you go on vacation. Everyone recognizes her and now everyone will get to know our Mail Lady, Michelle David.

Michelle was born in Pittsburgh, Pennsylvania in the mid-1960s. She had four younger sisters and her family moved to south Florida when she was eleven. In February 1988 Michelle married Theodore David. They have a son, a daughter, and one seven-month-old granddaughter. Theodore died in 2020 from the COVID 19 virus.

Michelle's career with the Post Office started in 1985. She reported for work on her first day wearing a REO Speed Wagon Shirt. After several fill in positions, Michelle landed the job of delivering mail at Century Village. She delivered mail there for thirteen years. She recalled becoming very attached to the residents and said, "seeing them pass away was very depressing. It was like I was losing my grandparents over and over again."

Michelle took the summer off and considered retiring. Instead of retiring she bid on the Meadows of Crystal Lake route. She started in the Meadows in 2005 and when the recession of 2007 hit, she and Theodore were both glad she hadn't retired. He owned a land surveying company that employed 23 people in 2007. By 2009 only three employees were left. Michelle recalled Theodore saying "Letting people go was the hardest thing." As the recession ended the company was back to having ten employees. Working together, the couple, and the company survived on their savings and Michelle's steady pay checks.

When she first started at the Meadows, Michelle's first reaction was, "All the houses look the same." The lot numbers don't mean anything to the Post Office. The Post Office

goes by real addresses. Michelle recalled, that the person who trained her, taught her to: "sort by address, but deliver by name." She said, "Sometimes a letter is addressed to Grandma and Grandpa at an address, and I know who it is going to." If you get a letter for a previous resident, it usually happens on a day when Michelle has the day off, because the substitute is delivering to the address.

One of Michelle's most memorable experiences with the Post Office came in 1996 when she was part of the Deerfield Beach Post Office crew that carried the

Olympic Torch through Deerfield Beach on A1A and passed the Torch off to Pompano Beach's Post Office at the city line.

Michelle has been working since she was 15 years old, so plans after retirement include: Not going to bed early, waking up late, reading books, walking the dog, bike rides, and coming to Bingo. She also said she wanted to learn sign language and Spanish. Michelle said, "I won't need to squeeze everything into 'that one day' I have off." About the Meadows, Michelle said, "I'm not going to miss the job, but I'm going to miss the people."




