Board of Directors Meeting Minutes

- Board members present: Bill McCaulley, Mark Presnell, Rob Gyngard, Ralph Gates, Micah Gibbons and Bill Spurlock. 30% of board members eligible to vote is a quorum.  $10 \times 30\% = 3$
- President Bill McCaulley called meeting to order.
- Previous minutes were approved.
- Secretary/Treasurer financial report was approved. Form 1023-EZ for 501(c) status with the IRS was filed. Should receive approval or request form more information in a month or two.
- Zone Shoot at St. Louis Skeet and Trap Club is ready for pre-registrations. Six fields will be used. Nine referees will be needed. STL will be doing a referee recruitment. Bill McCaulley will hold referee classes to get them certified.
- Joy Owens is ordering Missouri State Skeet Association shooting towels. They are very nice velour towels with the MSSA logo. Estimated cost will be less than \$4 each. They will be sold at a profit at the Zone and State Shoot.
- 2021 State Shoot, 8/27-29 at the Gateway Gun Club
  - 1) Program will be similar to 2020.
  - 2) NSSA \$1,000 grant has been applied for. If grant is approved, it will be distributed as a free HOA entry, with payments prorated by class size.
  - 3) Dinner on Saturday evening will be available. \$15 per person.
  - 4) Lunch may be available.
  - 5) Shooters should bring all their ammunition, as the club may not have any to sell.
  - 6) Mark Presnell will build a portable podium, and will obtain medals from the NSSA for open CH, RU, 3RD, class 1<sup>st</sup> & 2<sup>nd</sup>, and concurrents CH & RU. These will be presented at the completion of each event, and a photo taken for the website. The cost for the medals will be about 60% of patches and plaques previously used.
- Prairie Grove Shotgun Sports has committed to a \$1,200 sponsorship for the 2021 Points Challenge. The ten buckles will have Prairie Grove Shotgun Sports recognition on them.
- US Bank is authorized to add president William (Bill) McCaulley as an authorized signer on the checking account. Kevin Hess, the previous vice president has been removed as an authorized signer.
