On May 18th, the Chapter is sponsoring a CHILDREN'S VARIETY SHOW at Rincon High School. The Officer's and Directors of V.V.A. Chapter 106 are hopeful that we will see many of you at the show. On June 13, 1986, the City of Chicago is putting on a parade somewhat similar to the parade last year in New York City. The theme of the parade is "WELCOME HOME - VIETNAM VETERANS": To proudly welcome home Vietnam Veterans, followed by a week-end of activities honoring Vietnam Veterans. For further information, please call me at home and I will be happy to furnish you with more information.

V.V.A. NATIONAL is planning a National Conference to be held in September 1986, the theme of which is "IN SERVICE TO AMERICA", which is our National slogan and part of the logo. There will be various seminars on the different committee's and how to expand them into the various communities where we, as Vietnam and Vietnam-Era Veterans, live. If you have any suggestions or would like to become involved in a "Conference Committee" please contact me and we will work together on the project.

In conjunction with the above mentioned "Conference" in June this year is the V.V.A. SERVICE OFFICER REPRESENTATIVE Training Program. If you are interested in becoming a Service Officer to process disability and other claims, you must apply through the Chapter. The Board of Directors have to review your application, approve it and the Chapter President must make a recommendation after application review. The President is also required to submit a letter to National explaining why the President thinks that the applicant is "qualified" to apply for the Service Program.

At the last Chapter meeting I brought up the fact that I, as an individual am presently doing a feasability study about the possibility of starting the VIETNAM VETERAN'S RADIO NETWORK. Through contacts that I have at National, as well as in the Network media, I expect to have an opportunity to put together a plan where I can form a Non-Profit radio Network throughout the country, possibly through PBS. Plans are still on the drawing board, and it does take time to make all the necessary contacts, but I am hopeful that I will have something positive to report in next month's "Corner".

As you know, the Constitution has been amended and updated as of our last National Convention held in Detroit last November. There are many changes, that have to be dealt with IMMEDIATELY. I personally, as well as your Chapter President can not emphasize the importance of the interpretation of our Constitution. For that reason, I ask your help. Shortly, we will be forming a Constitution Committee. We will also be re-structuring our Committee's to become ON-LINE with National's. It is a very involved process and I definitely need YOUR help. Please contact me and I will fill you in on the process.

Finally, as you know, the Chapter has been involved in becoming more involved in the community. This kind of an effort is necessary for all to be participants. We need MORE contacts in the community; Doctors, Lawyers, Accountants and in general, Professional People who want to be involved in our Chapter. For this, we need your participation.

HISTORY

3 April 1964 Former VP Nixon visits Vietnam and issues a series of statements sharply criticizing US policies for "compromises and improvisations" calling for continues aid, an issue in the forth coming election.

25 April 1964 Pres. Johnson announces that Gen. William Westmoreland will will replace Gen. Paul Harkins as head of the US MACV.

24 April 1965 Pres. Johnson issues an executive order designating Vietnam a "combat area" for income-tax purposes.

2 April 1969 US combat deaths for the week of 23-29 March raised the toll to 33,641 Americans killed in eight years of US involvement in Vietnam, or 12 more than fell during the Korean War.

28 April 1970 Pres. Nixon gives his formal authorization to commit US combat troops against Communist troops sanctuaries in Cambodia. Three National Security Council Staff members and key aides resign in protest over the planned invasion of Cambodia.

16 April 1972 In the first use of B-52's against both Hanoi and Haiphong and the first attacks against both cities since 1968, US Navy and USAF fighters hit supply dumps and petroleum storage facilities. Washington makes it clear that the US will bomb military targets anywhere in Vietman.

The Secret Agent

From July 21st 1965 to April 3, 1970, 425,037 gallons of agent Orange, 8,950 gallons of Blue and 386,965 gallons of White were used in Province of Bien Hoa, III Corp Military Region. Were you there?

Does it worry you as a Vietnam Veteran that you may have been exposed to the deadly chemical <u>Dioxin</u> contained in defoliant Agent Orange used in Vietnam? Does it worry you as a Vietnam Veteran that more and more Vietnam Veterans around the country are showing symptoms of Dioxin poisoning in the deterioration of their health or worse yet, in birth defects and severe health problems for their children?

Above is just a small example of known areas of herbicide missions in the Republic of South Vietnam.

If you wish to know whether you were in an area during or after spraying missions, write to:

 Chloracne, skin erruptions on face, neck and back. Loss of sensations in the extremities, nerve damage.

3. Upper respiratory distress, shortness of breath.

4. Stomach and kidney pain, gastric hyperplasia and ulceration, hemorrhages of gastrointestinal tract and other organs, palpable and tender liver, gastric ulcers.




