AGENT ORANGE UPDATE--The Supreme Court ruled in favor of Vietnam veterans pursuing a class action lawsuit against AGENT ORANGE manufactures and ordered the trial to begin May 7, 1984. Automatically included in this lawsuit are all persons who were in the Armed Forces of the U. S., Australia or New Zealand Armed Forces injured while in or near Vietnam by exposure; spouses, parents, and children of the veterans born before January 1, 1984, directly or derivatively injured as a result of exposure. If you served for more than one enlistment and were denied replacement of teeth extracted during a prior period, you can apply for benefits at any VA health-care facility. Check with the VA to determine your eligibility.\*\*\*\*\*ARMY VIETVETS: Vietnam campaign stars are available now for many time periods of service in-country. Check page 6, of the VVA VETERAN, January, 1984, to determine which you are qualified for and then contact your respective records custodian in St. Louis-Commander, Reserve Components, Personnel and Administration Center, Box 12479, Olivette Branch, St. Louis, MO 63132. This address can also be used to correct SPN codes, etc. \*\*\*\*\*SPEAKING OF MEDALS, Congress has decided that VietVets should be awarded a Vietnam Medal, but are bogged down on the design, size, etc. on this when information is available.\*\*\*\*\*\*Controversy is brewing over the VA allegedly diverting 40% of the Vet Center funds or \$40.3 million to nursing scholarships, hospital expenses or possibly returned to the Treasury. Congressional hearings are currently being held to determine the facts, but for some reason, the House Veterans Affairs Committee has left many wondering why they have not yet intervened. \*\*\*\*\*\*Congratulations to VFW Post 10188, Casas Adobes, on receiving their colors last November. The Post spent two nights showing a emotional film about one of seven VA hospitals which deal only with advance stress cases. The Post Commander's son recently completed this program and was on hand to answer pertinent questions. The sensitivity towards VietVets was evident and the Service Officer, Don Sommerfield, is a VietVet and anxious to help with any inquiries. If you're in the area of 1st Avenue near River Road, stop by and give your regards to another group who cares.\*\*\*\*April 26 is Vietnam Era Vets Rememberance Day-don't hesitate to contact your local, state and federal elected officials to inquire of their activities that day. Point is, if we let people forget, then we'll soon become the same. The idea of extravaganza sales by many merchants on Veterans' Day should be a major conncern to all who served. \*\*\*\*\*\*Officially, the Vietnam War ended 11 years ago for the US, but there are 2,500 Americans unaccounted for in Southeast Asia. Of these, the DOD cites 1,900 missing in Vietnam and the remainder in Laos and The unaccounted for include Navy, 506; Marines, 294; Air Forces, 948; Army, 765; Coast Guard, 1; and civilians, 46.\*\*\*\*\*If you possess Fragments, please send to the newsletter care of the VVA PO Box or bring the info to our next meeting. DINNER FOR 400? \*\*\*\*\* Or three hundred. We don't know for sure yet, but the plans are for a dinner in Tucson at the Holiday Inn Holidome on May 29, 1984, to honor Vietnam Veterans. Chapter 106 is sponsoring the dinner in conjunction with VFW Post 8323, who are sponsoring a Vietnam veterans memorial to be placed in Presidio Park. Prensent plans are for the memorial to be dedicate on the same day as the Chapter 106 dinner. We are inviting several local state and federal official, and this would be an excellent opportunity

for all of us to meet them and make our viewpoints known. Tickets are \$20.00 each and tickets and reservations will be available the second week in April at VFW Posts or by calling 745-6403 or 792-0046.

(WESTMORELAND cont.) Arizona and put the dinner together. The plan was simple and worked better than anyone expected. A massive mailing to private business firms throughout the Phoenix and Tucson areas was made to invite these businesses to buy entire tables and give the tickets to their Vietnam veteran employees and to donate the tickets through the Vet Centers for those who could not afford the price of the dinner. One large firm in the Phoenix area donated ten tables - 100 tickets at \$20.00 each - now that's commitment by private industry to vets.

Jim Hartdegen was the Master of Ceremonies and his theme was that "This dinner is important because everyone needs to know and remember the Viet Nam veteran for what he or she is, a good citizen." Congressman John McCain (R) Arizona, conducted the opening remarks and thanked the Vet Centers in Tucson and Phoenix and the industries who helped sponsor the event. Congressman McCain, a Lt. Cmdr. in the Navy during the War, was shot down in 1967 over North Vietnam and was held as a POW until 1973.

General Westmoreland's (Now living in Spartanburg, SC.) opening shot was "The men and women who served in Vietnam did a heck of a job against the enemy despite a lack of political support at home. What I'm really saying is that you troops could have done better than you did." He also said, "The US Forces had them North Vietnamese on the ropes following the Tet Offensive in 1968, but let licked the living hell out of the enemy at Tet. Our political leadership did that would have accrued by taking the fight to the enemy when he was weak." Although South Vietnam was lost, Westmoreland said U. S. involvement allowed cal, military and ecomonic stability so as to prevent the spread of Russian and the cause.
