"PREVAILING WINDS"

So much is said these days about "good communication," or "breakdown in communication" that the general topic of communication sometimes seems like a boring or trite subject.

Nevertheless, it remains the <u>number one</u> problem area in unhappy families. Families who are stuck in a rut of nonproductive communication typically go around feeling hurt and not understood amidst the regular practice of put-downs, blame, threats, communication cutoffs, mind reading, and the like. People in this rut almost all have one thing in common: they do not <u>listen</u> to others in the family. Unless true listening begins, communication cannot progress to the point where the family can hash out other problems like lack of trust, or disagreement over how to spend money or how to discipline the children. So, how can we listen better? One way - a nearly impossible task for most - is to let one person talk for exactly five minutes, while the other person says absolutely nothing - no comments, no disagreement, nothing. Then the other person gets a turn. Truly easier said than done.

BOARD TALK

Notes from the February Board meeting

Re: Goals--Annual event. Gene Voelzow introduced Tom Patterson from Brewster House who gave a presentation on their organization. Brewster House is a shelter for abused women and children. They provide a place to stay for victims of domestic violence. Each year they hold a biathalon to raise funds. Brewster house cared for 415 women last year. Due to a lack of facilities they had to turn away 80 families last year. They are always in need of the basic items to care for these families. The board was invited by Mr. Patterson to visit Brewster House and see first hand what is going on there. Several board members expressed an interest in visiting and Gene Voelzow will set the visit up..... Chuck McHugh from the Sheriff's Department Search and Rescue gave a presentation on his organization. Although the full time personnel in the organization are paid by the Sheriff's Department, many of the people who work on the actual search and rescue operations are volunteers who work long and hard hours with no compensation. Many of them spend a great deal of money out of their own pockets and travel many hundreds of miles to help out when someone needs help in the Tucson area..... Officers and Directors reports.... Treasurer-Mike Smyth. He reminded everyone that dues are to be paid by Feb 28th. Also dues must be paid up in order to vote in the April elections. Two donations by the same person totaling \$ 278.84 have been given to the chapter for use in sending delegates to the National Convention..... Agent Orange--Louie Leos. He received an article from the Eagles about Agent Orange. After reading it he discovered no new information..... VVA Product Sales-Shawn Swartzmiller. He stressed the need to be given more money so that the Chapter could stock up on VVA items to be sold at Davis-Monthan during A and A days. The board voted to buy more items..... Gene Voelzow spoke of the need for more visibility for the organization. He said that one way is to volunteer to answer phones during the next KUAT public television and radio fund raisers. If ten people volunteered for a block of time we would get a lot of exposure. The board agreed. How about it? If you're interested in being on TV let us know YOU could be a star!.... Old business..... Service Representative. Dave Croteau passed out a letter from National concerning criteria for a service representative. Basically, from the letter it was evident that we can't qualify to send someone to service representative training. The position of Service Representative will have to wait until the Chapter has enough money coming in to be able to pay a full-time Service Representative..... Public Affairs. It was decided by the board that a more important position to fill is a Corresponding Secretary..... New business..... The board voted to spend \$125.00 to sponsor the T-ball team being coached by Bill Rasmussen. The cost will cover baseball hats for the team with the VVA logo. Bill will also take the chapter banner to the games to hang on the dugout. We now have a team to root for and Bill is going to get us a schedule of the games so we can go out and watch..... It was voted to contribute \$10.00 per day to sponsor a walker in the upcoming POW/MIA walk from Tucson to Phoenix. It is estimated that the walk will take seven days for a total of \$70.00. It was further decided that we will ask for contributions from the general membership at the next meeting and that any portion of the \$70.00 not collected in that manner will be made up from the treasury..... It was voted to expand the Board of Directors by one person to create the position of Corresponding Secretary. Albie Ginaro was elected to that position. Congratulations ALBIE..... Steve Nelson and Frank Thompson were nominated for the position of Nominating Chairman for the upcoming election in April..... Dave Croteau spoke of his visit to Casa Grande. They are in the process of trying to re-establish their chapter..... Dennis Calhoun a member of a WA chapter in Michigan was a guest at the meeting and spoke of his chapter. Dennis will be moving to Tucson toward the end of the year. He will be a great asset to the Chapter..... It was announced that Channel 40 is putting on a show about Vietnam Veterans on March 2nd and asked for a list of our members for possible interviews. The board decided not to release the list because it was unclear as to the content of the show and some members may not want to be contacted and the privacy of our members comes first. It was also decided that in the future not to give our membership list out. If anyone wants to interview Vietnam Veterans we can run an announcement in the newsletter and anyone wishing to participate can do so..... Mike Brasher will be out of town for the month of April and Albie Ginaro volunteered to take over as Secretary for the month. Thanks Albie!!!

HOMELESS VIET NAM VETERANS

As I was passing by a park my eyes were magnetized towards the homeless individuals that were there. Curiosity struck me and I decided to seek Viet Nam Veterans. the individuals that I approached became cautious and defensive, but as time went on I feel that I gained some confidence with them.

Of course being homeless is uncomfortable, for in order to survive many have to find a place to sleep, shower, eat, clothe, find employment; bluntly speaking - SURVIVE! I found it interesting to find out that amongst themselves they catagorized themselves in three areas: 1-Homer, 2-Tramp and 3-Transient. The Homers are individuals that have already learned to survive in Tucson. These individuals know where food, clothing and help is along with times and dates plus locations of donations. They also share this information with any newcomers. A Tramp is an individual who doesn't work and just bums around. Now the Transients just travel from city to city. They usually work temporarily and either jump a train or hitchhike to another location.

There was a rescue station nearby and I talked to a worker and he hypothetically stated that they feed around 300 individuals or more daily and that he believes that 65% are Viet Nam veterans.

I write this to share this with my brothers so they can know that there is a need with homeless veterans and also for the homeless to know that we are aware. Hopefully we as the chapter might be able to implement a program to assist the homeless veterans. Of course, time will tell.



The Secret Agent

Vietnam's Last Battle' Agent Orange Update

- 1. We are a long way from resolving the controversy surrounding this issue. But progress is being made.
- 2. As of September 23, 1986, 29,191 have filed claims with V.A. claiming disorder the believed are caused by Agent Orange.

None have been allowed. Re. No evidence of the conditions within six month of leaving Vietnam.

- 3. More than 214,000 Vets have received medical examinations under V.A. Agent Orange Examinations Programs as of last July. The V.A.'s computerized registry also showed 46,345 Veterans received follow-up exams.
- 4. The only health disorder the V.A. will recognize as linked to Agent Orange is the skin condition called Chloracne. No claims have been allowed for Chloracne, also no evidence within six months of leaving Nam.
- 5. Despite Veterans convictions most studies on Agent Orange and dioxin have reportedly determined that no conclusive evidence exists linking the herbicide to cancer or other serious illnesses.
- 6. V.A. recently contracted with New England Research Institute to begin preliminary work on a medical study of women Vietnam veterans that would look at possible health effects related to exposure or Agent Orange and other medical problems.
- 7. Meanwhile the Second Court of Appeals has granted a notion to stay the distribution of Agent Orange payments established under the settlement of class-action litigation in August.

The action freezes any further movement on the cash distribution plan. If and when the stay is lifted about 150 million in settlementfunds, plus interest, will be paid to contain totally disabled Vietnam Veterans and to survivors of certain deceased Vietnam Veterans.

Eligibility criteria for the payments will be announced later.

8. Called the last battle of the Vietnam war the Agent Orange Controversy-although progress is being made-doesn't appear to be reaching a swift conclusion.
