First Amendment to Leona's Rolling Meadows Subdivision Restrictions

WHEREAS, Neumann Emerprises, Inc. (Declarant) is the developer of Leona's Rolling Meadows Subdivision,

WHEREAS, Leona's Rolling Meadows Subdivision is described as part of the NW ¼ of Section 4, Township 1 North, Range 22 East, City of Kenosha, Kenosha County, Wisconsin,

WHERBAS, the original Leona's Rolling Meadows Subdivision Restrictions were recorded on November 20, 2003 as Doc. No. 1363647 in the Office of the Kenosha County Register of Deeds,

WHEREAS, item #30 of the original restrictions states that "These restrictions, except those which are the lot owners' responsibility in perpetuity, may be amended at any time by a majority vote from the Home Owners Association with only one vote per lot or unilaterally by the Declarant until one year after 100% of the lots have been built upon and occupancy permits granted."

NOW, THEREFORE, Declarant hereby declares the following:

- The Restrictions for Leona's Rolling Meadows Subdivision be amended by adding the owners of Lots 89 through 165 of Leona's Rolling Meadows Addition #1 Subdivision to enjoy all the rights and responsibilities of the original Restrictions as members of the Leona's Rolling Meadows Homeowners Association.
- Declarant retains ownership of Outlot 8 of Leona's Rolling Meadows Addition #1 Subdivision.
- 3. After the final lift of asphalt is installed and all infrastructure improvements have been inspected and approved by the City of Kenosha and the affected lots have been sold, Neumann Enterprises, Inc. shall no longer be held responsible for any subsequent damage to said infrastructure improvements, including but not limited to, street trees, curb lines, etc.
- 4. Lot buyers and homeowners are hereby put on notice that certain arrangements have been made between the Developer and Builders which require that the Builder be responsible for installation of street trees per the landscape design and City Forester instructions. In the event that any Builder does not plant the required street trees, and the Developer ultimately installs the trees, Buyers and homeowners are hereby made aware that during installation of the trees some damage may occur to the terrace area between the sidewalk and the curb line.

Buyers and homeowners shall be responsible for repair of any such damage.

- 5. All Lot buyers and homeowners in Leona's Rolling Meadows
 Subdivision are hereby put on notice that additional phases to the
 subdivision will be constructed in 2004 and 2005. This construction
 will involve large earth moving machinery, etc. which will generate
 noise, dust and other disturbances throughout the process.
- 6. All Lot buyers and builders in Leona's Rolling Meadows Subdivision are hereby put on notice that lot grades have been established as part of a master grading plan and that all lot owners are responsible for maintaining the approved lot grades. The lot grades may not be changed unilaterally by any lot owner without City of Kenosha approval.
