



**RECEIVER’S REPORT REGARDING DISPOSITION OF ASSETS AT  
FIRST AUCTION OF PERSONAL PROPERTY BY VOGT AUCTION GALLERIES**

Deborah D. Williamson, in her capacity as the Court-appointed Receiver (the “Receiver”) for the Receivership Parties (as defined in the Court’s December 2, 2021 *Order Appointing Receiver* [ECF No. 17] (the “Receivership Order”)) and receivership estates (collectively, the “Estates”) in the above-captioned case (the “Case” or “Receivership”), hereby files this *Receiver’s Report Regarding Disposition of Assets at First Auction of Personal Property by Vogt Auction Galleries*.<sup>1</sup>

**I. BACKGROUND**

1. On December 1, 2021 (the “Application Date”), the Securities and Exchange Commission filed its *Emergency Motion for a Temporary Restraining Order and Emergency Ancillary Relief* [ECF No. 3] which included an application for the appointment of a receiver for the Receivership Parties (the “Application”).

2. On December 2, 2021, this Court determined that entry of an order appointing a receiver over the Receivership Parties was both necessary and appropriate to marshal, conserve, hold, and operate all of the Receivership Parties’ assets (the “Receivership Assets”) pending further order of this Court. Accordingly, the Court entered the Receivership Order on December 2, 2021, appointing Deborah D. Williamson as the Receiver over the Estates in this Case.

3. On May 17, 2022, the Receiver filed the *Receiver’s Motion for Order Governing Procedures for the Sale or Abandonment of Personal Property and Brief in Support* [ECF No. 203]

(the “Auction Motion”), requesting Court approval of the procedures for the sale or abandonment of personal property.

4. On June 9, 2022, the Court entered an *Order* granting the Receiver’s Auction Motion [ECF No. 217] (the “Auction Order”).

5. On July 26, 2023, the Receiver filed the *Receiver’s Motion to Approve Sale of Certain Jewelry Obtained From Eldorado Ranch Owned By Receivership Party Dallas Resources, Inc.* [ECF No. 381] (the “Jewelry Sale Motion”), requesting Court approval to sell certain jewelry.

6. On August 23, 2023, the Court entered an *Order* [ECF No. 399] granting the Receiver’s Jewelry Sale Motion.

7. On October 24, 2023, the Receiver filed the *Notice of Proposed Public Auction of Personal Property* [ECF No. 423] (the “Auction Notice”) in accordance with the Court-approved sale procedures enumerated in the Auction Order.

8. On November 8, 2023, the Receiver filed the *Certificate of No Objection* [ECF No. 432] regarding the Auction Notice.

## II. REPORT

9. Vogt Auction Galleries (“Vogt”) held an in-person and online public auction of the personal property detailed on Exhibit A to the Auction Notice beginning on December 2, 2023, at 1:00 p.m. Central (the “First Personal Property Auction”).

10. The gross proceeds from the First Personal Property Auction were \$17,450.00. After payment of the contractual auctioneer fees in the amount of \$3,490.00, the net proceeds from the First Personal Property Auction to the Receiver for the benefit of the Estates totaled **\$13,960.00**.

11. On December 21, 2023, Vogt delivered \$13,960.00 to the Receiver, which has been deposited in a Receivership bank account.

12. The Receiver anticipates one subsequent auction for the sale of Receivership personal property items in accordance with the Auction Order.
