# Board Position Job Description: President

- Will preside at all meetings of the board and the membership.
- The president will execute contracts, orders, and other documents in the name of the association as its agent. Including liens, transfer of property ownership papers, common areas, and general maintenance contracts.
- Mailing and record keeping for by-law compliance related issues, in conjunction with the Accountant.

Nominations: Shawn Sampson nominated himself. Kristi Arends did not commit to run for the position, effectively stepping down at the end of her term. No other nominations were presented.

# Board Position Job Description: Vice President

- Manage meetings in absence of the president, manage architectural review/compliance requests
- Arrange for 1 fall and 1 spring neighborhood clean-up, curbside
- Set-up/return signs for neighborhood garage sale

Nominations: Felix Lococo nominated himself. No other nominations were presented.

# Board Position Job Description: Director

 Point of contact for maintenance of common areas, including lawn care, pond, fountain, entry landscaping, roads, and sidewalks/roads, collecting bids for landscape management

# Proposed Covenant Amendments

Article 7.02. Owner Occupancy/Private Use Only.

- 1. Grandfathers in existing renters, but not future renters unless family members
- 2. Owners must occupy houses
- 3. Limits on un-related tenants who may occupy home with homeowner (4).

#### **Discussion**

Motion to proceed with neighborhood vote/vote by proxy to approve change to covenants.

Must have super majority, or 2/3s of owners, voting to accept or reject initiative; 151 houses/100 majority. Discussion about majority v. super majority. Bylaws and covenants indicate super-majority required.

# Article 7.02. Owner Occupancy/Private Use Only.

Sean Sampson motioned NOT to proceed with neighborhood vote.

JeriLynn Taylor seconded and Felix Lococo agreed.

Members voted 6 aye to 0 nay, one abstaining, not to advance the proposal for neighborhood vote.

# Proposed Alternative Energy Guidelines

No bylaw currently exists to address the installation of alternative solar energy panels. It has been addressed on a case by case basis using the architectural review board.

Benefits: Federal: 30% tax rebate; State: non-assessed improvement for 1 years

## Solar Panel Guidelines

After discussion, Deb Shoffner motioned to carry the solar energy guidelines to the neighborhood for adoption with one modification: Panels must be roof and flush mount only. No lawn or side of house installations permitted.

Shawn Sampson seconded the motion.

Neighbors voted 6 aye- 0 nay to present the guidelines for HOA by-law amendment. One abstention.
