## October 22-Public Information and Public Hearing on Sharp Road Tofino Affordable Housing Initiative

Both are happening on October 22 starting at 3:30 for the Public Information Session followed by 4:00 for the Public Hearing both to be held at Council Chambers. Serious concerns have been raised about the amount of taxpayer assistance Tofino is putting into this project to subsidize "affordable housing". Also, there's concerns about density and use at this location and potential future implication to taxpayers if further development is to proceed in this area. For more information:

## October 30 – Proposed Tofino-Ucluelet Public Transit Service Open House

The Alberni Clayoquot Regional District has introduced a bylaw to fund a BC Transit initiative for Bus service on the West Coast between Tofino and Ucluelet and including Esowista and Ty-Histannis, and possibly Toquaht, Yuułu?ił?ath, and Hitacu. Details of the proposal can be found at:

An open House is scheduled to be held on Wednesday Oct 30, 4-7PM at District of Tofino Council Chambers to provide information to the public regarding the proposal. There are tax implications for Tofino that everyone should pay attention to. The proposal includes a tax of \$0.29 per \$1000 dollars of assessment, if approved. Based on recent assessments, this would mean about a \$250 annual increase for an average Tofino house.

The proposal also intends to raise an equal amount of money through a population method. We are unsure at this time what that means.

The Westcoast Transit Service bylaw is subject to an Alternative Approval Process. This provides for a period of time ending Nov 29<sup>th</sup> in which the public has the right to "Oppose" the bylaw. If sufficient numbers oppose, it may force a referendum.
