MONTHLY LUNCHEONS

hillip Merlo, Executive Director of the San Joaquin County Historical Museum, was the July luncheon guest speaker. A native of Stockton, he hopes to continue his research on the municipal government's history of disinvestment in low income communities, and to partner with other educators to build new forums for youth civics, and local history education. The Museum preserves historical county documents, the earliest of which dates back to 1850. Approximately 1,000 researchoriented requests are received each year. Education programs are offered, which include Valley Days, Pioneer School, Festival of Trees, and the San Joaquin County Tractor Fest. Mr. Merlo also commented on upcoming events, a planned rebuilding project, and a couple of state grants the museum has received. Pete Lepisto won \$5 playing the marble game, and Alan Preston won the gift basket donated by Tamara Langenfeld with Valley Strong Credit Union.

The August luncheon speaker was Dani Daly, the Recruiter/Trainer for CASA (Court Appointed Special Advocate) San Joaquin. Ms. Daly gave a passionate talk about the need for foster care youth to have a stable relationship with a supportive adult who can help those who have experienced abuse and neglect do well, even when they have faced significant trauma and hardship. CASA recruits and trains volunteers to advocate for the best interests of the youth to whom they are assigned.

BOARD OF RETIREMENT REPORT — By Steve Moore



n August, I attended the California Association of Public Retirement Systems (CALAPRS) Principles of Pension Governance a course for trustees. The course covered the following topics: "What's the Big Deal About Being A Fiduciary?" "How Should a Board Function?"

"What Benefits Do We Provide /

What is the Board's Role?"

"What Are the Key Issues in Disability Retirement? With Case Study.

"How Should We Manage Our Pension Liabilities?"

"Investment Basics"

"How Should We Manage our Investment Program? With Investment Case Study?"

"Who are Our Stakeholders/What Are Our Roles a "Case Study"

The curriculum was focused on the main responsibilities and duties of a trustee of a public retirement association. I found the case studies to be a most rewarding opportunity as we were broken into small groups to develop a consensus on the selected scenario amongst ourselves and then present our solutions in turn to the other groups. This provided the opportunity to see how other trustees and staff from other retirement boards viewed the facts presented and various alternatives to the presented issue(s).

Overall, the course was very well presented and the networking opportunities will prove invaluable in the future. It was very reassuring to recognize that our Board of Retirement and Staff of SJCERA readily apply the standards presented in the course in conducting the business of your retirement association.

The course concluded with an excellent presentation on AB1234, Ethics Training. I have completed the course before but found it a great review of our roles, duties and responsibilities under the law. I look forward to the additional training opportunities provided by CALAPRS in the future.

She distributed some literature that described the roles and responsibilities of CASA volunteers, and encouraged interested individuals to contact the Child Abuse Prevention Council. The luncheon concluded with Ginger Reese winning the gift basket brought by Tamara Langenfeld with Valley Strong Credit Union, and Carol Carson taking home \$5 from the marble game.

The featured speaker at the October luncheon was Maria Garcia, Program Manager of the Non-Emergency Medical Transportation Program with El Concilio, a nonprofit community organization based in Stockton. Prior to working for El Concilio, she worked for the City of Stockton Economic Development Department (Housing Division), and launched programs with El Concilio for rent and mortgage programs. In addition to the Non-Emergency Medical Transportation Program that provides free transportation to medical appointments, Ms. Garcia informed the group of other services provided to seniors through El Concilio, including Senior Legal and Caregiver Legal Services, Meal PickUp for Seniors, monthly free Farmer's Market, Home Visitation Program, and Citizenship and DACA Clinics. Joe Chelli won the basket from Valley Strong Credit Union brought by Tamara Langenfeld, while Steve Moore picked the black marble and collected the \$80 jackpot. ❖

BOARD OF RETIREMENT REPORT CONT.

I attended the September RPESJC luncheon and one of the attendees asked me two questions. First, what was the current funded ratio for the association? The System's funded ratio, increased from 68.1% last year to 78% as of January 1, 2022 on a Market Value of Assets (MVA) basis." Additionally, the Unfunded Actuarial Liability (UAL) - the excess of the System's Actuarial Liability over the Actuarial Value of Assets - experienced a decrease from \$1.72 Billion to \$1.47 Billion as of January 1, 2022. The second question was what specific items was the SJCERA Portfolio invested in? I related that anyone could view that information by going to the SJCERA website. www.SCJERA.org and selecting the Board Agenda for the month and look at the "Investment Consultant Reports", specifically Monthly Investment Performance Updates -Manger Performance Flash Report with the page number reference to the start of the report covering all actual funds the portfolio is invested in.

Again, you may review the minutes of past Board or Retirement meetings and the upcoming Board meeting agenda on the SJCERA website www.sjcera.org for additional information.

MEDICARE PART B REIMBURSEMENT DOCUMENTATION DUE

JANUARY 3

The Medicare Part B Reimbursement program reimburses the full Medicare Part B premium, up to the amount remaining in an eligible member's sick leave bank. As a retired SJCERA member, you may be eligible for the Medicare Part B Reimbursement program if you:

- Are a retired County employee or eligible beneficiary*
- Were hired before August 2001
- Have a Sick Leave Bank Balance (see your SJCERA monthly earnings statement), and
- Are enrolled in Medicare Part B

*If you are retired from another SJCERA participating employer, contact your employer for availability and eligibility of the sick leave bank.

If you are eligible and wish to participate, by the first business day of January each year, you must submit a completed Medicare Part B Reimbursement form and a proof-of-premium document issued by Social Security or Medicare. SJCERA will mail forms and instructions to eligible retirees by early December. It's a busy time of year: please keep an eye out for the mailing so you can meet the deadline. Visit the Retired Members Forms and Publications page on www.sjcera.org for more information, including the form and Medicare Part B Reimbursement fact sheet.

PREPARING FOR TAX SEASON

Did you withhold enough (or too much) in taxes from your benefit payment this year? You can adjust your future federal and/or state tax withholding by submitting a new tax withholding form, available on the Retired Members Forms and Publications page on www.sjcera.org. Newly submitted withholding forms received by the 15 of the month will take effect on the next month's payment.

Question: Hi Frank, I know you have talked about RMD rule changes not long ago. Could you talk more about the RMD basics? I'd love to have a basic understanding on what an RMD is and how it works. Thanks!

Answer: Here are a few basic facts regarding RMD:

- RMD stands for Required Minimum Distribution. IRS requires all people to begin to take out a portion of retirement account balances each year once they reach age 72.
- The RMD rules apply to all traditional IRAs and any retirement plan sponsored by an employer such as 457 Deferred compensation plans or 401ks. Original owners of Roth IRAs do not have to take RMDs.¹
- You can take your initial RMD from a retirement plan by December 31st of the calendar year in which you

- turn 72. You actually have the choice of taking that first annual RMD as late as April 1 of the following year, i.e., the year in which you will turn 73, but you'll have to take your second RMD by December 31st of that same year.
- The RMD amount is different each year and needs to be recalculated yearly. The "life expectancy factor" provided by IRA Publication 590-B is used to determine your yearly RMD amount. The specific calculations could be complicated, but usually the financial institution that holds your IRA or retirement account can calculate the RMD amount for you.
- If you own multiple traditional IRAs, you have the choice to calculate your RMD for each of those IRAs and take the combined RMD amount for all your IRAs from just one of those IRAs.¹
- The yearly RMD amount is taxable as your income so it will have an impact on your taxes. There are ways to manage the tax impact of RMDs, and you can explore those choices with a financial or tax professional.
