## Precautions in connection with Fire

Fire Fighters should wear self-contained breathing apparatus (SCBA) operated in positive pressure mode and full protective clothing to prevent exposure to vapours or fumes. ## 6. ACCIDENTAL RELEASE MEASURES.

## **Emergency Procedures**

Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. If possible contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain it. As a water based product, if spilt on electrical equipment the product will cause short-circuits. Dispose of waste according to the applicable local and national regulations. ## 7. HANDLING AND STORAGE.

## Precautions For Safe Handling.
