2021 Highlights

Another interesting year started with turning Pilgrim Point Road over to Douglas County for access to the Pilgrim Point Shores Development. Next we asked for quotes and did repairs on about 1,000 feet of soft areas on four different places. Sunset Strip south, corner of Blue Jay Way and Utopia Drive, another spot on Utopia Drive, and the longest area was on Pleasant Grove south of County Road 22. We also replaced a culvert there. We did tree trimming in a number of areas and will be doing more this year. Our biggest project this year was rebuilding 81st Avenue between County Road 6 and Pleasant Grove. Having to go through what is considered a wetland, we had to get a storm water survey done along with getting input from the Army Corp of Engineers and the Douglas County Soil and Water Conservation Department. We removed two feet of poor soil in the unstable areas of the road bed and placed a mat down covering it with three feet of good soil including six inches of class five gravel. We put six inches of gravel on the full length of the project.

A reminder of what can be allowed in the road right-of-way. Just your mail box and 911 sign. No rocks or retaining walls or any other structures. Also, during the winter, for snow removal, please place your garbage container in your clean driveway no further out than even with your mail box. Note. The township has spent about \$2,000 this past year picking up trash (couches, TV's, etc.) along our roads. Please take a note if you see anyone dumping trash along the roads.

Thanks again for the feedback you give the board; it helps us do our job better.

Lake Charley Cemetery

NOTES FROM LAKE CHARLEY CEMETERY OPERATIONS MANAGER

Greetings everyone! My name is Greg Cabana, manager of operations at Lake Charley Cemetery located on Sunset Strip in Ida Township. Over the summer months a project involving refurbishing the split rail fence along Sunset Strip was completed. Several decaying posts and rails were replaced, remaining fencing was power washed and one new 10 ft. section was added.

Another project that has been in the works for the past two years regards visible identification of unknown graves in the Cemetery. Previous volunteers worked diligently to identify unmarked/unidentified grave sites in primarily the older, pioneer section of the Cemetery. There were simple white wooden crosses placed on them at one time, but for the past several years, they were marked by a simple ground level metal tab. These have now been replaced by more permanent metal/powder-coated crosses. Materials and labor were provided by local businesses and installed by volunteers this fall.

A new project underway with completion targeted sometime in the next 18 months is a new section of the Cemetery designated specifically for Cremation interment. Final design and estimates are being completed. This will expand the potential plot availability for Lake Charley Cemetery which is currently limited. Hope to see you soon!

UNKNOWN BURIALS Everybody has a story. Lake Charley Cemetery is home to at least 28 unknown interred. Call the township office if you have any information that might help us determine who these people were.

Noxious Weeds

One of the duties of a township supervisor, each spring, is to patrol the township road ditches, vacant lots and farm fields for weeds that are on the state of Minnesota Noxious Weed List. Ida Township



seems to have an abundance of Canadian Thistle. Wild Parsnip was been found in the south Lake Ida area. Information about the weeds can be found on the MN DNR website.

Please take some time to look for these weeds and either spray or cut them. If you do this, we the board, will not have to send you a letter asking you to take this action. If issues are not addressed, after notification, the board will hire someone to get rid of the weeds and then bill you for the work. If we all work together on this issue we can do our part to help control noxious weeds and "OUR" township will benefit by this combined effort. Thanks for your help!
