CHIEF'S REPORT: Chief Lish reported that the District was in 100% compliance with the Governors covid-19 vaccine mandate of healthcare providers. The 2021 Flu Clinic was a success and a date for next year has been secured. The District received a rejection letter for the AFG grant for SCBA's.

COMMUNICATIONS: The Board received a copy of a memo from Snure Law Offices in regard to Commissioner and Personnel in Campaigns along with a copy of the PDC guidelines for local government agencies in election campaigns.

UNFINISHED BUSINESS: Chief Lish gave an update on the District's policy. Lexipol offers 11 Chapters of policy, of which the Board has approved 10 chapters. Chief Lish now has full access to the policy on Lexipol's website and has started many of the updates needed to continue, this needed help of Lexipol's tech support for a day. Moving forward with a clean updated copy and support from Lexipol Chief Lish recommended roll out to the membership to start in January 2022, this includes using the Lexipol app and training of the app. Chief Lish hopes to have Chapter 11 done this year, hopefully November. Although he understood due to workload, Commissioner Kopanos raised his continued concerns about the time frame not meeting the December 31st deadline. Commissioner Lee asked Chief Lish if he could get Chapter 11 out to the Board, he said he hoped too in November. Chief Lish stated that chapters 1, 2, 3, 4 and some others go back as far as 2013 with no updates preformed, now that he has access to the program it should start moving much faster.

NEW BUSINESS: Discussion of Motions from May 7th, 2021 was requested to be placed on the agenda. Chairman Lee asked for discussion, no discussion followed.
