2010 ANNUAL REPORT

At the start of 2010, we developed contingency plans for the shutdown of the Gooseberry Point dock. We met with representatives of the U. S. Coast Guard, Whatcom County Dispatch Center, the County Medical Program Director, Airlift Northwest and Naval Air Station Whidbey Island. Although the shutdown did not occur, it was a good opportunity to establish plans for other events that could severely affect our connection to the mainland.

In April, we were awarded our grant request for \$20,390 to purchase new respirator-fit testing equipment and additional bunker gear. Fit-test equipment is required to meet federal standards and state laws. More importantly, it provides a higher level of safety for our volunteers. With a price tag of \$15,000, it would have been difficult to purchase without grant funds. The bunker gear was necessary to outfit our newest members: Robert Sorensen, Becca Swaen, Laura Camarillo, and Patrick Slimane.

Becca and Laura joined as RNs but State Laws do not recognize those skills in the pre-hospital setting. Whatcom County Fire District 14 (Kendall) had a similar situation and decided to put on a small RN to EMT bridge class. It was a great way to get their pre-hospital certifications without going through the full EMT class. Our fire training focused on essentials for the many folks who have joined in the past 5 years. They spent a lot of time in the classroom and at home studying. In December several of them spent 2 days at the State Fire Training Center in North Bend fighting live fires and performing Search and Rescue drills.

In March we took delivery of our new ambulance. The old one served us well for 10 years but the required repairs were occurring too often and costing more each time. With a partial matching grant from The St Luke's Foundation, we were able to pay for it in full. In the past we serviced all the apparatus twice a year. After reviewing oil sample data for the past years, we cut back to only one annual service on a trial basis. We will continue taking samples twice a year. If it works out, it will cut some of the maintenance costs each year. The Firefighter's Association purchased a multi piece cordless tool set, heavy duty ratchet straps, high-lift jacks and miscellaneous tools to increase our inventory of extrication and rescue equipment.

Our eighth annual Open House was a big success. We really appreciate the large attendance from the community. It lets us visit with people in a non-emergency setting and to show our new equipment. The Fire Extinguisher person was very busy as were the bike helmet folks. As usual, the kids loved playing firefighter, trying to put out the house fire on the hill (some of the adults enjoyed doing it also). I think the funniest part was seeing them sliding in the foam like it was winter!

Our Basic Life Support (BLS) transportation agreement with Fire District #8 (Gooseberry Point and Marietta) continues to work very well. When non-critical patients need to go to the hospital by ambulance, we take them to the mainland where a District 8 ambulance is waiting for us. After we transfer the patient, they transport the patient to St Joseph's Hospital.

Beside monthly district meetings, the Commissioners also attend the County Commissioners Association and West Region (Sandy Point, Ferndale, Marietta and Lummi Island Fire Departments) meetings and County Council meetings when there are issues that affect fire and emergency services on the Island. At the annual budget meeting the board unanimously agreed not to file for the 1% tax increase allowed by law for the sixth year in a row.

In 2010 the volunteers dedicated over 2,543 hours serving you; 582 hours on emergency responses, 1,076 hours on-going training, 557 hours initial training and 328 hours on weekly truck inspections. They spend many more undocumented hours putting the equipment and apparatus back in service and writing reports after calls. Below is list of the unpaid professionals who dedicated themselves to our community in 2010. Please note the diverse professions of this group and the years of service each. We are very lucky to have true community-based responders; most other departments in the county have members that serve only 3-5 years before moving on. Following the membership list, I am pleased to provide a snapshot of the 2010 financial activity, the 2011 budget, end of 2010 fund account balances, and the emergency response data from 2010.
