# **2013 ANNUAL REPORT**

The volunteers responded to 59 different incidents in 2013, including EMS, wild land fires, structure fires, power lines, hazardous conditions, service calls and false alarms. 279 man hours were spent responding, taking actions and returning to the station. The volunteers spend many more undocumented hours writing reports and making sure the apparatus and equipment are ready for the next call.

As required by Federal and State regulations, annual testing was completed on all our fire hose, self-contained breathing apparatus, ladders, pumps and defibrillators. I am happy to report there were only two sections of hose that had to be repaired. None of the apparatus experienced any major problems; however we did increase the rear lighting and installed hose bed covers on both the engine and tender for safety reasons. At the beginning of the year, Washington Department of Natural Resources awarded us \$5,677 (50% matching grant) for 7 portable radios. In April, FEMA awarded us \$51,348 (95% matching grant) for a new heart monitor/defibrillator and to replace our oldest one. The heart monitor has the most current cardiac technology in the pre-hospital setting with the capability to send data directly to the hospital. In addition, it allows us to review call data for training and improved patient care. We came in under budget and with the remaining funds we purchased several CPR manikins, an additional defibrillator, and a bone drill for our Advanced Life Support (ALS) personnel. The volunteers spent a total of 468 hours inspecting the vehicles and equipment throughout the year to keep up on equipment locations and ensure everything was ready to respond to your requests for help.

The county wide ALS transport system moved forward when Whatcom County, City of Bellingham and Fire District 7 negotiated contracts for service. As with any new system that splits responsibilities from one agency to three, there were obstacles to overcome and unforeseen matters to deal with. The contracts were approved and signed in December. On or about July 1, Fire District 7 will replace one of the ALS ambulances in the county that currently is provided by Bellingham Fire Department.

The Civic Club generously donated funds to clean up the old flowerbeds, trim and prune the bushes and put down new gravel in front of the station and across the street near our live fire training prop. In the spring we noticed carpenter ants had invaded the building across the street causing structural damage. It was a great opportunity to gut and reroof it to make it more usable for storage.

After many years battling a rare disease, Scott Blanchard passed away in November. Scott joined the Department in 2007 and was a quick study in developing his firefighting skills and receiving his EMT certification. Scott's energy was an inspiration to us all, always ready and willing to get the job done. While his time on the department was short, his impact will be long lasting. Ernie Pearson retired after 28 years of dedicated service; Ernie always had a calm demeanor about him no matter how severe the call may have been. Bob Bush also retired from the department after 21 years and 12 years as a commissioner. His engineering and management experience was very beneficial when it came to the design, construction and acquisition of our firefighting fleet and ambulance.

We began a Cadet program at the end of the year for 16 - 18 year olds and already have two active members. We hope this experience is rewarding for them and they choose to become full members when they turn 18.

Ongoing fire training focused on a wide range of topics including report writing, positive pressure ventilation, logistics, ladders, scene size up, hand tools, traffic control, emergency vehicle driving, hazardous materials, and pumps to name a few. EMS topics included cardiac, altered mental status, abdominal, pediatric, soft tissue emergencies, infectious disease, and sick/not sick decision making. Including two Saturdays and Thursday evenings, the volunteers gave 1,355 hours to the community to maintain and improve their knowledge and skills required in this profession. We did three live fire exercises in our fire training prop including one with Fire District 17 (Sandy Point) in late spring for several of their members.

For the 8<sup>th</sup> consecutive year the Board of Commissioners chose not to take the 1% revenue increase allowed by statute. The Board had several special meetings to start discussing future funding options to keep up with the increasing costs. Bill Lee was elected to the Board for six years beginning January 1, 2014. I look forward to working with Bill in the future as the department moves forward.
