## **2014 ANNUAL REPORT**

This past year was not the best for our equipment. The engine in our staff vehicle seized up. Fortunately, we were already planning on replacing the staff vehicle with the generous support and funding from the Civic Club. The pump shaft broke on the Initial Attack apparatus and even though it was past its warranty period, the manufacturer recognized there was a design flaw and provided the parts at no cost to us. The Engine (which is approaching 20 years of age) had a major plumbing leak, a block heater failure and several air system leaks throughout the chassis.

In June FEMA denied our grant request for a new station generator. We partnered with LICA and submitted a proposal to Puget Sound Energy Foundation in October. We received word in December that it was awarded. We anticipate the new system to be operational by April. This will be a great improvement to have an automatic switchover, substantial fuel supply and the capacity to run all our equipment including the siren and breathing air compressor.

Training and Operations are the backbone of our department. The time needed to plan and perform these key roles has increased beyond what can reasonably be expected of any member with other work and family obligations. The Board decided to hire Captain Michael Lish as a full time Operations and Training officer. The result has been successful with a more focused training program and improved operational readiness.

With the support and commitment of all the Officers, we began a volunteer Battalion program where one Officer would respond to calls and be reachable 24 hours a day via phone: <u>360-739-0358</u>. This is the first time the District has been able to guarantee at least 1 person to respond 24 hours a day.

Looking forward, the Board recognized that the funding levels were not going keep up with the cost of operations. In addition to a constantly aging fleet of vehicles, they took a hard look at long term planning and what their options were under state law. There were many extra Board meetings to develop a presentation to present to the community and solicit feedback before a decision was made to propose an increase to the Fire levy. The support and generosity of this community fuels our commitment to provide an efficient emergency response system.

I was appointed to represent the Whatcom County EMS and Trauma Council on the Technical Advisory Board (TAB) for the Advanced Life Support service. We started the year meeting every other week working on the transition from one to two service providers. Many issues were identified and prioritized including equipment exchange, standardized and accessible training, uniform billing levels, and quality assurance using key performance indicators. On July 1<sup>st</sup> there was a smooth transition as Fire District 7 replaced the Bellingham Fire Department ambulance stationed at Grandview and Enterprise.

The survival rate of cardiac arrest victims improves dramatically with early CPR. As more community members are trained in CPR, the greater the survival rate will be for cardiac arrest patients in the community. Last year Dan Ohms provided CPR training to almost 90 members of the community, just shy of his 100 per year goal. Public CPR training will continue in 2015 with hopes to meet and exceed that goal. Please contact us to schedule a class for your neighborhood, organization or other group.

There are always members that come and go and this year was no different. Shelly Head, Eric Immer and Jim Lane turned in their bunker gear and pagers. Each one put in many hours to volunteer for the community and I would like to thank them for their dedication and commitment over the years. On the flip side, pagers were issued to Patti Bolyard, Brittany Swaen, and David Jones after completing their orientation training.

There were 1,776 individual hours spent on training in 2014 including fire, medical, command, control and apparatus driving. The highlight was the Search and Rescue crew from Naval Air Station Whidbey Island in April. They demonstrated their capabilities, let us tour the helicopter and gave us brief classroom training on how to activate and prepare patients for them. We are hoping to do another training again this year with them. Sam Bowman chose to attend the Whatcom County Fire Fighter Recruit Academy last fall. This class meets all Federal and State requirements to be certified as a Firefighter-1. I was proud to present Sam his Certificate of Completion at a formal ceremony in December with several other Fire Chiefs of Whatcom County.

In addition to the 1,776 hours of training, there were another 390 hours inspecting vehicles to ensure they are ready to respond, and 343 hours responding to calls. Below is a list of the unpaid professionals that train and respond to any type of incident at a moment's notice. This community is very fortunate to have these dedicated and community minded folks at their disposal and I am very proud to be part of their team.


