# **Executive session:**

2023 Budget Amendment. Chief Lish presented the Board with an amended budget for the 2023 year. Chief Lish gave an update on the capital budget with serval items coming in under budget and the County wide EMS levy amount was less than expected leaving the district with additional funds of \$8,932. At this time the Chief Lish requested that the Board amend the 2023 capital budget with an increase of \$22,580.00, moving the 2024 projected project of PPE (personal protective equipment) for responders to this year..

Motion: Commissioner Bill Lee made motion, "To approve the amendment to the 2023 capital budget of \$22,580.00." Seconded by Commissioner Wendell Terry, AND PASSED 3-0.

There was general discussion in regards to the districts covid-19. The station is now back open to the public not just for Commissioner meetings.

This year the districts open house will be held on Sunday June  $4^{th}$ , 2023 from 10am - 2pm.

**RESOLUTIONS:** Resolution 2023-272 Declaring the surplus of 20 (twenty) qty Motorola XTS 2500 portable radios and accessories to the needs of the district and disposed of at the least cost for the district.

Motion: Commissioner Wendell Terry made motion, "To approve Resolution 2023-272 to surplus the Motorola XTS portable radios and accessories." Motion seconded by Commissioner Bill Lee, AND PASSED 3-0.
