CHIEF'S REPORT: The new engine arrived on Friday April 9^{th.} and inspection is expected to take place this week. Chief McLane estimates 1-2 months to outfit and training members before placing in service. The Power Cot arrived on March 30th and the Power Load system is scheduled to be installed on Thursday April 15th.
