APPROVAL OF MINUTES: Minutes for the Regular Board of Commissioners Meeting on May 14th, 2019 were approved as submitted by Chairman Bill Lee.

CHIEF'S REPORT: Chief McLane gave his report. The Open House was a success, next year (2020) will be our 60th Anniversary. PSE is retrofitting the interior of the Station's lighting with all new LED tubes as part of their energy-efficient lighting program.

UNFINISHED BUSINESS: Chief McLane provided information on the current EMS levy rate and collection amounts, and the impact the Whatcom County EMS levy has on the District. Chief McLane also provided basic information on RCW 84.52.130 regarding fire protection district excess levies as a starting point for early brain storming for replacing our current EMS Levy.

NEW BUSINESS: Discussion was had regarding Engine 38's future once the new Engine is delivered in 2020. The current Engine was built in 1997 and comparable Engines range from \$35k - \$75k for resale with most falling in the \$60-65k range. Initial agreement by the Board was to keep the 1997 Engine as a backup or an additional responding unit after the new Engine is placed in service. Chief McLane will continue to research options for storing the 1997 Engine.
