<u>CALL TO ORDER</u>: Commissioner Ed Scott at 3809 Legoe Bay Road, Lummi Island, WA 98262 called the Regular Meeting for August 8th, 2017 to order, at 7:00 p.m.

PUBLIC COMMENT: Retired Commissioner Pete Cameron had a couple questions for the Board. First, why is the Fire Department not commenting on the Lummi Island Congregational Church's future facilities plans or on the purposed started up of the Lummi Island Parks and Rec District to build community meeting spaces. Pete commented that about 10 years ago the Fire Department was talking about future facilities as well. Second, what impact would a Park and Rec District tax have on revenue available to Public services, mainly the Fire Department and EMS Services. Pete had not found these topics of discussion in any minutes from previous meetings and felt that the Fire Departments stance on these topics should be on public record.

Chairman Ed Scott explained that when you factor in parking needs and the space needed for the Department to respond to emergencies, the Department doesn't have the space to share facilities as a public gathering place. For taxing purposes Fire Districts take precedence over Park and Rec Districts. Commissioner Bill Lee reiterated what Commissioner Scott related.

Retired Commissioner Pete Cameron was satisfied with the Boards answers.
