The association is organized into three regions (North, South and Central) to assure geographical balance on our Board of Directors.

The Napa County Chapter (NCC~CGJA) is joined with the California Grand Jurors' Association (CGJA) in promoting the purposes of the CGJA Articles of Incorporation and shall advance the goals and objectives of the CGJA within the State and particularly within Napa County to develop competence, serve as resource enabler, initiator of action and communicator of information.
