

**RELEASE OF LIABILITY AND  
ACKNOWLEDGEMENT AND ACCEPTANCE OF RISK**

I the undersigned in part consideration for being allowed to come onto the property and/or to participate in hunting or other recreational use, while on any property owned by **GBL Ranch, LLC, and the Members of GBL Ranch, LLC**, located in Edwards County, Texas, and any Property Leased, operated, or managed by Boss Gone Wild, LLC, doing business as GBL Ranch Manager (“Ranch Manager”), acknowledge and agree to the following:

1. I acknowledge and understand that no warranty, either express or implied, is made by the landowner or Ranch Manager as to the condition of the property located in Edwards County, Texas, or any roads, buildings, gates or other improvements located thereon.

2. If hunting, I agree to abide by all Federal and State game laws and/or rules and regulations set out for the hunting and taking of game, and I represent that I have a valid hunting license.

3. I agree to abide by any hunting instructions or other property use rules expressed by the Ranch Manager and/or landowner, including respectful treatment of all wildlife and fire building only in designated areas. I further agree not to litter and to pick up my shells and/or hulls.

4. This document shall serve as notice and warning that dangerous conditions, risks, and hazards do exist. My presence and activities on the premises expose both me and my property to dangerous conditions indoors and out, insects, spiders and snakes, as well as erosion and the general condition of the land and facilities, both wild and domestic animals that may be diseased and/or potentially dangerous, flash flooding, persons with firearms, both on or off the premises, people who may have communicable disease or caused areas to be contaminated, and the use of vehicles. I hereby state that I expressly assume all such dangers, risks, and hazards. I hereby state that I expressly assume all risks of personal injury and/or property damage. I AM AWARE THAT ACTIVITIES INVOLVING FIREARMS ARE DANGEROUS ACTIVITIES AND I HAVE CHOSEN TO VOLUNTARILY PARTICIPATE IN OR BE AROUND THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE TO ACCEPT ANY AND ALL RISKS OF INJURY OR DEATH.

5. As part of the lawful consideration for the right to enter the premises and hunt or pursue other recreational activities, I hereby release and agree to protect, indemnify and hold harmless the owner and Ranch Manager and their respective agents, employees and assigns from and against any and all claims, demands, causes of action and damages, including attorneys’ fees resulting from any accident, incident or occurrence arising out of, incidental to or in any way resulting from the use of said premises and all improvements thereon, whether or not caused by the owner’s or Ranch Manager’s negligence or gross negligence. This release applies during all times I am permitted on the property.

I, MY HEIRS, LEGAL REPRESENTATIVE SUCCESSORS AND ASSIGNS HEREBY RELEASE AND DISCHARGE FROM ALL CLAIMS GBL RANCH, LLC AND BOSS GONE WILD, LLC, THE OWNERS OF GBL RANCH, LLC AND BOSS GONE WILD, LLC, AND THEIR RESPECTIVE HEIRS, EMPLOYEES, AGENTS, REPRESENTATIVES, SUCCESSORS AND ASSIGNS FROM ALL ACTIONS, CLAIMS OR DEMANDS THAT I

NOW HAVE OR MAY DEVELOP IN THE FUTURE FOR ANY INJURY OR DAMAGE RESULTING FROM MY PRESENCE ON THE PROPERTY OR MY PARTICIPATION IN HUNTING OR OTHER RECREATIONAL ACTIVITY WHILE ON THE PROPERTY.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF, THE RANCH MANAGER, THE LANDOWNER, AND ALL OTHER RELEASEES. I HAVE SIGNED THIS DOCUMENT AFTER CAREFUL CONSIDERATION AND OF MY OWN FREE ACT AND WILL.
